Decision final, move unclear

Minister, secretary talk about removal of commercial entities from residential areas

LGRD and Cooperatives Minister Khandker Mosharraf Hossain and the ministry's Secretary Abdul Malek yesterday came up with different statements about removing commercial entities from residential areas.

At a press briefing at the secretariat, the minister said all the business establishments -- legal and illegal -- in the residential areas would have to relocate to other places. However, the secretary at the same programme said only the illegal ones would be removed.

"Any commercial entity in the government-approved residential areas is illegal and they must go within six months from April 4," Mosharraf said.

The briefing was organised to explain the implementation of a cabinet decision that commercial entities in residential areas of the country must be removed within six months. The secretary said, "We won't remove the organisations

which have been running with approval [from the authorities concerned]. Those who have no approval won't be given approval now, and they will have to leave." Confused, several journalists repeatedly asked the minis-

ter and the secretary what would happen to the commercial entities operating in the residential areas with the permission from the authorities concerned.

Doubling gas prices proposed STAFF CORRESPONDENT

Gas distributors have proposed increasing the charge for double-burner stoves in households to Tk 1,250 a month and single-burners to Tk 1,000.

In September, gas prices were raised 50 percent for single-burner stoves (to Tk 600). For double burners, it rose to Tk 650 from Tk 450.

Gas charges for other users had also been increased then.

Hasina pushes for Saarc food bank

Prime Minister Sheikh Hasina yesterday stressed the need for speedy implementation of the initiatives taken for setting up Saarc Food Bank and Saarc Seed Bank.

"Since it is essential for tackling any kind of disaster, I would like to urge the South Asian leaders to take necessary steps to establish the Saarc Food Bank as soon as possible. Let the Saarc Food Bank be a friend of need so that no one dies of starvation in our region, she said.

The PM was addressing the inaugural session of the 3rd Meeting of Saarc Ministers of Agriculture at a city hotel, reports UNB.

She called upon the policymakers to take steps to formulate policies to ensure the participation and empowerment of farmers in seed areas.

Hasina hoped the ministers and experts attending the conference will make recommendations that would help eradicate poverty from this region through increasing agri-production in a sustainable manner.

In this august conference, it should be our commitment to ensure food others. and nutritional security across the South Asia region," she said.

Citing that there is a high risk of adverse impact of climate change on Saarc countries, the premier said: "We won't be able to prevent natural disasters, but we can minimise the loss of lives and property by removing the causes of disasters and improving the post-disaster management."

Emphasis should be put on ensuring improved seeds at reasonable price, proper water management in agriculture, fair prices of agricultural produces at farmer level, introducing organic farming and reducing the use of chemical fertiliser, she observed.

"We don't want a single human being to starve and suffer from malnutrition. We want to meet the basic rights of every citizen. But it's not possible for an individual country to achieve this; rather a joint effort is required." PHOTO ON PAGE 2 SEE PAGE 17 COL 5

Hurt, handcuffed, under treatment

Banshkhali shooting victims say they don't know why they've been made accused

Handcuffed Zahirul Islam was lying on the floor of ward-26 of Chittagong Medical College Hospital (CMCH) yesterday with a bullet wound in his right leg. Three policemen were on guard.

The 30-year-old tea-stall owner was arrested by police on April 5 for his alleged involvement in the April 4 rally that protested the installation of a coalbased power plant by S Alam Group at Gondamara union in Banshkhali upazila, Chittagong.

The police opened fire on the protestors killing at least four people and injuring 30

"We are the victims. Now they are saying we are the accused," said 58-year-old Abul Khair, Zahir's father.

Not just Zahir, 3,000 unnamed people were sued in the case filed by police in connection with Monday's incident. This has panicked the villagers.

Abdul Khalek, 30, who lost his two uncles -- Anwarul Islam and Mortaza Ali -and a brother-in-law, in the firing was also under treatment at the CMCH in police custody.



BB HEIST 'Malware sent info to Egypt'

Bangladesh police probing an audacious \$81 million heist from a central bank account have found suspicious malware in the bank's computer systems that was sending information to Egypt, an officer said yester-Hackers stole the money

from the Bangladesh Bank's account with the Federal Reserve Bank of New York on February 5 and managed to transfer it electronically to accounts in the Philippines. Investigator Shah Alam said the malware just discov-

ered in the Bangladesh Bank's main servers had allowed information to be sent to an email address in Egypt for more than seven hours at the time of the theft. "We sought help from

our Egyptian counterparts

to find out the real person who was using that IP address during that period," Alam told AFP. Alam gave no further details, but an investigator


