

### Ethnic minority girl 'commits suicide'

An ethnic minority girl allegedly committed suicide by hanging herself from the ceiling of her room in a hostel of Mymensingh Mahila Degree College in Sadar upazila yesterday.

The deceased Mimi Chiran, 20, was a second-year student of the college. She hailed from Haluaghat upazila of the district.

Police said other residents of the hostel found Mimi's room locked from inside and informed the college authority as they were not getting any response from her.

On information, police recovered the body and sent it to Mymensingh Medical College Hospital morgue for autopsy.

Police also recovered a suicide note -- reading, "None is responsible for my death" -- from the spot, said Officer-in-Charge of Kotwali Police Station Kamrul Islam.

## DRAFT EDUCATION ACT-2016 More penalty for running coaching business sought

National Front of Teachers and Employees (NFTE), a platform of 11 organisations of teachers and education staff, yesterday demanded the penalty that the draft Education Act-2016 stipulates for running coaching business in the country be increased.

The penalty for those running coaching businesses should be a fine of Tk 25 lakh or five years' imprisonment, said leaders of the platform at a press conference at the capital's Jatiya Press Club.

According to the draft law, anyone doing private tuition or running coaching businesses will have to face a monetary penalty of Tk 2 lakh or six months' imprisonment or both.

"The government will have to take stern actions to stop such businesses mushroomed all over the country," said Quazi Faruque Ahmed, chief-coordinator of NFTE.

The platform's leaders also placed a 21-point demand including nationalisation of the post-primary and college education and increasing of budgetary allocation to the education sector in the forthcoming budget. They also announced a month-long programme to press home their demands.

## Road crashes kill 6

Six people were killed and 11 others injured in road accidents in three districts yesterday.

In Narsinghdi Sadar, two people were killed and five others, including a child, injured when a truck rammied a battery-run auto-rickshaw carrying them on Dhaka-Sylhet highway in Khatehara area.

The deceased were Sunil Das, 60, and Dulal Miah, 32.

In Tangail Sadar, three passengers of a CNG-run three-wheeler were killed and two others injured when a truck hit the vehicle on Dhaka-Tangail-Bangabandhu Bridge Highway in Rasulpur area.

The deceased were Joaher Ali, 30, and Shahar Ali, 25, of Lalmonirhat and auto-rickshaw driver Sadekul Islam, 24, of Kalihati.

In Jamalpur Sadar, Azizul Haque, 55, of Mymensingh was killed and four people were injured when a CNG-run-auto-rickshaw collided head-on with a battery-run auto-rickshaw on Jamalpur-Mymensingh road in Ghuradhap area.

Today is the 2nd death anniversary of eminent journalist ABM Musa.

On this occasion, a doa mahfil will be held at his 5/2 Iqbal road residence in the capital's Mohammadpur after the Asr prayers, said a press release.

AMB Musa died at Lab Aid Hospital in 2014.

Born in Dharmapur village of Feni in 1931, he started his career as a journalist in 1950 at the then Daily Insaaf. Later, he joined erstwhile Pakistan Observer.

He covered the war fronts in 1971 as a correspondent of BBC and Sunday Times.

One of the founder members of the Jatiya Press Club, Musa was elected its general secretary thrice and president for four times.

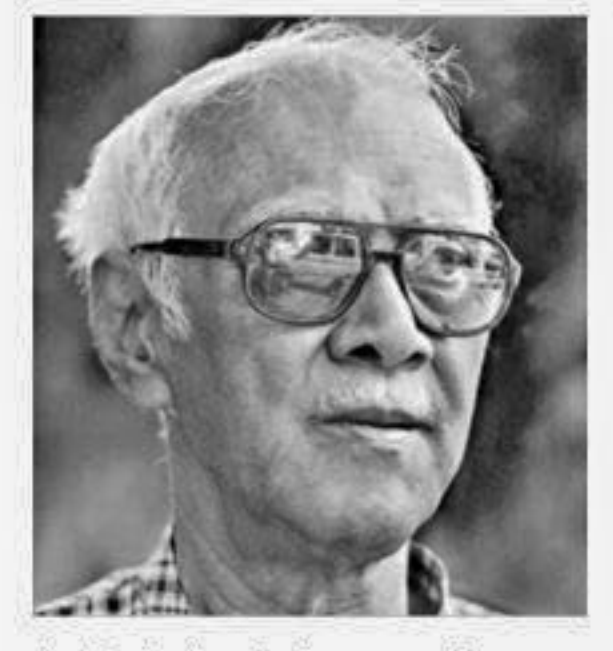
He was also a founder of Pakistan Journalists Union and elected general secretary of the then East Pakistan Journalists Union.

After independence, he joined Bangladesh Television (BTV) as its director general and later became editor of the then Morning News.

He was also elected Member of Parliament from Feni constituency in 1973 as an Awami League candidate.

ABM Musa joined the United Nations Environment Programmes in Bangkok in 1978 as its regional director and was the director general of Press Institute of Bangladesh (PIB) from 1981 to 1985.
