Canada jobless rate dips to 7.1pc

The Canadian economy gained 41,000 jobs in March, driven by demand for health care and social assistance workers, according to government data Friday which showed a drop in the unemployment rate to 7.1 percent.

It was an improvement from the 7.3 percent unemployment rate in February, the highest level seen in three years. The March figures were better than expected, with analysts projecting unemployment to hold steady from the February level.

"Employment increased in health care and social assistance, accommodation and food services, professional, scientific and technical services as well as 'other services'," Statistics Canada said.

Fresh attempt to update income tax law

At a consultation meeting in February this year, some businessmen and former tax officials recommended taking the local reality into consideration before passing the draft Direct Tax Code. The draft of Direct Tax Code, which comprises income tax, wealth tax and gift tax laws, seeks to keep corporate tax rates identical for all companies.

At present, the NBR maintains five rates of corporate taxes based on sectors, with cigarette makers and mobile phone operators taxed the highest of 45 percent.

It favours scrapping the provision of minimum tax for individuals, limiting withholding tax to 15 sectors, down from the existing 54, and withdrawing scope for final settlement.

Withholding tax and tax at source account for more than half of the income tax collection now, so drastic cuts in the sources or heads of such taxes may have a detrimental effect on the state coffers' receipts.

"Taxpayers have become accustomed to many provisions of the present law. So it will not be wise to bring in wholesale changes," said the official.

The draft of Direct Tax Code is not being scrapped entirely. "We will incorporate the good and positive things from the draft law as well as the present income tax ordinance," he added. Insiders said the tax authority plans to engage local experts on tax law and legislative matters to prepare the revised draft of income tax law by December to introduce the new law from fiscal year 2017-18.

The NBR has formed three separate committees to quickly draft the law, monitor the progress and implement it in line with the plan.

The new income tax law will be drafted in Bangla in line with a previous directive from the High Court and will be incorporating the issues of digitisation of tax system such as e-payment and e-filing.



One third of **Pakistanis** live below poverty line

....... Nearly 60 million people live below the poverty line in Pakistan, making almost a third of the country poor under a new formula adopted by the government to measure poverty.

The report, from Pakistan's Planning Commission, estimates that adults in up to 7.6 million households are earning less than 3,030 rupees per month (\$30), raising poverty levels to 29.5 percent from nine percent under former estimates.

Released Thursday, it calculates poverty by the cost of basic needs (CBN) rather than by food energy intake (FEI) as previously, saying the change was made in accordance with best international practices.

The government of Prime Minister Nawaz Sharif has been striving to boost an economy dragged down by security issues and a crippling energy crisis.

The change in methodology, said education activist Mosharraf Zaidi Friday, could help "cement the incentives for government to spend a growing share of the budget on development, including mostly infrastructure but also social services like health and education."

Increase income tax exemption limit for women: Ctg chamber

The next budget will be vital for the nation as it will take the country from the sixth fiveyear plan to the next one, National Board of Revenue Chairman Md Nojibur Rahman said at a pre-budget meeting yesterday.

"We will go for the new global paradigm of sustainable development goals from millennium development goals."

"The next 25 years are important for us, as in the next five years, we would strengthen our position as a middle income country and in the next twenty years, we would become a happy and rich nation," he said.

Chittagong Chamber of Commerce and Industry (CCCI) organised the discussion at World Trade Centre in Agrabad. CCCI President Mahbubul Alam presided over the meeting.

The Chittagong chamber has proposed

to increase the income tax exemption limit from Tk 2.5 lakh to Tk 2.78 lakh for women, from Tk 3 lakh to Tk 3.5 lakh for the elderly, from Tk 3.75 lakh to Tk 4.25 lakh for the physically challenged, and from Tk 4.25 lakh to Tk 4.5 lakh for freedom fighters.

The chamber also urged the government to impose VAT after discussing with traders, and fix the tax rates considering the rates in neighbouring countries.

"Honest traders and businesspeople will always get help from us," Rahman said.

A total of 198 proposals regarding tariff, VAT and income tax have been submitted to the NBR chairman, said Alam.

CCCI Senior Vice-President Md Nurun Newaz Selim also spoke.

Later, the NBR chairman joined another pre-budget meeting with the leaders of Chittagong Metropolitan Chamber of Commerce and Industry.

China firm boosts self-driving technology with \$1b overseas deals

A Chinese auto firm said Friday it is buying two foreign companies and their selfdriving technologies for more than \$1 billion, as the world's second-largest economy seeks to boost its foothold in the autonomous car market.

Ningbo Joyson Electronic Corp. said it has signed an agreement to buy US-based Key Safety Systems (KSS) Holdings Inc. for \$920 million, according to a statement to the Shanghai stock exchange, where it is listed.

Ningbo, which provides driver control technology.

Motors and Mercedes-Benz, said it also plans to buy the car navigation business of Germany's TechniSat Digital GmbH for \$204.6 million, the statement added.

Filipino banker to become a state witness to BB heist

While authorities blocked most of the illicit transfers, \$81 million ended up in Rizal Bank in the Philippines, wired to remittance company Philrem Service Corp before being sent to casinos where the money trail has gone cold. Almost all of the \$81 million is still missing.

CLOSED-DOORTESTIMONY Central to the probe is Deguito, who's fac-

ing possible money-laundering charges after she allegedly allowed the funds to be withdrawn on February 5 and February 9 despite requests from Bangladesh to halt the transfers. The banker gave closed-door testimony on the case to senators on March 17, but has declined to discuss the transfers at previous public hearings to avoid incriminating herself. The Department of Justice is currently investigating whether there is enough evidence to charge Deguito with money laundering.

The country's Witness Protection, Security and Benefit Program encourages anyone who has witnessed or participated in a serious felony to testify before a court or investigating body free from the risk of legal reprisals. The government will drop criminal charges against those who become state witnesses, Topacio said.

Deguito told senators on April 5 that she was just ""a pawn in a high-stake chess game played by giants in international banking."

Topacio said his client's testimony has been corroborated by Kim Wong, the casino junket operator who claimed to be an inter-

preter for two Chinese nationals linked to the stolen funds. Wong testified that he had introduced Deguito to some people who wanted to open bank accounts where the stolen funds were later deposited, Topacio said. Wong has denied any wrongdoing in the case.

FUNDS RETURNED

Wong has turned over \$5.46 million to regulators since March 31, which he said he received from the two Chinese nationals. He has promised to return another 450 million pesos within the month that he received from one of the men as repayment of a debt. Deguito's closed-door session with the
