MOVEMENT FOR DEMOCRACY New leaders to bring success

Says BNP Secretary General Mirza Fakhrul on visiting Swadhin Bangla Football Team member battling cancer

Strengthened with new leadership, BNP's "democracy restoration" movement will now achieve success, its secretary general, Mirza Fakhrul Islam Alamgir, told journalists yesterday after visiting an ailing former footballer at the latter's Jigatola residence in the capital.

"BNP's national council has surely helped the party become revitalised and reorganised," he said on providing, on Chairperson Khaleda Zia's behalf, financial assistance to Ainul Haq, a Swadhin Bangla Football Team member battling cancer for long, as per his

Fakhrul said with no democracy and "under the rule of an undemocratic and unelected government", the ruling party men were taking over polling stations and snatching people's right to franchise.

Lambasting government plans to hike power and gas tariffs, he claimed it was "to plunder more public money", threatening to wage tougher movements with the masses. He said utility costs have been raised in phases since the government assumed office in 2014.

SABBIR KILLING CASE

Five acquitted accused asked to surrender

The High Court yesterday ordered five accused, who got acquitted of Bashundhara Group official Humayun Kabir Sabbir killing case, to surrender before the lower court in six weeks.

During a hearing of a government petition, the HC however asked the lower court to grant them bail if they surrender.

It also issued a rule asking the accused to explain in four weeks as to why the lower court judgement should not be scrapped.

The HC bench of Justice M Enayetur Rahim and Justice Amir Hossain came up with the rule following a petition filed by the government seeking cancellation of the judgment.

The bench also asked the authorities concerned to produce the records in four weeks, HC sources said.

Sabbir, a director of Bashundhara

Telecommunications Network Ltd, was killed in capital's Gulshan area in July, 2006. A Dhaka court on December 15,

2011 acquitted all five accused including Shafiat Sobhan Sanvir, son of Bashundhara Group Chairman Ahmed Sobhan Shah Alam. Four other accused are Nure

Alam and Humayun Kabir, security guards of Sabbir's house, and Khairul Hassan Ujjal and Shamsuddin Ahmed, bodyguards of Sanvir.

4th phase of UP polls sees fewer AL men being elected unopposed

Just six ruling Awami League chairman candidates are set to be elected unopposed in the fourth phase of the union parishad polls, a sharp decline from the previous phases of the polls.

In the first phase, 54 ALnominated candidates were elected uncontested to the chairman posts in 725 union parishads, while the number of elected unopposed chairmen in the second and third phase of the polls were 34 and 25, Election Commission sources said. Sources at the EC said the num-

ber of elected unopposed chairman candidates dropped sharply as it took measures so that nomination papers could be submitted at two places. During the first phase of UP polls, the EC received allegations of

AL chairman aspirants creating obstacles for their opponents in submitting nomination papers to the returning officer's office. From the second phase of the polls, the EC took a step so that the faction.

nomination papers to the deputy

commissioner's office apart from the returning officer's office. Following the EC's move, the BNP got more candidates to run for the chairman posts, compared to the first two phases of the polls,

party insiders said. In the fourth phase, the party failed to nominate candidates in 55 out of 727 UPs. But in the first two phases, it faced a crisis of candidates as the ruling party men allegedly suppressed and intimidated them

into not running for the polls, sources at the BNP and the EC said.

In the first phase, the BNP failed to name candidates in 114 UPs, and the number decreased to 75 and 51 in the second and third phases, the BNP claimed. Asaduzzaman, director (public

relations) of the EC, said April 7 was the last day for submitting nomination papers in the fourth phase of the election, and 3,725 nomination papers were submitted for the chairmen posts in 727 UPs. The AL was able to name candidates in all UPs, while the BNP nominated candidates in 672 UPs, he said.

The number of the unopposed elected chairman candidates may rise from six as the deadline for withdrawal of nominations is yet to expire, EC sources said. Meanwhile, President of a fac-

tion of the Jatiya Samajtantrik Dal

(JSD) Hasanul Haq Inu yesterday sent a letter to Chief Election Commissioner Kazi Rakibuddin Ahmad, asking him to allocate the electoral symbol "torch" for his In the letter, he said the party

held a council, and he and Shirin Akhter were elected president and general secretary. But some leaders, including

Sharif Nurul Ambia and Mainuddin Khan Badal, left the party and were plotting to form another party with the same name and registration number and electoral symbol, alleged Inu, who is also the information minister.

The EC already talked to the two factions on April 6, but is yet to make any decision.

Ashraful Islam yesterday announced the new committees of AL Dhaka city north and south units during a press conference held at party president's Dhanmondi office. This is the first time the Dhaka city committee has been split in two.

Dhaka-11 lawmaker and former vice-president of city AL AKM Rahmatullah and former Lalbagh thana AL unit president Abul Hasnat were made presidents of Dhaka north and south units of the party respectively.

Former Mohammadpur thana unit president Sadek Khan has been made general secretary of north and former city AL organising secretary Shahe Alam Murad of south.

Ashraf claimed that the newlyformed committees were powerful and hoped that they would play an important role in the next general elections.

The last council of Dhaka city AL was held on December 27, 2012, and its three-year tenure had expired three months ago. In the last council, nearly 2,000 councillors and 3,000 delegates of Dhaka city AL gathered to elect new leadership through voting but it ended without any vote being cast.

The council left the decision to the AL chief.

The 2012 council was held nine years after the previous council which was on June 18, 2003, where Mohammad Hanif was made presi dent.

After Hanif passed away on November 28, 2006, MA Aziz was made acting president. Aziz died on January 23 this year. On having a fully-fledged com-

mittee, Shahe Alam Murad told The Daily Star that they would announce full committees after consulting with party chief Sheikh Hasina.

The Morcha, led by eminent journalist Abed Khan, will organise a rally at Bakultala of the Fine Arts Institute of Dhaka University at 4:00pm today, demanding a ban on Olama League.

Youth commits suicide failing to find job

A youth who came to Dhaka on March 28 from Nilphamari in search of a job, allegedly committed suicide yesterday morning at a relative's house, after failing to find one. Police broke open the door of a

bathroom of Shahidul Islam's house, a relative of Humayun Kabir Basunia, 24, at Monipur Mollapara and recovered the body hanging from a ventilator with a suicide note attached to the rope he hung himself with, said Sub-inspector (SI) Ahsan Habib of Mirpur Police Station. The body was sent to Dhaka

Medical College morgue for an autopsy, and morgue sources said Basunia committed suicide. Shahidul Islam, the relative he

was staying with, said Humayun, who quit his honours education in Dinajpur due to hardship, attended quite a few interviews but could not get a job.

Rahman of Basra village. He was a 3rd-year honours student of Comilla Victoria College. In Mymensingh, an unidentified

man, aged about 35, was killed when a truck ran him over while he was crossing the Dhaka-Mymensingh highway in Bhaluka Bus Stand area on Saturday evening.

failed to ascertain the cause of her death. This raised doubts about the autopsy and a court later ordered a second post-mortem.

Emerging from the CID office, Dr Saha told journalists, "They wanted to understand the matter [autopsy]. They wanted to know in details how it was done."

About the report of the second autopsy, he said they will submit it after receiving all the test results.

Asked about an allegation that evidences were destroyed during the first autopsy, Dr Sharmin, who conducted the post-mortem, said: "This is not true." Tonu, a 19-year-old graduate

student, was found senseless a few hundred yards from her residence inside Comilla Cantonment on March 20. She was whisked off to the Combined Military Hospital in Comilla where doctors declared her dead. Many suspect she was raped before being killed.

A CID team led by Deputy Inspector General Mahbub Mohsin yesterday visited the spot where Tonu's body was found and talked to the victim's family.

Later, Special Superintendent Nazmul Karim Khan of the CID's Comilla-Noakhali Division said they were making their sincerest efforts to unravel the murder mystery. The CID official on Saturday

said they had found some clues and would some arrests in two to four days. PROTESTS ON

Bangladesh Chhatra Union (BCU)

yesterday held a "citizens' rally" at the Raju Sculpture on the Dhaka University campus, protesting Tonu's murder. Teachers, students, politicians,

theatre activists and other joined the rally to demand immediate actions to stop murder and torture of women and children. "The administration is staging a drama in the name of investigat-

ing the murder. There is no law and order in the country and only the powerful people can avail justice," said Ashraful Alam Sohel, general secretary of Bangladesh Chhatra Federation, at the programme.

Actress Sumona Soma said the frequent incidents of murder were actually being used to cover up the previous incidents.
