HC stays suspension of Gazipur mayor

The High Court yesterday stayed for six months a government order suspending Gazipur City Corporation mayor MA Mannan for being charged with criminal offences.

The court also issued a rule asking the government to explain in four weeks why the suspension should not be declared illegal.

The HC bench of Justice Quamrul Islam Siddique and Justice Razik-Al-Jalil passed the order and rule following a petition filed by Mannan challenging the suspension's legality.

Mannan's lawyer Khandker Mahbub Hossain told The Daily Star that there was no legal bar on Mannan from discarging duties as the mayor following the HC order and that Mannan got bail in all 17 cases filed against him on different charges.

8-yr-old girl raped in Habiganj; four arrested

Police arrested three persons on charge of gang-raping a female RMG worker in Chittagong early hours today and another in Habiganj on Sunday for raping a child.

Our staff correspondent in Chittagong reports: police arrested Nejam Uddin, Md Alamgir Hossain and Md Osman Gani last night for gang-rapping a worker of Fair Choice Garment at Kulgaon in the city's Bayezid.

Following a case filed by the victim yesterday afternoon, a team of Bayezid Police Station raided the area and arrested the trio, said Mohammad Mohsin, officer-

in-charge of the police station. Quoting the victim, the OC said while

returning home after her night shift around 3:45am on Sunday, the victim was kidnapped by four persons including Nejam and Alamgir, who later took her to a nearby bushy area and gang-raped. The victim's co-worker Osman, who was

accompanying her at that time, deliberately took her to a wrong way before the perpetrators intercepted them, alleged the victim. She accused Osman of having links with

the rapists, said the OC, adding that the drive was underway to nab the rest.

Mahmudur in jail for exposing govt's misdeeds

BNP Secy Gen Mirza Fakhrul tells Amar Desh discussion marking three years of its editors incarceration

Nobody can now speak out freely in Bangladesh and Daily Amar Desh Editor Mahmudur Rahman was sent to jail for his statements against the government's misdeeds and misrule, said BNP Secretary General Mirza Fakhrul Islam Alamgir yesterday. Bangladesh is passing a "tough time" as the Awami League

government was closing down private television channels and newspapers one after another, he told a discussion in the capital's Institution of Engineers, Bangladesh.

BNP's movement against the government's "terrible misrule" will be victorious for sure, just as Bangladeshis were against the then Pakistani regime, he added.

However, he said BNP had not lost hope witnessing the "illegal" government's "unbearable and limitless oppression" against the opposition leaders and activists.

"Some 74,000 cases were filed so far against 4.5 lakh BNP men. Still I am hopeful...that the misrule will be over soon," he said.

The daily organised the programme marking three years of Mahmudur's incarceration. Discussants demanded his immediate release.

The government suffered from arrogance, could not accept criticism and did not pay heed to anyone's advice, he said.

"BNP Chairperson Khaleda Zia had called upon the government to resolve the ongoing political crisis through national unity but the government did not pay heed to it. I will therefore urge the government once again to resolve the crisis through dialogue," he said.
