#### CUSTODIAL DEATH OF JONNY Decision on charge framing against SI Jahidur April 17

A Dhaka court decides on April 17 whether charges will be framed against five persons, including three former policemen of Pallabi Police Station, for killing Ishtiaq Ahmed Jonny in police custody in February 2014.

The accused are Sub-inspector Jahidur Rahman Khan, assistant sub-inspectors Md Kamruzzaman Minto and Rashedul Hassan and police informers Sumon and Russell. Of them, Jahidur and Sumon are now in jail.

After completing the hearing on charge framing yesterday, Judge Kamrul Hossain Mollah of the Metropolitan Sessions Judge's Court of Dhaka set the date.

According to the prosecution, it was alleged that Jonny, his brother Imtiaz Hassan Rocky and three others were detained by a police team, led by SI Jahidur, on February 9, 2014, when they were celebrating a pre-wedding programme of Jonny's friend at Irani camp in Pallabi.

Informer Sumon and his friends Russell

Later, Jonny, 28, was allegedly tortured to death. He was a resident of Talab camp in Mirpur-11.

Following the incident, the victim's brother, Rocky, on August 7 that year filed a case against nine people, including SI

Later, a metropolitan magistrate conducted a judicial inquiry and found Jahidur and four others' involvement.

Jahidur is also accused of being invoved in the custodial death of garment-waste trader Mahabubur Rahman Sujan at Mirpur Police Station.

# Factory building tilts on another in capital

A six-storey RMG factory building has tilted on an adjoining five-storey residential building in Tejgaon in the capital, the factory workers verbally complained to Tejgaon police on Monday.

Rajuk officials inspected the building at the Airport Road Super Market in Monipuripara and vacated it yesterday, as police informed them.

"We have instructed the factory authorities to examine the building by a Buet expert team within a day or two and we will take necessary actions based on the report," said AZM Shafiul Hannan, a relevant authorised officer of Rajuk.

The factory authorities could not produce a copy of any approved plan or building construction design that houses the factory, Continental Apparels Ltd, and the building owner was not available at the site, Shafiul said.

He said he would serve a formal notice today asking for the plan.

They have not strengthened the building despite Buet's recommendation during the Accord inspection in 2014, he said, adding that they requested local police to make sure that no worker is allowed to enter.

The Accord on fire and building safety in Bangladesh, signed in May 2013, is a five-year, independent and legally-binding agreement to ensure a safe working environment in the readymade garments industry. The building is loaded with garments machineries on the top three

floors and houses warehouses on the first two floors, said Hannan, adding that apparently the tilt, if any, has occurred slowly over a long time.

Md Ashraf Hossain Khan, manager of the factory, said they have been running the factory since 1984 there at two adjoining buildings owned by two brothers Nazim Uddin and Abu Bakar.

As to compliance with the Accord recommendation, he said that they have downsized the number of workers from 1,500 to 421 with 62 working at the said building. While visiting the building, this correspondent did not find any sepa-

rate entrance, inside stairway or passage for the buildings. Rather, it was one large space on each floor, filled with machineries. The building was also mildly shaking as the machines were running. "We have written to the owners several times asking for the approval

documents but they did not respond. We have proof of such correspondence," said Khan.

Abdullah Al Rajin, a director of the factory, said, "We will act as per Rajuk's direction.

#### Amar Desh editor Mahmudur sent to jail for 'assault on police'

A Dhaka court yesterday sent back Mahmudur Rahman, acting editor of Bangla daily Amar Desh, to jail after rejecting remand and bail petitions in a police assault case.

The court, however, allowed police to interrogate Mahmudur at the jail gate for three days within four workdays.

The case was filed for creating anarchy and preventing police from discharging their duties in the capital's Kotwali area on February 23, 2013.

The court gave the order after Sub-inspector Azizul Haque, also the investigation officer of the case, produced Mahmudur before it with a seven-day remand prayer.

On February 15, Mahmudur was shown arrested in a bomb blast case, a day after the Supreme Court upheld a High Court bail granted to him in a sedition case.

Mahmudur was picked up from his newspaper office in the capital's Karwan Bazar on April 11, 2013. The newspaper stopped printing in mid-April that year.

# HC stays construction of park near Noakhali court for 3 months

The High Court yesterday prohibited construction of a "commercial park" in the government land near the district judge court in Noakhali for three months.

The court also issued a rule asking the government to explain as to why the construction without approval from authorities concerned should not be declared illegal.

The HC bench of Justice Zubayer Rahman Chowdhury and Justice Md Khasruzzaman came up with the order and rule following a writ petition filed by five local people, including one Shahid Sarwar, challenging the legality of constructing the park.

Petitioners' lawyer Gias Uddin Chowdhury told The Daily Star that some influential people had been constructing the park named "Dream Park" in the government land without approval from the authorities concerned of the government.

Some important structures including the grave of former Jatiya Sangsad speaker Abdul Malek Ukil, Shaheed Minar, Bijoy Mancha and Kochikanchar Mela will be affected if the commercial park is constructed, he added.

# BCL beating sends Chhatra Dal leader of JU to hospital

A leader of Jatiyatabadi Chhatra Dal (JCD) suffered serious injuries in an attack by Bangladesh Chhatra League activists at Jahangirnagar University on Monday night.

Ibrahim Khalil Biplob, JCD vice president of JU unit, was first taken to Enam Medical College Hospital and then to the Bangladesh Spine & Orthopaedic Hospital, as he suffered fractures in the right hand and right leg.

JCD General Secretary Abdur Rahim Saikat said Biplob was attacked in front of the vice chancellor's residence around 9:30pm while going to a teacher's house to sit for a special exam.

Among the BCL attackers were deputy human resource secretary Firojur Rahman Sobuj, assistant secretary Mehedi Hasan Roman and activists Soud Mishu, Ujjal Hossain, Saddam, Zubayer, Rokon, Imran, and Arif, he said.

They used iron rods and sticks.

All the attackers are resident students of Moulana Bhasani Hall and followers of JU BCL Organising Secretary Morshidur Rahman Akanda, he added.

Akanda said, "Suspecting that Biplob might create unrest on the campus, some juniors beat him up."

JCD demanded steps against the BCL attackers within 48 hours, and threatened to otherwise launch tough protests, said a JCD press release.

"In the last couple of years, BCL goons attacked 30-40 JCD activists and leaders of JU unit, but the university authorities did not take any action against the people responsible, which encouraged the goons to repeat such crimes," claimed the JCD general secretary.

JU Assistant Proctor Mehedi Iqbal said, "Proper steps would be taken after getting the complaint.'

# CNG sector owners for reduction of gas price

The government should cut the price of compressed natural gas (CNG) when reducing fuel oil prices, demanded businesspersons yesterday.

"If fuel oil prices are reduced and CNG price is hiked, it will create discrimination and chaos in the public transport sector," said a statement of the Bangladesh CNG Filling Station and Conversion Workshop Owners' Association, which raised the demand at a press conference at Dhaka Reporters' Unity.

Private entrepreneurs invested around Tk 3,500 crore in the CNG sector and vehicles owners spent around Tk 2,500 crore to run on CNG. So, the CNG sector will face a threat, if the price of CNG is not decreased proportionately, it said. Moreover, people will be discouraged to use CNG, increasing air pollu-

tion, said the statement, read out by the association president, Masud Khan. Currently, per cubic foot of CNG is sold at Tk 35, he said. The government plans to slash prices of diesel, kerosene, octane and

petrol by 15 to 25 percent to allow the economy to benefit from the slump in global oil prices, according to media reports.

The price of octane may come down to Tk 84.15 a litre from Tk 99, petrol to Tk 81.60 from Tk 96 and diesel and kerosene to Tk 51 from Tk 68. Moreover, Bangladesh Energy Regulatory Commission has received proposals from gas distributors to hike the price of CNG.


