Five Netrakona war crimes accused sent to jail

The International Crimes Tribunal-1 yesterday sent four Netrakona men to jail, a day after they were arrested over charges of committing crimes against humanity during the 1971 Liberation War.

The three-member tribunal led by Justice Anwarul Haque also fixed May 29 for passing the next order in the case.

The four are Azizur Rahman, 65, Ashak Ali, 82, Md Shahnewaz, 88, and Ramjan Ali, 78, of Durgapur upazila of Netrakona.

They were arrested on Tuesday, hours after the tribunal issued arrest warrants for five persons including the four. The fifth accused, Khalilur Rahman, is still on the run, said Prosecutor Zead Al Malum.

Meanwhile, the tribunal allowed the prosecution to interrogate Sohrab Fakir, accused in another case, at the safe home of the investigation agency. As per the order, he could be interrogated for one day on April 20. Two other accused of the case -- Hedayet Ullah Anju and his brother Enayet Ullah Manju of Atpara upazila of Netrakona -- are still on the run, said Prosecutor Mukhlesur Rahman Badal.

Fire breaks out in port city market

Fire gutted valuables, worth Tk 4 lakh, of two shops in a market in Chittagong city early yesterday.

The fire originated from an electric short circuit in a shop of Rahaman Market in Chawk Bazar Kitchen Market area and soon spread to another adjacent shop around 3:40am, said Fire Service officials.

On information, fire fighters rushed to the spot and managed to douse the blaze around 5:20am.

SC upholds stay

The Supreme Court yesterday upheld a High Court order that stayed suspension of Gazipur City Corporation mayor MA Mannan over criminal charges.

A three-member bench of the Appellate Division headed by Chief Justice Surendra Kumar Sinha passed "no order" on an appeal filed by Gazipur city's panel mayor Asaduzzaman Kiron against the HC order.

There is no legal bar for Mannan to discharge duties as the mayor of GCC following the apex court's order, Abu Hanif, a lawyer for Mannan told reporters. The LGRD ministry on

August 19 last year suspended Mannan, after a Gazipur court accepted a charge sheet against him in a case filed with Joydevpur Police Station for an arson attack on a passenger bus in the city on February 4 the same year.

Mannan, also an adviser of BNP Chairperson Khaleda Zia, was arrested in his Baridhara residence on February 11 last year.

The HC on April 11 stayed for six month the LGRD ministry's suspension order.

Baby thief caught red handed at DMCH

The Dhaka Medical College Hospital staff and patients' visitors beat up and handed over to police a man as he tried to snatch an eight-month-old baby girl from an aya (ward assistant) on Tuesday night.

Abu Bakar Siddique, officer-in-charge (OC) of Shahbagh Police Station, told The Daily Star that the detainee, Shahajuddin, 35, might have lost mental balance.

He said they would verify the information they got from locals. No case was filed till last evening.

Ahsan Ullah Biswas, 50, of Keraniganj, father of the girl Khadizatul Kubra, was admitted to the surgery ward on the ground floor of the hospital on March 9, the OC said.

The aya, Rehana, 60, said Shahajuddin held the hands of the baby and tried, in vain, to snatch her when her mother took Biswas to a toilet.

Abu Bakar said at that time people rushed in and asked Shahajuddin whether he was trying to steal the baby. Later, he confessed to doing so, he added.

HC questions legality of MPs being on governing bodies

The High Court yesterday challenged the legality and issued a rule asking the authorities concerned of the government to explain in four weeks as to why the Section 5(50) of Secondary and Higher Secondary Education Board Rules-2009 that allowed lawmakers to hold post of chairman on governing bodies of local school and colleges should not be declared unconstitutional.

The HC bench of Justice Zinat Ara and Justice AKM Zahirul Hoque issued the rule following a writ petition filed by Supreme Court lawyer Eunus Ali Akond challenging the legality of the 2009 rules.

According to the Article 65 of the constitution, the lawmakers are permitted to research and formulate laws, but they do not do that properly, said Eunus.

"Under the Section 5(50) of the 2009 rules, a lawmaker can hold post of chairman on governing bodies of four separate institutions, which is contrary to his or her duties defined by the constitution," added the lawver.

Education secretary, chairman of Dhaka Education Board, and Civil Aviation and Tourism Minister Rashed Khan Menon, who is also chairman of governing body of Viqarunnisa Noon School and College, have been made respondents to the rule.

DU hall provost confined for raid against outsiders

A group of students, including Bangladesh Chhatra League (BCL) activists, confined the provost of Amar Ekushey Hall of Dhaka University to his room for one hour and a half and vandalised his car early yesterday.

The attackers also vandalised furniture of the administrative room, scattered documents, and damaged some CCTV cameras of the dormitory when the provost and four house tutors raided the hall around midnight to evict outsiders and overstaying students, said witnesses. They also demanded resignation of the provost.

Provost Prof Anwarul Islam accused some "political students" of carrying out the vandalism and provoking others. DU unit president of BCL Abid al Hasan said BCL activists were among the protesters. Condemning the incident, he said action would be taken against the BCL men responsible. Acting proctor M Amzad Ali said action would be taken after investigation.

ACC arrests four current, former govt officials for embezzlement

The Anti-Corruption Commission (ACC) yesterday arrested four current and former government officials in three separate cases for misappropriating about Tk 11.26 crore at different times.

The arrested are Executive Officer of Sonali Bank Mosharef Hossain, Manager and Executive Officer of Sonali Bank Jakir Hossain, Engineer of Local Government and Engineering Division (LGED) of Patiya Ziaul Haque Dulal and former civil surgeon Dr Aftab Uddin Ahmed.

Meanwhile, the anti-graft watchdog sued Ekushey Television's former chairman Abdus Salam, its Director Ashraful Alam and Senior Manager (Finance) Fazlur Rahman Shikdar for allegedly laundering Tk 26.7 lakh.

Sources said LGED engineer Dulal "gobbled up" Tk 6.34 lakh from a
