# Lone doctor runs 20-bed Kuakata Hospital

Only one doctor is working in Kuakata Hospital, much to the suffering of patients. The 20-bed hospital has been facing a shortage of doctors since its opening in 2010, although it is the only hospital in the area.

The health department built the hospital on three acres of land in 2007 at a cost of around Tk five crore.

### Teacher held for leaking question paper

A mobile court arrested a teacher on Tuesday afternoon for leaking English question paper of Higher Secondary Certificate (HSC) examinations in Fenchuganj upazila of Sylhet District.

The detainee is Rinku Das, 32, an assistant teacher of Mahmudus Samad Farjana Chowdhury Girls' School and College in the upazila.

Acting on a tip-off, a mobile court led by Fenchuganj Upazila Nirbahi Officer (UNO) Nure Jannat raided the school and checked Rinku's mobile. They found a photo of the English question paper and arrested him.

He was later sent to jail, said Nandan Kanti Dhar, officer-in-charge of Fenchuganj Police Station.

## Charges pressed against 72 Jhenidah BNP men

Charges have been pressed against 72 BNP leaders and activists in the case for torching a truck in Jhenidah town during the countrywide blockade enforced by the BNP-led alliance in February 2015.

Sub-Inspector (SI) Aminul Islam, also the investigation officer (IO) of the case, submitted the charge sheet to Senior Judicial Magistrate's Court president Ashaful Islam

in Jhenidah yesterday. Former BNP lawmaker

and district unit president Moshiur Rahman, general secretary Abdul Malek, Jhenidah municipality unit president Zahiduzzaman Mona, general secretary Abdul Majid Biswas, Sadar upazila unit president advocate Munshi Kamal Azad Pannu, Sadar upazila parishad chairman advocate Abdul Alim, BNP district unit leader Aktaruzzaman, and former Chhatra Dal

Pintu are among the chargesheeted accused.

According to the case statement, the accused torched a truck by hurling petrol bomb at Chuadanga bus stand in Jhenidah town at around 9:00pm on February 2, 2015. Later, trucker Sabuj Hossain filed a case with Sadar Police Station.

After investigation for 13 months, investigation officer Aminul Islam pressed charges against 72 BNP men.

and phensidyl at Koilabari truck terminal in Shibganj upazila of the district yesterday. #### 50 houses gutted

At least 50 houses were gutted in a fire at Bhajanpur Bhradeswar village in Tentulia upazila of Panchagarh district on Tuesday. Firefighter sources said the fire originated from an earthen oven of one Saiful Isalm's house around 5:30pm and soon engulfed the adjacent houses. On information, firefighters rushed to the spot and doused the blaze. The affected house owners claimed that the loss caused by the fire could go up to Tk 1 crore.

#### Upazila chairman suspended

A upazila parishad chairman in Sylhet district has been suspended as he was charge-sheeted in a violence case. The accused is Saifullah Al Iqbal Ahmed, chairman of Fenchuganj Upazila Parishad, and ameer of Jakiganj upazila unit of Jamaat. Deputy Commissioner Joynal Abedin said he received a letter from the ministry concerned in this connection on Tuesday afternoon. A Sylhet court recently accepted the charge sheet of the case.
