Freeze on Foreign Labour Recruitment

Malaysian govt urged to review decision

Suffering a severe shortage of manpower, many Malaysian industries have been appealing to the government to review the freeze on foreign labour recruitment, a Malaysian minister said.

Datuk Seri Wee Ka Siong, minister in the Prime Minister's Department, said he had been gathering information from many groups, including furniture makers and those in the export-oriented industries, that they desperately needed workers.

"We understand their grievances. It's high time we conveyed their feelings to the authorities so they can review the decision," said Wee after attending the annual general meeting of the Kuala Lumpur and Selangor Fruit Farmers Association, The Star online of Malaysia reported yesterday.

In February, Deputy Prime Minister Datuk Seri Ahmad Zahid Hamidi announced the government's decision to suspend the recruitment of all foreign workers to Malaysia.

The ban came a day after the Malaysian government had signed a memorandum of understanding to bring in 1.5 million Bangladeshi work- one will suffer."

ers over three years.

Wee said many parties who had opposed bringing in new foreign workers two months ago are now regretting the decision after being affected by the freeze.

The situation would be worse in June when the five-year permits for skilled workers under the 6P amnesty programme would expire and the workers would be sent home, he added.

The minister said he would raise the issue with Ahmad Zahid, also the home minister. According to him, the farmers were

facing a 30 percent manpower shortage and the situation was expected to Wee said fruits needed to be han-

'VAT Evasion'

11 Star Kabab outlets raided in city

VAT Intelligence officials yesterday raided 11 city outlets of Star Kabab and Restaurant simultaneously for alleged evasion of VAT. The raids were conducted follow-

ing complaints from people over the phone and online over a long period of time, said VAT Intelligence in a statement. Officials said they seized business

related documents of the famous eatery for scrutiny. Cases would be filed against the restaurant if evidence of VAT evasion is found.

This was the biggest ever raid by the VAT Intelligence in terms of involvement of officials. A total of 150 revenue officials conducted the search at the restaurant's outlets in Banani, Dhanmondi, Wari, Tikatuli, Elephant Road and Thatari Bazar areas, according to VAT officials.

"We conducted the raid simultaneously so that the restaurant authorities cannot pass information to other branches and hide documents," said a senior official of VAT Intelligence, a directorate under the National Board of Revenue (NBR).

According to the directorate, Star Kabab and Restaurant has one registration, but it uses two non-fiscal electronic cash registers (ECRs), the memory of which can be deleted or manipulated.

Officials said such drives against VAT evasion would continue. They requested people to get ECR receipts to make sure that their money paid as VAT goes to the state exchequer. They also welcomed complaints on the directorate's Facebook page about VAT dodging by any firm.

Contacted over the phone, one Shahidul Islam from Karwan Bazar branch of Star Kabab said someone from the eatery would return the call shortly. But nobody called back.

Zahir Uddin, conservator of forest in the Sundarbans, said they formed a three-member probe committee led by Belayet Hossain, assistant conservator of forest. The committee will submit its report within seven working days.

fire incidents along the Mora Bhola river in East Sundarbans over the last 16 years, this was the first time the forest department filed a case with a local court against some people, said sources in the department.

Earlier, the department had only assessed the damages and tried to find out the causes of fire incidents. Probe reports mentioned that fire might have originated from a cigarette or stove or torch left in the forest by honey collectors.

Meanwhile, a Bagerhat court on Sunday issued arrest warrants for the six accused.

ACC sues contractor, engineer

The Anti-Corruption Commission yesterday filed a case against a contractor and a sub-assistant engineer of the public health engineering department for allegedly using bamboo sticks instead of iron rod in the construction of Meghdomor Govt Primary School in the district.

Md Zakaria, assistant director of ACC in Rangpur, filed the case with Gaibandha Sadar Police Station.

AKM Mehdi Hasan, OC of Gaibandha Sadar Police Station, said the ACC conducted a probe into the allegation and found it to be true. The commission later picked up the two and handed them over to police.

On Monday, the Department of Public Health Engineering suspended the official.

Police on Wednesday produced contractor Abdul Khaleque and engineer Arif Billah Dakua before a local court, showing them arrested under Section-54 of Bangladesh Penal Code. The court sent the two to jail.

Meanwhile, local contractors at a press conference at Gaibandha Press Club yesterday demanded unconditional release of the contractor and engineer.

They claimed the two were "victims of a conspiracy as there had been a dispute between two rival groups over the construction work".
