Fund dispute led to muezzin killing

Four suspects arrested

Police have arrested four suspects of the murder of Jabbu Khanam mosque muezzin in the capital's Islampur over two weeks ago.

They claimed that during primary interrogation, the suspects admitted the plot and execution of the killing of Maulana Belal Hossain, 49. The arrestees are mosque khadem

Habibur Rahman Habib, 20, Belal's assistant Hafez Mosharraf Hossain, 19, his aide Sarwar Halim, 38, and mosque staff Hafez Tofazzal Hossain, "Habib had masterminded and executed the killing following a dis-

pute [with Belal] over the mosque funds," Mofiz Uddin Ahmed, deputy commissioner (Lalbagh division) of Dhaka Metropolitan Police, told a press briefing yesterday. Habib had planned the killing with

Mosharraf and Tofazzal at a mosque in Keraniganj a few days before the killing. Belal gave Sarwar about Tk eight lakh to invest in the share market, which made Habib angry with Belal, he said.

At the briefing at DMP media centre, the police official said police nabbed Habib, Mosharraf and Tofazzal from Narail, Netrakona and Dhaka's Keraniganj in separate drives on Tuesday.

Sarwar was held under Section 54 of the CrPC from Islampur days after Belal was murdered on April 4, he added.

Based on information from Habib, police recovered the "murder weapon", a knife, from a drain in Babubazar area,

the DMP official added. Replying to a query, the police official said they would investigate whether the suspects have any militant

The Jabbu Khanam mosque has a handsome monthly income from various sources including shops in the building. Belal used to handle the financial matters and invest money outside for interest, the DC said.

"Habib and others wanted their shares in it, but the muezzin refused. The suspects failed to kill the muezzin several times in the past." On the fateful night, Habib took

position on the stairs between the first and second floors of the mosque around 10:00pm and waited for Belal who was outside at that time, he said.

Habib met Belal on the stairs around 10:45pm and stabbed Belal to death at one stage.

Meanwhile, investigators said a Dhaka court yesterday placed Habib, Mosharraf and Tofazzal on three-day remand each and Sarwar on one-day remand in the murder case filed with Kotwali Police Station.

FROM PAGE 1 Witnesses said the buses leapt to five to six feet up in the air after the collision.

The coach still had around 20 passengers on its roof at that time, they added. Eight people died on the spot and

five more died on their way to or in the hospital, said police.

The injured were rushed to Rangpur Medical College Hospital (RMCH) and Taraganj Upazila Health Complex.

The fate of the driver/helper of the driving and killing people. coach could not be known.

The dead are: Jinnat Rehena Banu, 32; Chandan Roy, 35; Mohammad Ali Kala, 45; Abdul Matin, 35; Liton Islam, 34; Babul Mia, 28; Akabbar Ali, 65; Mizanur Rahman, 35; Alekh Uddin, 50; Babu, 26, said police. The identities of the remaining could not be ascertained.

Mohidul Islam, additional superintendent of highway police, told The Daily Star over telephone, "Some injured told me that they protested when the driver asked the helper to drive and went to the rear to sleep. They also asked the helper to drive slowly but he did not listen."

After the crash, locals barricaded the Rangpur-Dinajpur highway for two hours from 11:00am.

Getting assurance from the local administration of exemplary punishment for the culprits, they withdrew the blockade, reports our Rangpur correspondent.

Most drivers are least bothered about safety and they drive recklessly without almost any intervention from law enforcers on the highways.

The authorities' reluctance to punish unruly drivers, helpers and vehicle owners help recurrence of fatal road crashes in regular intervals.

There is only one instance in which a driver was punished for reckless

According to World Health Organisation, more than 21,000 people die a year on the roads of Bangladesh, which takes a heavy toll on victims' families and the country's economy.

There are a number of high court directives to improve road safety but no significant improvement in roadfatality statistics has been observed.

In 2010, the UN General Assembly adopted the resolution Decade of Action for Road Safety (2011-2020) with a goal to stabilise and reduce predicted levels of road traffic fatalities around the world.

The issue has also been included in the adopted Sustainable Development Goals with a target to halve traffic deaths and injuries by 2020.

Helali and the other by Abdul Hasan Sheikh Shariatpuri.

On April 9, the faction led by Shariatpuri demanded a ban on Bangla New Year festival terming it haram (forbidden in Islam) and urged the government to cancel the festival bonus for Pahela Baishakh, saying the allowance should instead be given to Muslims on the occasion of Eid-e-Miladunnabi.

It went as far as to demand resignation of the chief justice saying, "A Hindu chief justice in a country where 98 percent people are Muslims is an assault on the sentiment of religious Muslims."

The faction also demanded revoking the minimum marriageable age for girls, making a law with a provision of death penalty for demeaning Islam, banning the CHT Commission, taking all Indian TV channels in Bangladesh off the air and cancelling the education policy and Vested Property Return (amendment) Act.

Yesterday, The Daily Star photographer was barred from entering the Olama League office on the second floor of the AL headquarters. Later, a guard of locked the entrance to the

Leaders of both the factions say they want to run the country in line with the Madina Charter. They also cite Prime Minister Sheikh Hasina's comment on March 7, 2015, that the country would be run according to the Charter and the last sermon and directives of Prophet Hazrat Muhammad (PBUH).

According to the AL constitution, the party is committed to fighting communalism and ensuring religious freedom and human rights of all -irrespective of religion, caste, gender, community and ethnic identity.

On April 10, Abdus Sobhan Golap, office secretary of the AL, said the Olama League was not a front body of the party or a like-minded organisation. So the party does not own the demands of the organisation, he added.

About the Olama League using a floor of the AL central office, Golap said he was not aware of it and he would look into the matter.

AL Joint General Secretary Mahbubul Alam Hanif, on the same day, claimed Olama League had no office at the AL headquarters.

"We don't own the organisation. The Awami League does not believe in religious bigotry," he told The Daily

AL publicity affairs secretary Hasan Mahmud at a press conference at the party president's Dhanmondi office on April 13 said Olama League did not have any affiliation with the ruling "Some people introduce themselves

as Olama League leaders. Actually, they don't belong to the Awami League. This is not even a like-minded organisation," he had said. The Daily Star called him on

Tuesday for his comment about his presence in Olama League programmes, but he did not pick up the call. His phone was found switched off yesterday evening. Olama League's documents show

that many top leaders of the AL, including Golap, Hanif and Hasan, participated in several programmes of

Besides, both Helali and Shariatpuri

intelligences official said. Taxes do not apply to cars brought

in with carnet de passage. Moinul Khan, director general of Customs Intelligence, told The Daily Star, "The letter said the car has been handed over to customs intelligence to

comply with the law. "This car has been used on roads without compliance. The owner preferred anonymity while handing over the car which was found to be not registered."

The letter addressing the DG of Customs Intelligence said, "I am a permanent resident of London for the past 49 years. I have been working in Bangladesh as a foreign investor for a

long time." "I brought this Lexus car under Carnet De passage facility for my personal use. I thought I could renew the permit as a foreign investor. But I did not get any assistance from the

government in this regard. "Hence, the tax and duty money for this vehicle went out of my hands. I could not pay them. I did not send the vehicle back and did not use it since its

permit expired. "I am surrendering my vehicle to you out of respect for law. Soon, I will bring all documents and receipts related to this car from London and

hand it over to you." The letter read, "I firmly believe I will get all necessary assistance from the government and will not face any harassment."

"Now, I humbly request you to let me know the accurate sum I need to pay to clear the pending tax. I am also requesting the government's assistance in this regard."

Breaching of polls rules, violence on

1 killed; third phase of UP polls Saturday

Breaching of electoral code of conduct and spates of violence continue in different districts, leaving one person dead, as the third phase of Union Parishad (UP) polls starts on day after tomorrow.

A member aspirant of Prahladpur UP under Sreepur upazila in Gazipur was killed on Tuesday night, bringing the death toll to 37 in violence over the

polls across the country so far. Besides, tension prevails at Dimla upazila of Nilphamari as ruling Awami League (AL) and main opposition Jatiya party (JP) men are at loggerheads

BNP men in Chittagong have meanwhile alleged that AL men were obstructing their candidates in 15 UPs in Fatikchhari upazila.

over elections to seven UPs.

In Bogra and Munshiganj, candidates and their supporters have kept violating the electoral code of conduct.

Elections to 621 UPs are scheduled for April 23 in the third phase, while 743 UPs will go on polls on May 7 in the fourth phase and around 1,400 more UPs in two other phases until

Earlier, polls to 1,364 UP were held in two phases on March 22 and March 31. Both the phases witnessed widespread violence and irregularities that left at least 35 people dead and more than 1,000 wounded.

In Gazipur, member aspirant AL leader Akhter Khandaker, 45, was hacked to death around 10:00pm on Tuesday, reports our correspondent.

Police and witnesses said Akhter was returning to his house on a motorcycle when miscreants stopped him, indiscriminately chopped him and left

him dead on the spot.

The police recovered his body around 12:00am and sent it to Shaheed Tajuddin Ahmed Medical College Hospital morgue for autopsy, said Asaduzzaman, officer-in-charge (OC) of Sreepur police.

Victim's cousin Abdul Baten alleged rival member aspirant Mujibur Rahman had been threatening Akhter for last couple of days. He also accused Mujibur of being involved in the killing.

Mujibur denied the allegations and said his rivals were hatching conspiracy against him.

In Chittagong, Fatikchhari upazila unit BNP convener at a press conference yesterday alleged that AL men were threatening their candidates and obstructing them from electioneering.

In Nilphamari, tension prevails at Dimla upazila as AL and JP come face to face over elections to seven UPs. Both groups are verbally attacking each other, triggering fears among locals of deadly clashes anytime, reports our correspondent. In Bogra, a mobile court fined two
