

# DEMANDING SECURITY AT SEA Trawler owners suspend fishing

Owners and senior crew of fishing trawlers in Chittagong yesterday suspended fishing in the sea for an indefinite period protesting reported attacks on several trawlers injuring several crewmen last week.

Leaders of Bangladesh Marine Fisheries Association, Marine White Fish Trawler Owners Association and Ex-Cadet Association of Marine Fisheries Academy at a press conference at a city restaurant also demanded immediate arrest of the culprits.

Addressing the conference, Ahsan Iqbal Chowdhury, secretary general of Bangladesh Marine Fisheries Association, said a group of miscreants under the banner of "Matsya Shikari Jahaji Sramik" on April 20 morning made attacks in phases on eight to ten fishing trawlers anchored near Fishery Ghat in the river Kamaphuli in the name of a strike for increasing salary.

They went on rampage on the day, he said.

Severely injured captain (in-charge) Hasanuzzaman of Sea Heart-4 and third officer Mehran Forhad of Sea Heart-3 were admitted to a hospital, the leaders said.

No attackers are yet to be arrested although general diaries were filed, said Chowdhury.

Sailors of these trawlers are usually paid much higher than the fixed wage for the water transport workers by the government as they are paid several allowances alongside the basic salary, he said.

A section was trying to create anarchy in a bid to destroy the fishing sector, he alleged.

Captain Shamsul Islam, president of Ex-Cadet Association of Marine Fisheries Academy, said officers including captains, chief officers, and first, second and third officers had already stopped going to the trawlers sensing insecurity.

# bKash agent shot, robbed of Tk 5 lakh in capital

Muggers shot a bKash sales representative and looted around Tk 5 lakh from him in the capital's Mirpur yesterday.

Azizul Hakim Suman, 28, a sales representative of Shuvro Trade International Ltd at Gabtoli, is undergoing treatment at Dhaka Medical College Hospital.

Jamil Hossain, manager of the business outlet, said three muggers on a motorcycle intercepted Suman when he was collecting money at Rainkhola around 12:30pm.

They pushed him on the ground and tried to snatch the money. As he tried to resist them, the muggers shot him in the right leg and fled with the money, added Jamil.

As locals tried to come forward for help, the muggers fired a blank shot and left the scene on the bike, police said.

# MISAPPROPRIATING Tk 4.1 CR 2 former Uttara Bank officials jailed for life

A Dhaka court yesterday sentenced four people including two former Uttara Bank Ltd officials to life in jail for misappropriating Tk 4.1 crore by submitting fake documents in 2002.

The convicts are: Khan Ahsan Ertazul Islam, former branch manager of Uttara Bank Ltd of Darus Salam branch, and Mizanur Rahman, its former foreign exchange in-charge; and Abdullah Al Mamun, chairman of M/S Apparels Sources Ltd, and its managing director Md Saiful Alam.

The court also fined the convicts Tk 1 crore each, in default to suffer seven more years in jail.

All the convicts have been absconding since the case was filed against them. Their conviction will be effective from the day of their arrest or surrender.

Judge Dr Md Akhtaruzzaman of the Special Judge Court-3 handed down the sentence in the absence of the convicts.

Earlier, the court recorded statements of eight prosecution witnesses including complainant of the case.

According to the prosecution, two businessmen in collusion with the bank officials took a loan of Tk 4,01,90,706 from Uttara Bank Ltd of Darus Salam branch by submitting fake documents sometime between January 1, 2000 and December 31, 2002.

But the accused misappropriated all the money without investing it to the business.

Later, a case was filed against them with Mirpur Police Station on August 5, 2003.

After an investigation, the Anti-Corruption Commission pressed charges against them on December 5, 2012 and the court framed charges against them on April 9 in 2014.

# WAR CRIMES IN JAMALPUR Testimony against 8 'Al-Badr men' to start May 19

The International Crimes Tribunal-1 yesterday fixed May 19 to record testimony of the investigation officer of the case filed against eight Jamalpur "Al-Badr men" allegedly for committing crimes during the 1971 Liberation War.

The tribunal set the date after completing recording of the testimony and cross-examination of Azab Uddin Mia, 24th prosecution witness in the case.

The accused are Ashraf Hossain, Sharif Ahammed, Abdul Mannan, Abdul Bari, Harun, Abul Hashem, Shamsul Haque, and SM Yusuf Ali. All are absconding except Shamsul and Yusuf.

They are facing five charges including genocide. Shamsul and Yusuf, however, pleaded not guilty.

# Road crashes kill five in three dists Three-year-old among victims

Five people, including a three-year-old girl, were killed and two others injured in road accidents in three districts yesterday and Saturday.

In Chittagong city, Bibi Joynab, 3, daughter of Mostafa Kamal, of Outer Stadium area was killed and her sister injured when a pick-up van hit them while they were sleeping at Outer Stadium on Saturday.

The injured is Mokarama, 7. Police said they seized the vehicle and detained its driver Abul Hashem.

Meanwhile, Roksana Akter, 30, of Halishahar area was killed when a microbus hit her while she was crossing the road in front of Agrabad Fire Service and Civil Defense in the city yesterday.

In Khagrachhari, two motorcycle riders were killed when a truck collided head-on with their motorcycle in Baillyachhari area of Matiranga upazila yesterday.

The deceased were Jayantu Tripura, 22, and Sukandra Tripura, 45, of Punki Karbari Para area in Guimara upazila of the district.

In Jhalakathi, Selim Howlader, 45, of Barguna Sadar was killed when a motorcycle hit him while he was crossing the Barisal-Khulna highway at Galua of Rajapur yesterday.

The motorcyclist was injured in the accident.
