Rapid Action Battalion yesterday fined the capital's Padma General Hospital Tk 10 lakh for anomalies including keeping the father of an eight-year-old patient in the dark even after her death and not letting him see her since she was admitted Sunday evening. The hospital did not have qualified

doctors, nurses and necessary medical equipments, said the Rab team. "A patient at the hospital's Pediatric

Intensive Care Unit died about 30 minutes before we reached there. But her father was outside, not knowing what happened," said Dr Shahzahan, an assistant director (hospital) of Directorate officials. General of Health Services (DGHS).

It was after the team found out what actually had happened to Nilufar, her father took the body back to his village in Brahmanbaria, he said.
