Who will now run the music school?

The fate of the music school that slain Prof AFM Rezaul Karim Siddiquee had endeavoured to give an institutional structure has become uncertain.

Locals of Dargamaria said the school was the lone source of entertainment for music lovers in the area and the neighbouring villages.

Who would run the school as its main entrepreneur is gone, many of them asked.

"It would be difficult for the school to sustain as there is no one to look after it," said Riasat Imtiaz Sourav, Prof Rezaul's son.


Although we did not get any time to think about the school, my grandparents, who are there in the village, would decide on the matter, he said.

Siddiquee said, "The main man behind the school is gone, now the villagers together can run it." Except for Shilpakala Academy in Bagmara upazila headquarters, there is

no other music school in the upazila. Another institution named Premiere Academy is there but it remains closed most of the time. Around one and a half years ago,

Prof Rezaul, who used to play the sitar, organised a meeting with more than 50 villagers and decided to set up the music school there after taking their opinions, said Zahrool Islam.

Zahrool, a teacher of Peerganj Karigori BM College and president of the music school committee, said Prof

Rezaul donated a portion of his land for the school and built a tin-roofed school house.

nium, dugi-tabla, and employed a music teacher at Tk 1,000 per month. Electricity connection was also taken for the school and Prof Rezaul regularly paid the bills, he added.

The villagers showed huge enthusiasm for the school in the beginning, but mysteriously, the number of students started to dwindle in the following months, said Ibrahim Ali Sardar,

the music teacher of the school.

Ibrahim, also a teacher of Basupara Government Primary School, said he Prof Rezaul also bought a harmo- began with around 30 students in August or September of 2015. Then the number came down to 15. "And when the number fell to 3 or 4, I talked to him [Rezaul] and he asked me to continue," he said.

Prof Rezaul used to go to the neighbouring villages for students for the school after he failed to get enough students from his own village, he said.

Bring culprits to book thru' swift probe

EU, 3 countries urge govt

Calling for swift investigations into the recent murders and bringing the culprits to justice, the European Union and three more countries have urged the Bangladesh government to ensure freedom of expression as a fundamental human right.

They have also called upon the government to ensure the protection and safety of lives of all citizens. The calls have been made amid a

series of killings and attacks on online, cultural, rights activists and members of civil society and religious : minorities in the country. The EU, France, Australia and Switzerland have joined other coun-

tries in condemning the recent killings, especially the murders of Xulhaz Mannan, a locally-hired employee of the US embassy in Dhaka, and his friend Mahbub Tonoy, and Rajshahi University Prof Rezaul Karim Siddique.

US with Bangladesh in fight against terror

Says Bernicat; 'killers here think over latest spate of killings they can get away with it'

US Ambassador in Dhaka Marcia Bernicat has said : what have been happening in Bangladesh are not its "characteristics" at all.

The country has a long tradition of tolerance, free speech and certainly a diversity of religions and cultures,

: yesterday.

The US television channel talked to Bernicat via Skype to know her reactions to Monday's killings of USAID official and LGBT magazine editor : Xulhaz Mannan and his friend Khandaker Mahbub Rabbi Tonoy.

She said the violent ideology of the attackers has created "fear" among people, reports UNB.

Responding to a query, the envoy France and Australia say they stand : told CNN that Bangladesh has been a : very strong partner in the fight against terrorism.

She appreciated Bangladesh government's efforts in this regard.

"This is a government that has a track record of successfully fighting terrorism in the past. It is led by Prime Minister Sheikh Hasina who has said on numerous occasions that terrorism knows no religion and no boundary," Bernicat said, adding that Bangladesh government shows zero tolerance to any form of terrorism.

Asked about reported hit lists not just

in Bangladesh, but even in Europe and America, the US ambassador said, "That's exactly correct. There have been numerous hit lists published in Bangladesh over the last vear."

She said they are working "diligently" with the government, civil society and the

she told CNN in an interview media to help strengthen Bangladesh in its fight against terrorism. Asked what the US expects

Bangladesh to do in addressing the issue, the envoy said, "We expect the government and everyone to speak out forcefully to condemn these acts of violence." The questioner from the CNN news-

room asked Bernicat whether the claims of terrorist groups appear to be authentic to her. In response, she said they have

tracked 35 similar attacks in the last 14 months and 23 of those attacks have been claimed by terrorist groups. Earlier in the day, the US ambassa-

dor told reporters that an environment is prevailing in Bangladesh where they [killers] think they can get away with murders.

"I want to say to you all today that no human being deserves the death he got. It doesn't matter what you believe; it doesn't matter what you write; it doesn't matter who you love; and it

Another victim of Kushtia stabbing dies

A man, who was hacked at Fakirabad village in Bheramara on Monday night, died at Rajshahi Medical College Hospital early yesterday.

The dead is Mizanur Rahman, 58. His elder brother, Mojibor Rahman, 65, a retired headmaster of a primary school, was killed on the spot in the same attack.

Police suspect that the attack was carried out as the brothers had protested the stalking of their granddaughter, a class VIII student at a local school.

According to police, one Ariful Islam, son of late Ayub Malitha, stalked the girl frequently.

Failing to stop Ariful despite repeated attempts, Mojibor informed the elderly people in his area about the matter. A village arbitration was held on April 21 but it was not

proved fruitful. On April 24, Mojibor filed a written complaint over the matter to the upazila nirbahi officer which angered the stalker, said police.

Around 8:45pm that night, a group of seven to eight criminals swooped on the siblings soon after they came out of a local mosque after Esha prayers.

The criminals hacked them indiscriminately with sharp weapons and left, killing Mojibor on the spot and injuring Mizanur critically.

a Comilla court ordered exhumation of the body for a second autopsy.

Police on March 30 exhumed the body, with various law enforcement agencies struggling to identify a single suspect in her murder.

Talking to the BBC Bangla later that day, the police superintendent of Comilla said Tonu might have been raped before being killed.

"Considering the circumstantial evidence and symptoms found on the body, it seems Tonu was raped."

A three-member board led by Kamoda Prosad Saha, head of forensic medicine department at Comilla Medical College, conducted the second autopsy later on March 30. Its

report is yet to be prepared. Experts think that no evidence of rape would now be found even if the

crime had been committed. "It is almost impossible to detect rape signs on a decomposed body and after 10 days of the burial," said a "Even if there was rape evidence, it was damaged during the first autopsy and when the body was given a bath for the

first burial." He, however, said the cause of death can be determined by examining even a decomposed body and suggested that it should have been done at a medical college with more experts and

better facilities. The killing of Sohagi Jahan Tonu, a student of Comilla Victoria Collage and a member of the college theatre,

sparked widespread protests across the

So far, the investigators recorded statements of over 50 people, including parents of Tonu and her relatives and friends in phases.

No arrest has been made; nothing is known about the motive.

One of the main reasons behind no visible progress in the investigation could be that it was mishandled from the beginning.

The Rapid Action Battalion took away earth and grass from the crime scene, though it was never officially assigned to probe the murder. The case has been transferred to the CID from the Detective Branch of Comilla police.

"A spot visit might give an impression that some evidence might have been tampered with," said National Human Rights Commission Chairman Dr Mizanur Rahman on March 31.

On the fateful night, upon finding his daughter around 10:30pm, he took her to the Combined Military Hospital in Comilla with the help of some others. Tonu went missing after giving tuition at two cantonment houses in the evening.

According to the death certificate issued by the CMH, she was brought in dead.

Cops claim to have got vital information

Police yesterday claimed to have important information regarding the killers of Rajshahi University teacher Rezaul Karim Siddiquee.

They expressed optimism that they would soon be able to make significant progress in probing the murder case. Commissioner Muhammad Shamsuddin of Rajshahi Metropolitan

part in the killing of the 58-year-old professor of English. Two of them carried a machete and a big knife. The other sped off with the two on a motorbike after committing the murder in a minute or two, the

RMP chief told The Daily Star. Quoting witnesses and the post mortem report, he said the killers first hit Rezaul in his neck from behind and then slit the teacher's throat to confirm his death.

Seeking anonymity, a top RMP official quoting witnesses said the killers shouted "Allahu Akbar" during the killing. "We are trying to identify the killers. We've reliable information about the physical appearance of the killers." Ten police teams have been probing

the murder case while a six-member police team, led by the additional commissioner of RMP, is monitoring

the investigation, he added.

Cops said they quizzed a crosssection of people, including the victim's family members, his fellow villagers, RU teachers and students and traders of the crime scene, regarding the murder.
