City, appearing in their first semifinal, did not work visiting goalkeeper Keylor Navas until Kevin De Bruyne found the target with a stoppage-time free-kick, but Pellegrini said that his side would show a greater cutting edge in next week's return leg in the Spanish capital.

"I don't think they are favourites," said the Chilean, who was sacked after only one season as Madrid head coach in 2010.

"We have the same option as Real Madrid. Of course they have the advantage to play the first game away, so they try to manage the tempo of the game.

"After that they finish at home. But this team play away very similar to how we play at the Etihad. We had good results playing away against Paris Saint-Germain, against Dynamo Kiev and against Sevilla.

"We are not afraid to go to the Bernabeu and we will see which team plays better in

that game."


Pellegrini claimed that his side had shown the "most intent to win the game" and that Madrid had arrived at the Etihad Stadium "with a result in mind".

His opposite number, Zinedine Zidane, contested the claim, asserting that his team "always go out to win", but he agreed that neither side had procured an out-

right advantage.

"We could have scored a goal, but even with scoring a goal we would not have been sure of being in the final," said the Frenchman, whose memorable volley against Bayer Leverkusen inspired Madrid to Champions League glory in 2002.

"I think it is still 50-50. We have got a game at home. We know what we are capable of. Right until the death it will be the same. We are going to have to work hard."

HILLSBOROUGH DISASTER

L'pool unites for tribute

Thousands of sympathisers were expected to pay an emotional tribute to the Hillsborough disaster

victims on Wednesday after a landmark inquest found that 96 Liverpool football fans were unlawfully killed. The day after the biggest inquest in

English legal history determined police blunders caused the fatal 1989 stadium crush, the city of Liverpool was due to come together to reflect on the relatives' arduous 27-year campaign for justice.

The two-year inquest delivered the answer families waited a quarter-century to hear after an original inquest, since quashed in the light of fresh evidence, recorded a verdict of accidental death.


Wednesday's event will also be a chance to consider where the families' struggle goes next, with some campaigners insisting prosecutions must now follow over Britain's worst stadium disaster.

The commemoration outside St. George's Hall in Liverpool, northwest England, in the presence of the victims' families, will be filled with music, speeches and moments of reflection.

The names and ages of the dead were to be displayed on big screens. Some 38

of the victims were between 10 and 19. The event will conclude with a choir leading the throng through the Liverpool Football Club anthem "You'll Never Walk Alone".

The commemoration "is an opportunity for the city to come together with the families and campaigners and show the world the overwhelming spirit of comradeship and solidarity that exists in this city towards them", said Liverpool Mayor Joe Anderson,

Families of the deceased voiced their relief that the jury exonerated Liverpool fans from blame, after examining all the evidence.

The inquests heard testimony that

the local police force had decided to blame drunken, ticketless Liverpool fans for the disaster. But the behaviour of Liverpool fans

was found in no way to have contrib-

uted to the crush outside the ground which led to police opening the gates to alleviate it. Home Secretary Theresa May, the interior minister, was to set out the government's full response to the

inquest's findings in parliament on

Wednesday. English inquests only establish how the deceased came by their deaths.

Now there is set to be a particular focus on the role of David Duckenfield, the senior officer in charge of policing Hillsborough on the day of the disaster.

It was Duckenfield who ordered the opening of an exit gate. That enabled 2,000 fans to surge into the already over-full terracing pens behind one of the goals, causing a fatal crush.

Duckenfield, now 71 and retired, admitted at the inquest he told a "terrible lie" in the immediate aftermath of the match by claiming that fans had

stormed the gate. Following Wednesday's mass event and media analysis of the inquest's outcome, attention is likely to shift towards two huge criminal investigations into the disaster, which should conclude by the end of the year.

Helal backs Salahuddin

Golam Rabbani Helal, an independent candidate for the president's post of Bangladesh Football Federation (BFF) elections, has exclaimed his wish to opt out of the polls in support of incumbent president Kazi Salahuddin.

Helal's retreat following a similar step by Nurul Islam Nuru, who pledged his support to Kamrul Ashraf Khan MP, has effectively left only Salahuddin and Kamrul in race for the BFF hot seat even if the names of both Helal and Nuru will remain on the ballot papers.

"I have had disagreements with Salahuddin bhai about district football. have talked to him in this regard and he has promised to give emphasis on district football if he is re-elected. I think football still needs him," Helal said at a media briefing at the BFF House yesterday.



Rafa requests ITF to reveal results

Fourteen-time Grand Slam champion Rafael Nadal asked for the results of all drugs tests he has taken in his career to be released to the public in a letter to the International Tennis Federation (ITF) on Tuesday.

Nadal filed a lawsuit against former French sports minister Roselyne Bachelot on Monday after she accused him of covering up a failed drugs test.

"It is necessary that our sport becomes a flagship in a world where TRANSPARENCY and HONESTY are two pillars of our conduct and way of living," Nadal wrote in the letter addressed to ITF president David Haggerty.

Bachelot alleged that Nadal -- one of Spain's most loved and admired sportsmen -- faked an injury in 2012, when he missed the final six months of the season due to knee problems, in order to hide a positive drug test. Nadal has never failed a drug test in his many years on the

ATP Tour and has always vehemently denied ever using a banned substance. "I believe the time has arrived and our sport and our

the world," Nadal's letter continued. "I know how many times I am tested, on and off competition. Please make all my information public. Please make public my biological passport, my complete history of Anti-Doping controls and tests.

"From now on I ask you to communicate when I am tested and the results as soon as they are ready from your labs.

"I also encourage you to start filing lawsuits if there is any misinformation spread by anyone. It can't be free anymore in our tennis world to speak and to accuse without evidence."

The ITF acknowledged receipt of Nadal's letter and confirmed he had never committed a doping violation, while inviting the Spaniard to personally make his records public.
