Slovenia opens consulate office

Slovenia, a member of the European Union (EU), yesterday opened its consulate office in Dhaka to boost trade and diplomatic relations between the two countries.

Commerce Minister Tofail Ahmed inaugurated the office on Pragati Sarani in Dhaka in presence of Slovenia's Ambassador to India Jozef Drofenik.

Currently, Slovenia does not have a full-fledged embassy in Bangladesh. Drofenik who is based in Delhi is also responsible for

Bangladesh.

The Swedish embassy in Dhaka issues visas to the Bangladeshis who want to travel to Slovenia.

Bangladesh and Slovenia will soon start exchanging business delegations, the minister said after a meeting with

Drofenik. "We will explore the Slovenian markets as we can export

a lot of goods, especially garment items," Ahmed said. Drofenik said the main task would be deepening the bilateral relations between the two countries. "This would be done through exchange of business delegations."

The balance of bilateral trade between the two countries is in favour of Bangladesh. In fiscal 2014-15, Bangladesh exported goods worth \$36.04 million and imported products worth \$1.6 million, according to data from the commerce ministry.

In 2013-14, Bangladesh exported goods worth \$29.05 million and imported products of \$1 million.

Bangladesh has quality to become leading economy: Chinese envoy

................ Bangladesh has all the potential to become one of the leading economies in the world and China wants to support it in every possible way, Chinese Ambassador in Dhaka Ma Mingqiang said yesterday.

The envoy said the change he has seen on development front in Bangladesh is the sign of a booming economy.

Terming Bangladesh a time-tested friend, he said they just want to see a developed Bangladesh as China believes a well-developed Bangladesh will be an asset for China.

He spoke at a workshop on China-Bangladesh cooperation on human resources development, at a hotel in Dhaka.

The Chinese envoy said Bangladesh has a huge potential market, huge labour force and very strategic geo-location in between three major economies -- India, Northeast Asia and Southeast Asia.

So, finance, capital and technology will come into Bangladesh, he said.

He appreciated the government's efforts to set up 100 economic zones in the country and said more Chinese investor will come here through the initiative.

Ma said it is very important to have qualified skilled workforce for development. "Human resource is the core element of development. We wish to share our experience and technology without any reservation."

Citing an example, the ambassador said China sent 50,000 mid-level officials to Singapore to develop expertise.

China wants to carry out more functional cooperation with Bangladesh in the coming days, he said.

Chinese Embassy Commercial Counsellor Li Guangjun said Bangladesh and China have a lot of work to do in the coming days to boost bilateral relation.

Officials from the Prime Minister's Office, industries ministry and Bangladesh Economic Zones Authority shared their experience acquired through their participation in programmes held in China.

Govt to enforce zero discharge plan for industries by 2030

The government has moved to implement a "zero discharge" plan for all industries by 2030 to control environment pollution, Environment Minister Anwar Hossain said yesterday. Zero discharge means all wastes are recycled and no pollutants are discharged into the environment.

The government has taken various enforcement measures against the effluent producing industries, Hossain said in parliament.

Between 2010 and March this year, 2,191

industrial units were fined Tk 213.09 crore for polluting the environment, he added. BIMAN'S NEW ROUTE

Civil Aviation and Tourism Minister Rashed Khan Menon told the parliament that Biman Bangladesh Airlines will resume operations to three suspended routes: Delhi, Hong Kong and Tokyo.

Foreign aid policy in the works

The government will discourage offers of foreign assistance where it considers: the transaction costs to be unacceptably high, alignment to the government's priority to be insufficient, conditionality to be excessive and contrary to the country's existing

In case of foreign aid, the ERD will prepare a priority list in consultation with the line ministry and planning ministry.

If the project involves over Tk 30 crore, a feasibility study will have to be conducted, and after completion of the primary work of the project, it will have talks with the website. development partners about the project

A fund search committee will be formed in this regard.

The draft policy has also proposed bringing in transparency in the foreign aid received by the civil society and

nongovernmental organisations.

The policy said the civil society and NGOs can take funds from foreign sources but they must be aligned with the national priority. The development partners will have to

report their commitments and disbursements through non-state stakeholders to AIMS to ensure that the government is aware of their contribution and to avoid overlap or uncoordinated work. For monitoring at the local and dis-

trict levels, there will be an institutional body titled Zila Unnayan Samannay Committee, which will regularly inform of the progress through the ERD

The policy said the aim of all the processes is quick utilisation of foreign aid.

An inter-ministerial committee under the leadership of the ERD senior secretary developed the policy.

The draft has been uploaded to the ERD website and will be finalised based on public opinions.

reforms and simplification of the revenue 38.5 percent from 40 percent now.

The FBCCI also proposed raising the taxfree income limit for individuals to Tk 300,000 in 2016-17 from the existing Tk 250,000.

In case of women and taxpayers of more than 65 years of age, the FBCCI suggested increasing the limit to Tk 325,000 from Tk 300,000 now, and for the physically challenged to Tk 400,000 from Tk 375,000.

The FBCCI proposed a uniform minimum tax rate at Tk 3,000 for people living in

and outside city corporations. The trade body also called for reducing

corporate tax for publicly traded companies to 23 percent from 25 percent now, and for non-publicly traded companies to 28-33 percent from 35 percent.

It demanded corporate tax for publicly MA Mannan, state minister for finance traded banks, insurance and other financial and planning, underscored the need for institutions should be brought down to

For non-publicly traded financial organisations, the rate should be 40.5 percent, down from 42.5 percent now, the FBCCI said.

For merchant banks, the FBCCI proposed bringing down the rate to 35 percent from the existing 37.5 percent.

Bangladesh emerges as robust market for apples

FROM PAGE B1 Bangladesh imports the fruit from China, India, South Africa, Brazil, New Zealand, and Argentina. China and India are the largest suppliers of fresh apples, constituting 68 and 9 percent of total market share here, because of geographical proximity.

From 2009 to 2014, imports from countries such as South Africa and Brazil have increased, at a compound annual growth rate of 2.9 and 4.1 percent, according to the report. "Because of this demand, the US industry should consider exploring potential market opportunities for all US apple varieties, especially in more urbanised markets such as Dhaka and Chittagong," said the USDA.

The USDA said high tariffs generally prohibit higher quality, more expensive fruits from entering the Bangladesh market, although as incomes rise, demand for higher quality fruits will also grow.
