### Ministry unable to deal with environment issues: Experts

Though the environmental pollution has emerged as a major issue, the Ministry of Environment and Forests appears unable to take the lead role in dealing with the alarming incidents of pollution and enforcing the existing laws of the land, said environment experts. Talking to the news agency, Prof M Shahidul Islam of

Dhaka University's Geography and Environment department, environment expert Dr Atiq Rahman, ex-additional director general of DoE Md Shahjahan, Poribesh Bachao Andolon (Poba) Chairman Abu Naser Khan and Bangladesh Paribesh Andolan (Bapa) General Secretary MA Matin, observed that the ministry still can play a vital role in using its existence capacity to control environmental pollution with its sincerity. Prof Shahidul Islam said the main role of the ministry is

to protect the environment and ensure development and identified the ministry's lack of manpower, competence, strong monitoring and coordination with other agencies as the main barriers.

Existing laws are enough to check environmental problems, he said.

Dr Atiq Rahman said the Environment Ministry and the relevant agencies, have so far could not take a coordinated

policy to address many environmental problems. He suggested taking integrated plans alongside carrying out an awareness campaign to free every ward of the city from environmental pollution.

Md Shahjahan said the government should properly empower the ministry and DoE as a regulatory body and enforce the laws.

Abu Naser Khan said, "With proper training, the ministry can diminish the environmental pollution using its existing manpower and capacity."

He said the ministry should work in coordination with relevant ministries, including industries and commerce ministries, and agencies like Dhaka Wasa, city corporations, BRTA and Dhaka Metropolitan Police, to check pollution and enforce laws.

MA Matin said, "Environment Ministry doesn't get enough budgetary allocation and due attention to play a strong role. "He said the government should strengthen the "Paribesh Adalat" (Environment Court), to punish all environment offenders and criticised the political parties for not talking about this issue.

Deputy Minister for Environment and Forests Abdullah Al Islam Jakob said their ministry is doing very well in managing environmental problems despite some limitations.

He said they are also taking various steps to overcome shortcomings, including manpower shortage, for playing a stronger role in conserving environment.

been suffering for the last one year. Jahanara Begum, owner of an underconstruction six-storey building at Hijbullah Road of Chingipara is a lucky one who has water in their reservoir and she is sharing it with her neighbours out of compassion.

"I never force them to return empty handed considering their sufferings," said Jahanara.

"I come to the building to take water every day which is a 10 minutes walk, but I

have to go to another house to take my bath and use the dirty pond water for washing clothes and dishes," lamented Nazma, a resident of Kaborsthan Lane.

A local Wasa official said there are four pumps— Kunipara water pump, Shahjalal Road water pump, Momenbagh water pump and a water pump at Basher Pool, but the capacity of the pumps have been dropped around one third to one fourth due to declining ground water level.

He said to solve the problem some new water pumps are necessary and they have already taken initiative to set up two pumps at Mridhapara in Matuail and Shadhur Math in Basher Pool, which will take three to five months to come into operation.

He also said a pump at Dogair is also very necessary but they are not getting any land to do it. "If locals or public representatives can manage the land, we will take initiative to set up the pump," he said.

assistant Razib Ahmed tried to save him, the gang allegedly beat him mercilessly also, and threatened them of dire consequences if the matter is disclosed.

Hearing the scream, other office staff and contractors rushed to the spot and rescued us, claimed the officer.

Abdullah Al Mamun, a contractor who yet. was present there, said, "Habib along with 4/5 men entered the room and beat the official," adding, "Some 20 minutes later, Mahbubur, with his gang arrived and repeated the beating."

Liakat Hossain, an ex-BCL secretary of Phulpur upazila unit, and a contractor, who came for Zakir's rescue, said such

incident is very untoward and harmful for the party's image.

Zakir alleged that he immediately informed Rashed Hossain Chowdhury, upazila nirbahi officer (UNO) and Ali Ahmed Mollah, officer-in-charge of Phulpur Police Station, but to no avail.

Asked, the OC said no case was lodged

"I will lodge a case after talking to the higher authorities," informed Zakir.

The UNO of Phulpur said an investigation was underway.

Denying allegations, Habib and his brother Mahbubur said they just had an argument with the official over starting of the construction work.



locals from Wednesday evening to yesterday noon. Meanwhile, the FD issued a special alert in Chandpai range following the fourth fire there in four weeks.




