### WAR CRIMES TRIAL Verdict on 5 Kishoreganj suspects today

The International Crimes Tribunal-1 is set to deliver the verdict today in a case filed against five Kishoreganj men for alleg-

edly committing crimes against humanity during the Liberation War in 1971. The accused are Gazi

Abdul Mannan, 88, alleged commander of a local Razakar camp, and alleged Razakar Bahini members Nasiruddin Ahmed, 62, his brother Shamsuddin Ahmed, 60, Hafiz Uddin, 66, and Azharul Islam, 60. All of them are from

Kishoreganj. They are facing seven charges, including those of mass killing, murder, confinement, torture, arson and looting. Of the five, only Shamsuddin is now in

Karimganj upazila of

jail, and the rest on the run. The fugitives were tried in absentia.

kept the case waiting for the judgement after the prosecution and defence counsels completed their arguments. Yesterday, the three-member tribunal led by Justice Anwarul Haque announced to deliver the verdict today.

The prosecution claimed they had proved all seven charges "beyond reasonable doubt" and sought the capital punishment for the accused; on the other hand, the defence prayed for their acquittal, saying no charge was proved at all.

If convicted, the accused may face the death penalty. The prosecution produced 25 witnesses, includ- : them, Edris is on the run.

Court asks for probe report on three Moulvibazar accused

The three-member tribunal led by Justice Anwarul Haque also fixed May 29 for recording the prosecution's open-: ing statement and witness's testimony.

On November 16 last year, the prosecution pressed the four charges against the duo.

During indictment, the tribunal said, "The formal charge and the statement of witnesses prima facie demonstrate that the accused persons enthusiastically sided with the policy and plan of the Pakistani occupation army and had allegedly carried out horrific activities of genocide and crimes against humanity and other inhumane acts..."

"The accused persons shall be presumed innocent until they are found guilty," it said.

According to the prosecution, Sulaiman was a Muslim League leader who in 1971 formed the Peace Committee and Razakar Bahini in Shariatpur. Edris was a leader of Islami Chhatra Sangha, then student wing of Jamaat-e-Islami, and joined Razakars. FOUR CHARGES

The first charge says Sulaiman and Edris along with 100 to 150 Pakistani troops, attacked Angaria, Kashabhog, and Modhyapara in Palang upazila (now Shariatpur sadar) on May 22, killed 200 Hindus and one Abdus Samad Sikder, and looted and burnt all houses. The next day the accused, along

# Home boss seeks early US intel

IGP puts Ctg, Sylhet cops on high alert STAFF CORRESPONDENT

Home Minister Asaduzzaman Khan yesterday urged the US to share advance intelligence about activities of militant outfits, if there were any, and provide technological assistance and trainings, saying Bangladesh was stressing on preventing terror attacks.

Meanwhile, apprehending that, after the capital and northern regions, targeted killings might occur in Chittagong and Sylhet, Inspector General of Police (IGP) AKM Shahidul Hoque instructed subordinates stationed there to remain on high alert. "They wanted to provide assistance. We hope they will do

so," the minister told BBC Bangla, adding that the government was taking such assistance from Australia and India. He avoided a question on how foreigners could provide

intelligence when the government was denying links with militant outfits abroad. He reiterated that militant outfits in Bangladesh were home-grown. Addressing a quarterly crime conference at Police

Headquarters yesterday, the IGP asked the commissioners and deputy inspectors general to share relevant information with the officials in Dhaka monitoring and investigating such killings and superintendents of police to visit crime scenes, meeting sources said.

Stressing the need for curbing the crime through community policing, he also instructed close monitoring of SEE PAGE 5 COL 1

Haque 16 months after his retirement," he told journalists at his Supreme Court Bar Association (SCBA) chamber. The CJ on January 19, in a statement marking his first

year in office, said making unusual delays in writing judgements or orders and doing it after retirement was unlawful and unconstitutional. He recently decided to rehear 168 cases involving two

retired judges. The rehearings will start on May 5 by two SC benches.
