

# Open campaign to kill professor

Culprits propagate in social media over his position on veil

A Dhaka University professor is living his life under a 24hour police protection, after a Facebook page administered supposedly by militants openly called for his death for asking a female student to remove her veil during a class.

Police in uniform now guard his campus residence while plainclothes cops follow his movement when he comes out of his residence, said the professor.

"Four police personnel are guarding my house since May 2," the teacher told The Daily Star.

Since the threat, he restricted his movement. Now he goes out of his house only to teach at his department. "I am avoiding all other programmes in and outside the campus as my family members are very worried about my security."

On April 29, he filed a general diary with the Shahbagh Police Station regarding the death threat and sought police protection.


The Daily Star is not naming the professor and his department for security reasons.

The call for his murder comes amid the spate of targeted attacks that saw secular bloggers, writers and people of different faiths and ideologies killed over the last few years.

Contacted, DU Vice-chancellor Prof AAMS Arefin Siddique said he spoke with the Dhaka Metropolitan Police commissioner about the matter and requested him to ensure security of the professor.

"I told him [DMP commissioner] that the persons behind running the Facebook page and calling for his death should be arrested. We have taken the matter seriously."

### HC judgment soon on executive magistracy

The High Court is likely to deliver a final decision on the legality of empowering administrative officials to perform judicial functions this month, as it is about to finish hearing arguments on the seven-year-old relevant writ petition.

In response to the petition, the HC on November 15, 2009, issued a rule asking the government to explain as to why the amended rules of the Criminal Procedure Code (CrPC) giving judicial powers to executive magistrates should not be declared illegal.

Counsels for the petitioner and the state, and two amici curiae (friends of the court) -- Dr Kamal Hossain and Ajmalul Hossain -- had already placed their arguments before the HC on the petition in April last year.

Other two amici curiae -- M Amir-Ul Islam and Rokanuddin Mahmud may place arguments before the same court any day, petitioner's counsel Manzill Murshid told The Daily Star yesterday.

He said the bench of Justice Moyeenul Islam Chowdhury and Justice Md Ashraful Kamal is expected to deliver a judgment on the petition after concluding hearing arguments this month.

Jurisdiction of this bench has to be restored through the chief justice for concluding the hearing and delivering the judgement on this case, as its powers have been changed, Manzill said.

He said Chief Justice Surendra Kumar Sinha has the authority to restore the jurisdiction of the bench for disposal of the petition. Both Dr Kamal Hossain and Ajmalul Hossain had told the HC that perform-

ing judicial functions by the executive magistrates was not lawful, he added. Deputy Attorney General Motaher Hossain Sazu opposed the writ peti-

tion, saying the executive magistrates have been given the powers to take cognisance of some offences for the time being to protect peace in the areas concerned.

Three HC benches had been scheduled to hold final hearing of the petition for its disposal at different times earlier, but they could not do that due to reconstitutions of their jurisdictions.

## Turkey jails 2 journalists

An Istanbul court on Friday jailed two opposition journalists on charges of revealing state secrets, in a trial that has become a lightning rod for concerns about the erosion of press freedom in Turkey.

Can Dundar, editor-in-chief of leading opposition daily Cumhuriyet, was sentenced to five years and 10 months at the closed-door trial, while his Ankara bureau chief Erdem Gul was handed five years in prison, television stations said.

The sentencing came hours after Dundar escaped an apparent attempt on his life by a gunman outside the court-

The two men were acquitted of espionage but were found guilty of revealing state secrets over a story accusing the government of seeking to illicitly deliver arms bound for Syria.

They will not immediately be placed in detention as the court of appeal has yet to rule on the case.

"We will continue to do our job as journalists, despite all these attempts to silence us," Dundar told reporters after the verdict. "We have to preserve courage in our country."

# 35 tons of dead fish appear in a Chinese lake

At least 35 tons of dead fish appeared in a lake in southern China, leaving residents stunned.

The piles of fish washed up in a lake in Hainan province on Wednesday, Chinese state media reported.

Residents expressed concerns on pollution, but local authorities said the fish died as a result of salinity change.

The change in salinity levels likely occurred after a tide pushed the fish up farther into Hongcheng Lake in the city of Haikou, state-run

# ISI 'poisoned' CIA ex-official in Islamabad

The US made secret preparations to evacuate its diplomats stationed in Pakistan to India on the night of the raid in May 2011 on the Abbottabad compound where Osama bin Laden was hiding, unnamed US officials have disclosed, while also suggesting that the then CIA station chief in Islamabad was poisoned by ISI in retaliation for the humiliating commando assault that killed the al-Qaeda chief.
