

DEATH OF ETHNIC MINORITY MAN

Parents claim they got threat to their son's life
Cops suspect suicide

Parents of an ethnic minority man, who was found dead in the capital's Kalyanpur area last month, said they had received threats to their son's life months ago.

Puspita Tripura, mother of deceased Harsson Tripura, 20, said a middle-aged man accompanied by his sister visited their Dighinala house in Khagrachhari several months back and threatened to kill her son. The man told her that Harsson should stay away from his niece and that one would be staying in jail not more than six months for killing him, alleged Puspita.

On April 26, police recovered the body of Harsson, a first-year student of Haji Mokbul Hossain Degree College, from a footpath in South Kalyanpur where he used to live at a mess. His parents met law enforcing officials, seeking justice for their son's death.

Darussalam police detained seven suspects including his friend Sabuj in this connection, but later freed four of them. The other trio were taken on a one-day remand. Checking Harsson's cell phone, Officer-in-charge of Darussalam Police Station Selimuzzaman claimed he was dumped by a girl and was depressed for it. About an hour before his body was recovered, he talked to his mother and told her that he was going to Sabuj's house, claimed Puspita. The OC said he might have jumped from an under-construction building, adding that the autopsy report would shed light on the mysterious death.

ARSON CASE
Mirza Fakhru gets bail

A Dhaka court yesterday granted bail to BNP Secretary General Mirza Fakhru Islam Alamgir in an arson case filed with Paltan Police Station.

Metropolitan Magistrate Maruf Hossain passed the order after Fakhru surrendered before it seeking bail in the case.

During yesterday's hearing, Fakhru's lawyer told the court that his client got bail from the High Court on June 18 last year. The HC in its order said the bail would be valid till submission of a police report.

However, on May 3 this year, police pressed charges against Fakhru and 42 others in the case. So, his client surrendered before the court, said the lawyer.

Sub-inspector Tabibur Rahman, also the case's investigation officer (IO), submitted two charge sheets—one for arson and another for hurling crude bombs—to the chief metropolitan magistrate's court.

Eleven others including BNP leaders Rizvi Ahmed and Amanullah Aman are on bail.

Barrister Rafiqul Islam Mia, Barkatullah Bulu and Habib-un-Nabi Khan Sohel are among the remaining 31 who are now absconding.

The IO also appealed to the court to issue an arrest warrant against them.

The case was filed after a bus carrying public administration ministry staff was set ablaze at Pura Paltan intersection around 6:00pm on December 28 of 2014.

HC stays exclusion of names of 22 naval FFs from gazette

The High Court yesterday stayed for six months a government decision to exclude the names of 22 naval-commando freedom fighters of Gobindaganj in Gaibandha from its gazette notice.

It also issued a rule asking the authorities concerned to explain in four weeks as to why the decision should not be declared illegal.

The bench of Justice Zubayer Rahman Chowdhury and Justice Md Khasruzzaman came up with the order and rule following a writ petition filed by the 22 freedom fighters

'PLOT TO KILL JOY' Mahmudur Rahman sent to jail again after remand

A Dhaka court yesterday sent Daily Amar Desh acting editor Mahmudur Rahman to jail after completion of his remand for the second time in a case filed over an alleged plot to kill prime minister's son Sajeed Wazed Joy.

A metropolitan magistrate passed the order after Detective Branch produced Mahmudur before it. The order came after the IO did not submit any remand petition for quizzing Mahmudur.

The IO appealed to the court to confine him in jail until the investigation was complete. Mahmudur was also placed on a five-day remand on April 25 in the first phase and shown arrested on April 18.

In the same case, journalist Shafiq Rehman was placed on a 10-day remand in two phases.

LAXMIPUR DISTRICT JUDGE COURT PREMISES Demolish within 2 months illegal building on site: HC

The HC bench of Justice Obaidul Hassan and Justice Krishna Debnath issued the directives after a high-powered committee led by Supreme Court's Registrar General Syed Aminul Islam submitted a probe report before it saying that Laxmipur bar association was illegally constructing the building without taking permission from authorities concerned, said petitioner's counsel Manzill Murshid.

The chief executive engineers have been asked to submit a report to HC by July 17 in this regard, added Murshid.

Rab arrests father, son for 'fraud' in Dhaka

Rab claimed to have detained a man and his son from the capital's Jigatola on charge of deceiving people by luring them to buy auctioned cars at a cheaper price and fleeing with their money.

Hafizur Rahman Khan, 70, and Biplob Khan, 28, were arrested along with a Noah Microbus and human hauler on Sunday from their residence, said a press release. Hafizur used to rent residence and offices in different areas identifying him as a freedom fighter, or customs' commissioner or government official to gain the trust of the locals, and offered to sell auctioned cars from Mongla and Chittagong, it added.

The fraudsters used to take potentials buyers to the ports to show them cars and then used to take money as down-payments or full payments and flee from the area. The duo had embezzled over Tk 6 crore, it added.

Man arrested for torturing son in capital

A man was arrested for allegedly torturing his son after hanging him upside down in the capital's Sabujbagh yesterday.

The arrestee is Abdul Hakim, 55, a rickshaw puller, of Wahab Colony under Sabujbagh. Police said the boy narrated the torture to a Dhaka court when police produced both of them before the court yesterday.
