# Six to die, two get life in 3 murder cases

Six people have been sentenced to death and two others to life term imprisonment in three separate cases of murder in Habiganj, Tangail and Bagerhat districts.

A Habiganj court sentenced five people to death for the murder of a boy in Baniachong upazila of the district yesterday.

The convicts are Ali Haider, 50, Abdul Ahad, 46, Renu Mia, 45, Habib

Mia, 52, and Ronju Mia, 45. Habiganj Additional District and Sessions Judge Mafroja Parvin pronounced the verdict.

According to the case, the body of Ziaul Haque was recovered from a water body on May 13, 1994.

The victim's mother Rupchan Bibi filed a case regarding the incident on January 19, 1995. In the case, Rupchan Bibi men-

tioned that the accused including her foster son Ali Haider killed Ziaul and dumped his body following a dispute over property.

Police submitted charge sheet against six people after investigation,

due to uncertainty of resumption of classes.

but one of them died during the trial, said Additional Public Prosecutor Abdul Ahad Faruk.

reports: A Tangail court yesterday sentenced a man to death for killing his wife in Basail upazila of the district in 1998.

The convict is Abul Hossain, 45, son of late Miah Chan of Sonalia Uttarpara village in the upazila.

Judge Mohammad Shorfuddin Ahmed of Women and Children Repression Prevention Tribunal in Tangail handed down the verdict.

married Khodeja Begum, 20, daughter of Dudu Miah of nearby Karatia College Para village in Sadar upazila, in June 1996. Just after marriage, Khodeja was informed that her husband Abul had another wife.

On July 15 in 1998, Abul pressed Khodeja to bring Tk 10,000 from her father's house.

Khodeja went to her father's house the same day and brought Tk 3,000 from him. Angry Abul then beat Khodeja mercilessly, leaving her dead on the spot.

The victim's uncle Shahidul Islam Shahid filed a murder case with Basail Police Station on the same night accus-Our Tangail Correspondent ing Abul and his first wife Jalena

Police later arrested Abul and Jalena and produced them before the court. As Abul made a confessional statement over the killing, police pressed a charge sheet against him, acquitting Jalena from the charges.

Both of them had given confessional statement under Section 164 before the court that they strangled to death Al Amin Sheikh, 18, a student of Belayet Hossain Degree College, on March 6 in 2014 over a personal conflict.

### **Politics** banned at IU

The authorities of Islamic University (IU) have banned all kinds of political activities on the campus for an indefinite period to avoid unwarranted situation.

Following an urgent order of the vice-chancellor of the university, Registrar SM Abdul Latif issued the notice yesterday.

Proctor Mahbubur Rahman told this correspondent that the ban was imposed so that none could create chaos on the campus over suspension of two university officials on May 6.

The suspended officials are assistant registrars Alamgir Hossain Khan and Abdul Hannan. They were suspended after two cases were filed against them for their alleged involvement in the attack on a human chain on the campus on May 4.

One case was filed by IU acting Registrar Abdul Latif and the other by Deputy Registrar Harunur Rashid.

#### Jamaat Amir arrested with bombs

## Dinajpur farmers share experiences of better yield with same cost

It was an unique occasion for around one hundred farmer couples as agro-chemical firm Syngenta Bangladesh Ltd organised a 'field day' at Chowmuhani village under Biral upazila of Dinajpur yesterday.

The event, aimed at facilitating farmers to share their experiences to get better yield of crops, began at around 11:00am.

Sharing his experiences, Abdul Hamid, a farmer of Chawmuhani village, said this year he cultivated BR-28 paddy on one acre of land following the Good Growth Plan introduced by Syngenta this year.

"Under the system, saplings are planted with eight inches gap with balanced and careful application of pesticides, fertilisers and irrigation. Following the method, I got 115 maunds of paddy from one acre of land while other farmers got only 67.5 maunds,"

he said.

Inaugurating the programme as chief guest, Julfiqar Haidar, additional director of the Department of Agriculture Extension (DAE), urged the Syngenta officials to extend their work area to help farmers adopt adequate safety measures while using chemicals in their cropland.

Golam Mostafa, deputy director of Dinajpur DAE, and high officials of Syngenta were present at the programme. Farmers can greatly benefit by adopt-

ing the above mentioned method and it does not require additional spending, they said.

Golam Mostafa informed the farmers that Bangladesh Rice Research Institute released a new paddy variety named BR-63, which is able to produce one tonne per hectare.

Farmers urged the company officials to organise such programmes again.

#### Three stalkers jailed

Three stalkers were jailed for one year each for stalking two schoolgirls at Alauddin Nagar village in Patgram upazila of the district on Sunday evening. Patgram Upazila Nirbahi Officer (UNO) Noor Qutubul Alam, also executive magistrate, delivered the verdict in his office, police said. The convicts are Soyat Hossain, 25, son of Shahidur Rahman of Nabinagar village, Abdul Malek, 22, son of Shohedar Miah of the same village, and Imrul Kayes, 23, son of Azizul Haque of Tepurgari village. Police said they arrested the three while they were stalking two schoolgirls who were returning home from Bawra Arefa Khatun High School in the upazila on Sunday afternoon. They had been stalking schoolgirls on their way to and from the school for a long time, police said quoting locals. Mahfuzar Rahman, officer-in-charge (investigation) of Patgram Police Station, said the stalkers were sent to jail yesterday morning.

#### Worker hacked to death

A man was hacked to death by a local youth at Basantapur village in Kalaroa upazila of the district yesterday. The deceased, Abdul Mannan, 23, son of Ismail Hossain of Monirampur upazila in Jessore, was a worker at a shrimp enclosure owned by one Abdul Khaleque of Keshabpur upazila in Jessore. Quoting locals, police said Mannan, who used to live near the enclosure along with his wife, was sitting outside his house yesterday noon. Around 12:45pm, Saju Hossain, 27, of the same village swooped on Mannan and hacked him with a machete. He died on the spot, Officer-in-Charge Abu Saleh Md Masud Karim of Kalaroa Police Station said. Hearing screams, locals and a police team from nearby Basantapur police-outpost chased Saju and caught him after a scuffle, OC said. Sub-inspector Tanvir Hossain and two constables--Wahidul Islam and Kamalesh Sana--received minor injuries during the scuffle, the OC added.

#### Jewellery shop owner missing

### Child worker beaten dead at Laxmipur bakery

A child worker was beaten to death allegedly by his employer and colleagues at a biscuit and bread factory in Bismillah Road area of Laxmipur Sadar upazila yesterday.

The deceased, Alauddin, 12, son of Abul Kalam of Maguri village in the upazila, was a worker at Ananda Bakery in the town.

Police detained the bakery owner Mohammad Nasir, 32, and its staff Al-Amin, 28, for interrogation.

Victim's father Kalam alleged that Nasir along with other staff of the bakery beat up Alauddin mercilessly for not attending his workplace in early hours everyday, leaving the boy dead around 5:30am.

Later the criminals hung the body from the ceiling of the factory and left the place locking the bakery from outside, Kalam added.

Sub-inspector Kawsar Chowdhury of Chandraganj Police Station said, being informed by locals, police recovered the body and sent it to Laxmipur Sadar Hospital morgue for autopsy.
