148 school management bodies scrapped for taking extra fees

Education ministry yesterday dissolved the management committees of 148 non-government schools under Rajshahi Education Board for taking additional money in tuition and registration fees for the SSC examinations. On February 3, Education Minister Nurul Islam

Nahid asked the institutions to return the additional money within seven working days and warned of stern actions if they fail to do so.

A notice, issued by the ministry yesterday, stated the ministry has found allegation that the institutions did not return the extra fees to the students despite the order.

According to a High Court order, if any school violates the admission policy, the government can dissolve the school management committees.

Barisal SSC results deteriorate

The results of Secondary School Certificate (SSC) examinations of 2016 under the Barisal Education Board deteriorated compared to the previous two years.

Teachers were not properly prepared for the creative question system, especially in mathematics, which might be the reason behind poor results, said Muhamammad Shah Alamgir, controller of examination of the board, in a press briefing at his office yesterday.

This year the pass rate under this board was 79.41 percent and 64,902 examinees passed among 81,728. The pass rates were 84.3 percent and 90.6 percent respectively in 2015 and 2014.

This year the number of schools with zero pass rate is two while 79 schools have 100 percent pass rates under this board, said Alamgir.

Speakers at a programme yesterday laid emphasis on the protection of the migrants who often face exploitations and discriminations in the destination countries.

The safe, orderly and regular migration can bring economic development for the both sending and receiving countries, they added at a public lecture on "Emerging Global Migration and Mobility, Trends and Issues: Swedish Perspective" in the capital.

Morgan Johansson, minister for Justice and Migration of Sweden, gave a keynote presentation focusing on migration and refugee issues.

"We need to prevent labour exploitation and discrimination. Our government is very aware of protecting the migrants' rights. We have a commission in this regard," he said, adding that around 24 percent of the Swedish population was migrants.

The Bangladesh foreign ministry and Swedish justice ministry jointly organised the programme ahead of the upcoming Global Forum on Migration and Development (GFMD) to be held in Dhaka next December.

"The dignity and rights of the migrants must be upheld," said Md Shahriar Alam, state minister for

foreign affairs. Foreign Secretary Md Shahidul Haque also spoke.
