Body of missing farmer found hanging from tree

The body of a farmer, who went missing on Wednesday night, was found hanging from a tree at Charkalikapur village under Dewanganj municipality of the district yesterday morning.

The deceased was identified as Majal Haque, 47, son of late Ijaruddin of the village.

Police, quoting the victim's family members, said there was a longstanding feud between Majal and his neighbour Abdul Kader, 60, son of late Boro Gella, over the ownership of 6.5 bighas of land at the village.

On Wednesday, at around 9:00pm, Majal went out of his house to borrow some money from one of his neighbours, but did not return home.

The victim's nephew Rafiqul Islam found Majal's body hanging from the tree, a half kilometre away from their was hacked to death by a gang of house, while he was going to his cropland at around 6:00am, said police, quoting Rafiqul.

Being informed, police rushed to the spot, recovered the body and sent it to Jamalpur General Hospital morgue for autopsy, said Mostasinur Rahman, officer-in-charge (OC) of Dewanganj police station.

Victim's wife Marichphul filed a murder case with Dewanganj Police station, accusing 16 people, including Abdul Kader, the OC said.
