Ershad rants again rationalising his martial law

Claims Jatiya Party's birth was to restore democracy

Contradicting the fact that he had staged a military coup to overthrow elected president Justice Sattar and grabbed state power on March 24, 1982, former military dictator HM Ershad yesterday claimed that state power was "bestowed" upon him by the president who was "reluctant" to take it up.

"Had there been any other person in the post of army chief...he or she would have taken up the same responsibility," he told Jatiya Party's (JP) 8th National Council in the capital's Institution of Engineers, Bangladesh. He also claimed that JP was founded on January 1, 1986

"to restore democracy in the country" and would not have come into being had the major political parties joined, instead of boycotting, a national election he announced to hold in 1984 and "had the democratic journey been smooth and not stigmatised". "My plan was to return to the barrack after handing over power to elected representatives," said Ershad.

Following President Ziaur Rahman's assassination on May 30, 1981, the then army chief General Ershad staged the military coup before imposing martial law.

His autocratic rule came to an end though a mass uprising of political parties, including the Awami League and BNP, student organisations and professional bodies on December 6, 1990, now observed as "Democracy Restoration Day".

Yesterday he bemoaned the election system, saying it has been jeopardised due to utter failures of the Election Commission and that 84 people have so far been killed in the violence-prone union parishad elections and "none accepted the elections". He also demanded reforming the parliamentary election system, introducing an option to elect parties instead of candidates, claiming it would reduce related violence significantly. "...the parties will nominate their candidates as per the percentage of votes they get. Every party will get three MPs for one percent of votes," he said. Ershad said JP was still in politics and in good shape

overcoming many obstacles and adversities. "Jatiya Party was in power and now is the main opposition party. We will again return to power in the days to come. We all take a vow from here to work hard and strengthen the party to this end," he said.

JP Senior Co-Chairman and Leader of the Opposition in Parliament Raushan Ershad also called upon leaders who left to join other parties to return. "...we will gladly accept you and honour you," she said.

JP Co-Chairman GM Quader urged leaders to unite setting aside misunderstandings and conflicts to make the party stronger and vibrant.

Probe at final stage

Claims home boss without elaboration RU CORRESPONDENT

Home Minister Asaduzzaman Khan Kamal yesterday claimed without elaborating that investigations over Prof AFM Rezaul Karim Siddiquee's April 23 murder in Rajshahi city's Shalbagan area were in the final stage and would end soon.

Addressed a rally Rajshahi University Teachers' Association organised at the Kazi Nazrul Islam auditorium protesting the murder, he also claimed that the killers were not being brought to the fore for the sake of investigations.

He assured ensuring justice and deploying additional police in Rajshahi, especially on the campus.

Urging teachers and students to keep faith on police, Inspector General of Police AKM Shahidul Hoque said they were working internally and not making anything public for the sake of investigations.

Education Minister Nurul Islam Nahid expressed solidarity with a seven-point demand, including a fair investigation and exemplary punishment, and urged law enforcing agencies to take preventive measures to stop recurrence.

EXPLORATION OF THREE OFFSHORE GAS BLOCKS

Petrobangla in talks with three int'l oil companies

Petrobangla commenced negotiations yesterday with three international oil companies (IOCs) for three offshore gas blocks, targeting a conclusion by the end of the month.

The three deep sea blocks -- DS12, 16 and 21 -- are located at depths ranging from 20 to 200 metres, with area 3200 to 3600 square kilometers in the Bay of Bengal in Bangladesh. Petrobangla received formal proposals for

the blocks in the form of request for proposals (RfP) from Singapore-based Kris Energy, South Korea's Daewoo International Corporation, and Norway's Statoil on May 7. An RfP is treated as the final offer.

Prior to submitting the RfPs, Kris Energy and Daewoo initially submitted expressions of interest (EOIs) for the deep-sea blocks in the last week in February in the form of unsolicited offers, responding to a

call from Petrobangla.

Statoil had long been embroiled in negotiations with the government over the blocks without any breakthrough. The Norwegian company submitted its own RfP on the same date to stay in the race. "We'll start the negotiations with

Daewoo on Sunday. Then separate negotiations will take place with the other two, Petrobangla director (PSC) Md Quamruzzaman told the news agency. Petrobangla Chairman Ishtiak Ahmed said the target was to conclude negotiations

with the three IOCs within the current month. "Our final target is to complete the

awarding process by September to allow the companies to utilise the coming dry season for exploration purposes," he said. Ishtiak said through these talks the gov-

ernment would be trying to set a standard for future negotiations over the gas price and other issues in its deep-sea blocks.

"Our shared history and religious affinity provides a

foundation to build this relationship constructively and positively," he added. Aizaz termed Nizami's execution "politically motivated"

and said the war crime trials "flawed".

"As far as the recent trials (war crime trials) are concerned, we've made our views known. We believe these are politically motivated trials, we believe these are flawed trials targeting opposition leaders," he said. However, India has supported the war crimes trial and

said it was Bangladesh's internal issue.

"India has also been supportive of a judicial process to address pending issues of retributive justice for war crimes committed during the movement for the independence of Bangladesh in 1971," said External Affairs Ministry Spokesperson Vikas Swarup after Nizami's execution.

Referring to the 1974 Tripartite Agreement, the Pakistan foreign secretary said the government of Bangladesh had "decided not to proceed with the trials as an act of clemency".

However, there was no mention in the agreement that the war criminals will continue to enjoy impunity and accordingly Bangladesh government tried the war criminals.

Aizaz said it was time for the two countries to pursue a forward-looking approach in the spirit of "forget and forgive".
