# 3 arrested over monk murder

Police yesterday arrested three people in connection with their alleged involvement in the killing of a Buddhist monk in Naikkhangchhari upazila of Bandarban.

The arrestees are Abdur Rahim, 25, Chak. Mohammad Zia, 26, and Sa Mong Chak, 35.

During drives, police caught Rahim and Zia at Tadangkhali Para and Titar Para and Sa Mong at Upor Chak Para under Baishari union around 3:30am yesterday, said Abul Khair, officer-incharge of Naikkhangchhari Police Station.

The OC said the trio were nabbed due to their suspicious movement around the Kyang (temple) where the body of 73-year-old monk U Damma Oaing Cha was found early Saturday morning.

Rahim and Zia belong to the Rohingya community, said police.

Meanwhile, the Buddhist community in Bandarban yesterday staged a demonstration in the town, demanding immediate arrest and exemplary

punishment of the killer(s). They also criticised Home Minister incident".

The monk who dedicated himself to the path of spiritualism a couple of years ago was found dead, with his throat slit, inside Chak Nirvana Bouddha Kyang, about 250 yards from his village Upor Chak Para.

His previous name was Shwe U

His daughter-in-law, Manu Ching, found him when she went to serve food there around 5:00am.

The victim's son, Aung Sa Thoai Chak, filed a murder case accusing unnamed people with Naikkhangchhari Police Station on Saturday evening.

Police were yet to ascertain the motive behind the killing, which resembles recent murders of people of different faiths and ideologies.

Investigators said they were probing the incident keeping in mind possible militant links, among other things.

Mizanur Rahman, superintendent of Bandarban police, yesterday said they would be able to unearth the motive soon.

Locals said the monk had no enmity with anyone and that he used to meditate most of the day.

#### PM reaches London en route to Sofia

Prime Minister Sheikh Hasina reached London yesterday afternoon for a three-day private visit on her way to another three-day official trip to Bulgaria.

During her stay in London on May 15-17, she is scheduled to meet her niece Labour MP Tulip Siddiq, highly placed sources said.

Also a granddaughter of Bangabandhu Sheikh Mujibur Rahman, Tulip gave birth to her first child, a girl, on April 9. Tulip and her husband Chris Percy have named the baby Azalea Joy.

The prime minister has no official business in London, diplomatic sources in Dhaka and London have confirmed.

She accompanies a 39-member delegation, which includes 10 officials from the PMO, four officials from the foreign ministry, an 11member advance security team, eight accompanying security personnel and six official media persons.

Bangladesh High Commissioner in London Abdul Hannan and other high officials received the prime minister upon her arrival by a VVIP flight of Biman Bangladesh Airlines

in Heathrow International Airport. She was then taken to St James Court-Taj Hotel at Buckingham Gate in London where she would stay

during her visit. Hasina is set to leave London for Bulgaria on May 18 to attend the Unesco-sponsored Global Women

#### HC clears way to try Khaleda

The High Court has cleared the way for a lower court to continue trial proceedings against BNP Chairperson Khaleda Zia in Zia Charitable Trust corruption case.

The HC bench of Justice M Enayetur Rahim and Justice Amir Hossain yesterday rejected two separate revision petitions filed by Khaleda seeking a stay on the trial proceedings.

Following yesterday's order, there is now no legal bar for the lower court to continue the trial proceedings against Khaleda, Anti-Corruption

Commission lawyer Khurshid Alam Khan told The Daily Star. Raghib Rauf Chowdhury, a lawyer

for Khaleda, told reports that they would move an appeal before the Appellate Division of the Supreme

Court against the HC order. On April 18, the BNP chief filed two separate revision petitions with the HC challenging a lower court order that rejected her two applica-

tions in the graft case lodged by the ACC on August 8, 2011. One of the applications was filed

for re-cross examination of the investigation officer of the case while the other for scrutinising the case diary.

The applications were lodged with the court at Bakshibazar in Khaleda's

Bangladesh. But it's not correct. This doesn't mean that we are rebuking SWIFT."

"But SWIFT must accept responsibility for the incident. They should help Bangladesh Bank."

SWIFT now says its job is to provide solutions and it is the client's responsibility to ensure the safety of the system, Farashuddin said. "I admit that."

But he emphasised that if SWIFT or any individual provides any system, it is the provider's responsibility to supply a secure system and make sure that it doesn't become vulnerable midway.

The SWIFT system has been working in Bangladesh since 1995.

In March last year, SWIFT wrote to the BB that the Belgian organisation wants to link the SWIFT platform with RTGS.

"The letter contained nothing but

excitement and flattery. It didn't explain how Bangladesh and the BB would benefit if the linking goes ahead," said Farashuddin. Upon receiving the letter, the bank's

executive committee approved it in an irresponsible manner, and the decision was "devoid of common sense", he said. Before the link was established, 13

was connected with the RTGS in November last year without following two or three major procedures, he said.

The connection was supposed to be established after SWIFT provided the BB with a hardware security module. But SWIFT didn't do so.

Later, the module was brought in, but it is yet to be installed, said the former BB governor.

While establishing the link, it was million to the Fed. found that the connection couldn't be established due to the anti-virus embedded with the SWIFT platform.

When the link was established, the SWIFT engineers tried to disable the

anti-virus in vain. Later, the anti-virus was uninstalled because the two systems couldn't be connected while it was active, according to Farashuddin.

involved in the matter were not aware of the changes, he said.

"Because of all these reasons, we think the SWIFT system had been compromised." There was no logic behind estab-

Farashuddin said 18 messages with payment instructions involving \$500 million were sent to the Fed from the BB back office till 7:15pm on February 4. Of the amount, \$200 million was sent for buying bonds from Basel Bank.

"Why did they make payment? Why didn't they issue the 'stop payment' order or recall the fund if they had felt it was suspicious?" The Fed should have smelt a rat as it sent messages to the BB but didn't receive any responses, he said.

Of the five payment orders, the beneficiaries of the four were individuals. Historically, BB's payment instructions involving large amounts are made for institutions. In case of individuals, the amount is small, said Farashuddin.

The hackers had made attempts to steal \$950 million. Of those, advices worth \$101 million were sent, he said.

The BB got back \$20 million because of misspelling of the beneficiary organisation in Sri Lanka. Now, the amount of the missing money stands at \$81.16 million.

mation about two BB officials, said

Farashuddin. "However, the information we have received so far indicates that they were not a party to the crime."

About the recovery of the stolen funds, he said the government and other departments concerned would work jointly to retrieve the money.

Quoting the Filipino-based Inquirer media outlet, which broke the news, Farashuddin said Philippine's casino junket operator Kim Wong is believed to have been holding \$35 million and remittance company Philrem \$17 million. "It is possible to recover more than

\$50 million."

Diplomatic strategies and legal tools have to be used to recover the stolen money, he said. "We have to take assistance from the Fed. We have learnt that they are ready to help," he added.

Last week, the Fed, the BB and SWIFT vowed to work together to trace the stolen \$81 million, following their first-ever joint meeting in Basel, Switzerland.

It was not clear when and where the incident happened.

Both the video and the authorities' decision triggered huge reactions among social media users, many in favour of the students. They said these students did nothing wrong.

However, a couple of reactions were critical, saying the authorities were right to take action.

Contacted, College Principal Prof Md Abu Sayeed said they had to take action for the "interest of the institution". He declined to elaborate.

Generally, those expelled from an institution cannot get admission in the same institution. In case of the two expelled by the Commerce College authorities, it is not clear if they can enrol at other institutions this year.

And the nine students whose admission was cancelled would have to take readmission if they want to continue their studies at the Commerce College, or else take admission in other institutions.
