Assaulting UNO in Feni

8 charge-sheeted

Police yesterday pressed charges against eight people, including Feni district Awami League Vice-President Khairul Bashar Majumder Tapan, in a case filed for assaulting Parshuram Upazila Nirbahi Officer.

Parshuram Police Station's Officerin-Charge Abul Kashem Chowdhury Jalal Uddin, also investigating officer of the case, submitted the charge sheet before the Senior Judicial Magistrate's Court in the afternoon.

Magistrate Sheikh Md Badiul Alam fixed May 26 for hearing the case.

He also rejected a bail petition moved by the three accused and sent them to jail.

OC Kashem said the case was filed under the speedy trial act and the police pressed charges against Tapan, Chithalia Union Parishad Chairman lasim Uddin and six others.

On May 6, local AL leaders and activists allegedly assaulted Parshuram UNO HM Rakib Haider for "not showing respect to Tapan".

Around 10:30am, the UNO, the upazila chairman and some local AL leaders and activists were waiting at Dhanikunda on Feni-Parshuram road to welcome Shipping Minister Shajahan Khan who was scheduled to visit Bilonia land port.

At that time, Mohammad Faruk, a local AL leader, asked Rakib to get introduced with Tapan.

The UNO did not respond to this and Tapan got into a heated argument with Rakib, accusing him of "not showing respect to him". At one stage, the AL leader's followers started beating him up, leaving him seriously injured, according to police.

Rakib was taken to Feni Sadar Hospital.

The UNO's diver, Abul Kashem, filed a case against seven named people, including Tapan, with Parshuram Police Station that night.

Parshuram police arrested six accused of the case while Tapan and Jasim surrendered before a Feni court.

As the meeting started, a committee member said a female guardian had lodged a written complaint against Shyamal that he had beaten her son, a class-X student of the school.

Within minutes, several youths suddenly entered the meeting room and started beating Shyamal.

The headmaster told this correspondent that he later learnt from his relatives that when he was under attack, it was announced over the loudspeakers of a nearby mosque that he had hurt religious sentiment.

Later, he was made to do sit-ups in the presence of the JP lawmaker.

"I was dumbfounded by the incident. I lost sense of what was happening around me... I want justice. I pray that no teacher would ever go through such an ordeal." Shyamal said he didn't say any-

derogatory remarks. The video clip showed that the mob encircling Shyamal was chanting "Joy Bangla" while he was doing

sit-ups. At one stage, Shyamal fell to the ground. He was then made to stand

up and apologise to the crowd. Syed Borhanul Islam, a teacher of Islamic Studies at the school, told reporters that he had never heard of any allegations that the headmaster had

made disparaging comments on religion. The chairman of the school man-

aging committee couldn't be reached for comments.

Earlier, Selim Osman told the BBC that the headmaster was made thing about religion, let alone make to do sit-ups in his presence.

> Meanwhile, Narayanganj Superintendent of Police Khandaker Mohit Uddin said the police have nothing to do with the incident. "Police went there to prevent any cognisable offence from taking place."

In the meantime, detained BNP Joint Secretary General Aslam, who sparked controversy after meeting Safadi in India early this month, and his associate Asaduzzaman Miah were placed on a seven-day remand in connection with a case for allegedly hatching a conspiracy with an Israeli national to topple the Bangladesh government.

The two were arrested by detectives in the capital's Khilkhet area on Sunday.

Known to be a trusted lieutenant him. of BNP Senior Vice Chairman Tarique Rahman, Chittagong-based businessman Aslam came under severe criticism after several photographs showing him with Safadi went viral on social media.

Several photographs posted on the Facebook page, "Mendi N Safadi Center -- for International Diplomacy and Public Relations",

Talking to BBC Bangla Service yesterday, Safadi said he was invited by the youth front of India's ruling Bharatiya Janata Party to attend a programme in New Delhi where he met Aslam. He mentioned that Aslam was

invited to the programme as a political leader of a neighbouring country. The Israeli politician also said

they had not known each other before, and they had a conversation just as guests. Safadi said he couldn't believe

that Aslam was arrested because the BNP leader had a conversation with "Did he [Aslam] kill anybody? He

just had a conversation with an Israeli during his visit to India." Safadi was aware that some media

outlets in Bangladesh had labelled him as an agent of Mossad, the national intelligence agency of Israel.

The Israeli politician said he had nothing to say if anyone considered

him a Mossad agent despite the fact programmes in India earlier this that he leaves posts on Facebook about his activities every hour, deliver speeches at seminars and gives interviews to newspapers.

Meanwhile, the organisers of the programme in India said they were surprised that Safadi was termed a Mossad agent.

Indian Citizens Security Council, which organised the programme in

Delhi, told BBC Bangla that it was not believable that Safadi visited India to hatch a plot to stage a coup in Bangladesh.

FROM PAGE 16 Talking to The Daily Star, Md Humayun Kabir, statistics officer of the Civil Surgeon's Office in Sirajganj, said this is the second consecutive outbreak of anthrax in the district. As many as 87 people in three upazilas have so far been infected in the last couple of weeks, he added.

Earlier, 47 people in Shahjadpur and Kamarkhand upazilas were infected from animals a couple of weeks ago. Of them, 29 were infected in Jamtoil village of Kamarkhand upazila and 18 were infected in Koizuri village of Shahjadpur upazila of the district between May 5 and May 10, he added.

Civil Surgeon Shahed Mohammad Sadekul Islam said apart from providing treatment to the affected, the district health office has also started generating awareness among the locals. He suggested that people should avoid slaughtering any sick animals as well as consuming their meat.

Anthrax is an infection caused by a bacterium called Bacillus anthracis. It is a common livestock disease. Symptoms begin between one day and two

months after contacting the infection.

Immunising animals against anthrax is recommended in areas where there is a history of previous infections. The disease can be transmitted to humans if people get them exposed to infectious cattle or consume meat of any butch-

ered infected animals.

Nothing free in prison

The Daily Star learnt these from three prisoners who wanted to be anonymous. One of them walked out of the jail on March 27 and two others in February last year.

"The jail is apparently hell for those who are unable to manage the money," said a CNG-run auto-rickshaw driver who served one month. He said those prisoners would be

forced to lie down on their left or right

side in a row, which is known in jail as

hilsa fal. The designated cell keeper then pushes the back of the last prisoner in the row with his leg to ensure there was

no room between prisoners, he said. An ex-jail official wishing anonymity, however, said each prisoner is

entitled to get six square feet of space. "I saw two youths crying relentlessly for the whole night on my first day in jail, but the jail people were unmoved,"

said the auto-rickshaw driver. He said he managed Tk 30,000 by pawning two gold bangles and earrings of his wife and survived prison.

The driver was among 30 other drivers who were sentenced to a month's jail each by a mobile court on February 28 in Sadarghat area.

THE PROCESS

Within hours after landing in Dhaka jail, the process of trading starts at Amdanikhana, a certain cell inside the

jail where the newcomers are usually

kept for a night and then moved to gave him Tk 4,000 I had agreed to pay

other cells. After completing initial processes like frisking newcomers and enrolment of the prisoners, the man incharge of the Amdanikhana asks inmates to meet him one by one. He threatens them with sufferings if they do not get enrolled for "service package" costing Tk 3,600. However, one needs to send Tk 4,000 inside that jail so that the recipient gets Tk 3,600. The Tk 400 is the commission for the jail gate staff.

A portion of the first week's toll goes to the Amdanikhana in-charge.

"When my turn to meet the Amdanikhana in-charge came on the first night, he narrated the horrific sufferings of prisoners as far more inmates stay in jail than its capacity," said a Mirpur trader who was arrested in February last year on suspicion of planning subversive activities to destabilise the country.

The jail has around 7,600 inmates against the capacity of 2,650, he was told.

"How will you get water for toilet use and for bathing? the Amdanikhana in-charge went on.

"I got scared. I was about to collapse as it had already been 22 hours since I was arrested. So, I agreed to the package offer," said the man in his 40's.

"When my family members visited me in the morning, the convict who brought me did not allow me to talk to my relatives until one of my relatives

He was among 32 people picked up from their homes at Senpara Parbata on February 25 last year. His neighbour was among the 32 people arrested and he too gave this paper almost an identical picture.

Although it was extremely expensive, when he wanted to buy some extra food, they supplied him.

About Tk 3,000 a week is needed for additional food items.

"Whenever we wanted, we the inmates who bought the package were allowed to sit inside the cell during the daytime. But, those, who did not buy the package, were not allowed. They were only allowed to use the toilets outside which were too filthy to be used and most of the time had no water," he said recollecting his days in jail. The jail code, however, says the

MORTAR ATTACK Dhaka lodges around 30 percent prisoners, who are strong protest with Myanmar

Dhaka yesterday lodged a strong protest with Naypyidaw over the recent mortar shell attacks and repeated intrusion by Myanmar secu-

rity forces inside Bangladesh territory. In a note verbale sent to the Myanmar government through the Myanmar embassy in Dhaka, the foreign ministry said the incident of mortar shell attack targeting a Border Guard Bangladesh (BGB) camp on May 12 was most unfortunate and

totally unwarranted. Such unprovoked firing by the Myanmar security forces is not accept-But some unscrupulous officials able at all, said the strongly-worded protest note.

The ministry further said the Myanmar security forces illegally entered Bangladesh territory frequently despite repeated requests from the Bangladesh side not to violate the international rules on the border. Tk 2 for it and even that is illegal, the

It also urged the Myanmar authorities to take appropriate steps to reduce tension on the border and refrain from such attacks in future.
