The Supreme Court yesterday directed the authorities concerned to maintain status quo for six weeks on the possession of a land used for the Bihari camp in the capital's Pallabi area where some 70,000 stranded Urdu-speaking Pakistanis live.

The four-member bench of the Appellate Division of the SC headed by Chief Justice Surendra Kumar Sinha passed the order on a petition filed by two residents of the camp seeking status quo on the possession of the 97 acre land. Hafizur Rahman Khan, lawyer for the petitioners, told The

Daily Star that people of the camp cannot be evicted for six weeks following the apex court order, adding that the government and the camp's residents would have to maintain status quo on the possession of the land following the SC order.

The petition was moved before the apex court after the High Court on March 29, upheld a government decision to evict the people, who live outside their designated camps, from the government land.

However, the HC ordered the government to rehabilitate those evicted persons who had national identity card and were loyal to Bangladesh as soon as possible.

The HC gave the verdict hearing after some Urduspeaking people of the camp and Odhikar, a rights organisation, filed nine petitions with it between 2001 and 2011, challenging the eviction move.

ICT orders to publish ads for Mymensingh fugitive STAFF CORRESPONDENT

The International Crimes Tribunal-1 yesterday ordered the authorities concerned to publish ads in national dailies asking Wajuddin, a war crimes accused from Mymensingh, to appear before it within two weeks from the publication date.

Earlier, police submitted a report to the tribunal mentioning that they could not arrest the accused yet, Hrishikesh Saha, the case's conducting prosecutor, told The Daily Star yesterday.

Wajuddin, 70, is one of the two accused from Mymensingh, who allegedly committed crimes during the Liberation War.

Another accused, Riaz Uddin Fakir is now in jail. The tribunal fixed June 6 for passing the next order in the case.



SC upholds tariff hike on int'l incoming calls

The Supreme Court yesterday upheld a decision to hike tariff on international incoming calls from 1.5 cents to 2 cents (Tk 1.60) per minute. The four-member bench of the Appellate Division

headed by Chief Justice Surendra Kumar Sinha passed the order after cancelling a High Court verdict in this regard. Following the directives of Bangladesh Telecommunication Regulatory Commission, the authorities of Bangladesh Telecommunications Company Limited

(BTCL) hiked the tariff from 1.5 cents to 2 cents in November last year, Masud Ahmed Syeed, a lawyer for BTCL, told The Daily Star. The increased tariff will remain effective following the SC order, he added. Four members of international gateway forum -- Orbit Telecom Limited, UK; Telecom Asia, Singapore; Transman

Limited, Singapore; and ITC Limited, Singapore -- filed separate petitions with the HC, challenging the BTCL decision. The HC on January 9 this year disposed of four petitions

and ruled that the issue of increasing the international incoming call rates would be settled through arbitration.

Later, BTCL and international gateway forum filed two separate leave-to-appeal petitions with the SC.
