Thousands in DND area marooned

Thousands of people living inside the Dhaka-Narayanganj-Demra (DND) dam areas have been marooned following incessant rains for two days caused by cyclone Roanu. Low-lying areas of Fatullah and its surrounding DND areas have been submerged, with many points going under ankle to waist-deep water causing immense sufferings to locals. Many schools and madrasas have been closed.

About 56 square kilometres of low-lying areas inside the 32-kilometre dam -- Sastapur, Tallasha, Gaptola, Kayempur, Chandmari, Islambagh, Shahidnagar, Enayetnagar, Sabujbagh, Kutubpur, Pagla, Aliganj, Dapa, Raghunatpur, Lamapara, Patantoli, Haziganj, Dupata and Jalkori -- have been swamped by rainwater.

People living inside the embankment said grabbers occupied most of the area's canals, leaving little scope for rainwater to run off. Delwar Hossain, a resident of Tallasha area, alleged that many people constructed structures occupying canals and water bodies and many industries were set up on the canals at Fatullah, restricting rainwater flow.

Kotubpur Union Parishad Chairman Monirul Islam Monto said he had informed the deputy commissioner and upazila nirbahi officer of this yearly incident.

Water Development Board Executive Engineer (Shimrail Pump Station of Shiddirganj) Golam Sarwar told the news agency that four 128-cusec pumps and 22 small ones were running continuously.

Two held for swindling bKash accounts in Ctg

Police arrested two persons in Satkania upazila of Chittagong on Saturday night in connection with swindling money from several bKash accounts through forging SIM (subscriber identity module) cards.

They are Kutub Uddin, and Md Farhad. Police said Kutub was a former employee of bKash in Bandarban, while Farhad a distributor of bKash in the upazila.

The duo allegedly swindled one Nurunnahar Begum of the upazila out of Tk 20,400 from her bKash account, registered on her Robi SIM, which was recently registered through biometric system, said police, adding that they started investigating the complaint she filed with Satkania police on Saturday.

Nurunnahar in the complaint alleged that her Robi SIM was locked suddenly, and when she went to nearby Robi customer care centre to resolve the problem, the officials told her that the SIM was withdrawn and registered by Kutub, said AKM Emran Bhuyan, assistant superintendent of police (ASP) of Satkania circle in Chittagong.

After showing necessary documents, she got back the ownership of the SIM card but found that all the money from her bKash account registered on the SIM was swindled, added the ASP. "We came to know that a group of fraudsters withdrew over 150 Robi SIM cards bearing bKash accounts," said Emran, adding that the duo confessed to their involvement in the forgery and swindling.

Mentioning that there might have been some loopholes in the biometric SIM registration system of the mobile operator, the ASP said, "We talked to 25 Robi subscribers, whose SIM cards were forged by the duo.

During the primary interrogation, the arrestees admitted that they withdrew Tk 35,000 from seven bKash accounts, he added.

Contacted, Ekram Kabir, vice president (communications and corporate responsibility) at Robi Axiata Limited, claimed that there was no loophole in the security system on their side. "...The biometric verification of SIMs of all subscribers is in still progress. It is worth mentioning that police could arrest them with our help," added the official.

Journos demand announcement of 9th Wage Board within a month

Sangbadik-Sramik-Karmachari Oikya Parishad (SSKOP), a platform of journalists, workers and employees, yesterday threatened to go on a greater movement if their demand for the announcement of the 9th Wage Board for the media people is not met by a month.

SSKOP leaders came up with the ultimatum from a rally held on the Jatiya Press Club premises.

They said journalists, workers and employees have been subjected to discrimination although the salaries of the government service holders and members of the judiciary have seen a good hike.

Former president of a faction of Bangladesh Federal Union of Journalists (BFUJ) Monjunul Ahsan Bulbul, former BFUJ secretary general Abdul Jalil Bhuyian, BFUJ secretary general Omar Faruk, president of Dhaka Union of Journalists (DUJ) Shaban Mahmud, and general secretary of Dhaka Reporters Unity Raju Ahmed, among others, addressed the rally with President of Bangladesh Federal Union of Newspaper Press Workers Alamgir Hossain in the chair.

Omar Faruk said if the government does not announce the 9th Wage Board for journalists, workers and employees within the next one month, a greater movement will be waged after visiting the union units across the country.

Teenage girl raped in capital

A 17-year-old girl was allegedly raped by a youth in the capital's Paltan yesterday.

The girl, who passed SSC examination this year from a school Keraniganj, on the outskirts of the capital, got acquainted with Tamim, 24, through Facebook a few months ago.

Tamim, introducing himself as a student of a public university, used to chat with her. And he invited her to meet in the capital's Dainik Bangla area on Sunday afternoon. They met each other there, and Tamim took her to a restaurant, the victim's father quoted her daughter as saying. The youth got her unconscious mixing sedatives in her drink and raped her, alleged the father, adding that the accused dumped his unconscious daughter beside a road near TSC on the Dhaka University campus.

The girl, however, managed to call her father, who rescued and rushed her to Dhaka Medical College Hospital. The father demanded arrest of the rapist and said he would lodge a case in this regard.

Abu Bakar Siddique, officer-in-charge of Shabbagh police, said he heard about the incident and that police were collecting information about it.

Obituary

Bahauddin Bhuiyan, a valiant freedom fighter, passed away yesterday evening at his home Bhuiyam in Narshingdi Sadar upazila, aged 77. He left behind one daughter.

He retired as the deputy director of Power Development Board (PDB) in Ghorashal. He was the general secretary of the district Awami League's Relief and Social Welfare unit.

Bahauddin will be buried at his family graveyard in Narshingdi after the Juhar prayers today.
