## 4 to die for killing fish trader

A court here yesterday sentenced four people to death for killing a fish trader at Tongi of the district in 2006.

The convicts are Rubel, 35, Ashraf Ali, 31, Solaiman, 31, and Babu, 32.

Judge Md Fazley Elahi, additional district and sessions judge-1 of Gazipur, also awarded 14 years' rigorous imprisonment to them and fined Tk 10,000 each for trying to extort the trader.

According to the prosecution, the convicts demanded illegal toll from fish trader Moksed Ali Sentu on January 27, 2006.

# ASI, writer held on rape charge

An assistant sub-inspector (ASI) and a writer of Dagonbhuiyan Police Station, arrested on charge of raping a justice seeker woman and aiding in the heinous act, were sent to jail through the court yesterday.

The arrestees are ASI Delwar Hossain, 36, and writer Abdul Mannan, 48, said police.

The 35-year-old woman, hailing from Dagonbhuiyan upazila, said she went to the police station on Sunday morning to file a complaint over a family dispute.

"Mannan helped me write a complaint and then took me to a room of an adjacent building around 11:00am. Mannan left the place and ASI Delwar raped me there," she alleged.

"Delwar and Mannan were arrested following the allegation made by the woman. Doctors at Feni Sadar Hospital conducted a forensic test of the woman today [Monday], OC Aslam said.

# Soft variety sugarcane gains popularity in Gobindagani

Chewed for juice, the item brings better profit to farmers

Cultivation of HYV sugarcane Q-16 sees gradual increase in Gobindaganj upazila under the district as the soft variety, chewed with relative ease, sells for much higher prices than that of local varieties.

Its demand has highly increased, especially amid the prolonged heat wave this year.

Many farmers in Gobindaganj upazila traditionally cultivate ordinary local varieties of sugarcane for supplying to Rangpur Sugar Mills at Mohimanganj in Gobindaganj upazila but the mill authorities often pay low price, leading to gradual reduction in sugarcane cultivation, said Rajab Ali, a grower.

Bakchar village in Gobindaganj upazila started cultivation of Q-16, locally called 'chewing sugarcane', and now its cultivation has spread to several other villages in the area, even in some places of Mokamtola in Bogra district.

"Ten years ago, I started cultivating chewing sugarcane on two bighas of land and earned Tk 15,000 to 20,000 per bigha after covering the production cost. Now the demand and price have multiplied," said Montaz Ali of

Seeing his success, some 20 farmers of the village started cultivation of the high yielding variety sugarcane within next two years. By this time, its cultivation spread to adjoining ten villages A decade ago, a few people of including Kamadaha, Kalitola,

Mastha, Nayapara Chawghaia, and Panthapara. Now the farmers are using modern

technology for growing Q-16 sugarcane and they earn Tk 65,000 to 70,000 from a bigha of land, spending Tk 20,000 to Tk 25,000 for inputs, said Altaf Hossain, another grower.

The HYV cane Q-16 has created an opportunity to earn better from the same area of land, several growers said, adding that wholesalers often procure the crop from fields with their own carrying cost.

Agriculture officials are encouraging farmers to cultivate Q-16 sugarcane for better gains, said AKM Ruhul Amin, deputy director, the Department of Agriculture Extension, Gaibandha.

#### BSF kills Bangladeshi youth

Indian Border Security Force (BSF) shot dead a Bangladeshi youth yesterday afternoon near Kanakata Premcharanjouth border in Tentulia upazila of Panchagarh district. The dead was identified as Sujan, 22, son of Sanaullah of Premcharanjouth village under the upazila. Quoting villagers, commanding officer of Panchagarh BGB 18-Battalion Lt Colonel Al Hakim Mohammad Nowshad told this correspondent over cellphone that three people including Sujan had gone to the Gabra River near border pillar No 38/3-S. Members of BSF of Lochugoch Camp opened fire on them around 3:45pm, leaving Sujan critically injured. The two others escaped unhurt. Soon after the incident, villagers brought Sujan to Tentulia Upazila Health Complex where the on-duty doctor declared him dead.

#### Youth murdered

A young man was beaten to death at Mirzapur village in Keshabpur upazila of Jessore district early yesterday. The deceased is Sumon Mandol, 34, son of Gopal Mandol of Kusulpur village in the upazila. Police arrested one Tania Khatun, 20, wife of Belal Hossain of the village, in connection with the incident. Criminals beat Sumon, leaving him dead on the spot when he was going to a paddy field around 6:30am. Sumon was killed for illegal relationship with a housewife, said Sahidul Islam, officer-in-charge of Keshabpur Police Station. The body was sent to Jessore Medical College Hospital morgue for autopsy, said the OC. A case was filed, he said.

#### Hundi trader arrested

# traceless for 18 days

A maize trader of the district, who went missing 18 days ago, still remains traceless.

On May 5, Arifuzzaman came to Jaldhaka upazila for business purpose and withdrew Tk 5.5 lakh from Jaldhaka branch of Islami Bank on the day, said his elder brother Hasanur Rahman.

He did not return home since then and his abandoned motorbike was seized from Golmunda Bazar in Jaldhaka upazila the following day.

The victim's brother Hasanur filed an abduction case with Jaldhaka Police Station on May 12, accusing

Alam, Mozammel Huq, Jahangir Alam and Md Tareque. Arifuzzaman's father

alleged that police are reluctant to arrest the accused for some mysterious reasons while they are moving freely in the town.

However, police claimed that law enforcers arrested Mozammel Huq, one of the accused, and produced him before the court but he was later freed on bail.

Contacted, Delwar Hasan Inam, officer-incharge of Jaldhaka Police Station, said they are sincerely investigating the incident.

"We have gathered much information and made significant development in this case but cannot disclose it for the sake of investigation," said the OC.

## Missing maize trader Locals besiege health complex as boy dies 'unattended'

According to residents of Dinajpur's Khansama upazila, the local health complex has been without doctors and nurses since yesterday morning.

The unfortunate situation that saw many patients arrive only to find no medical professionals present to offer assistance turned tragic when a child died, allegedly without any treatment.

Mizanur Rahman of Bhandardah village brought his two-and-a-half-year-old son Luhin to the compex at around 10 a.m., after Luhin had fallen into a nearby pond.

According to Mizanur, a doctor arrived 45 minutes later and declared the boy dead without examining him properly. As news of the tragedy spread, relatives and locals stormed the health complex.

"My son's life could have been tion," he said.

saved if doctors had treated him immediately," says Mizanur, "The doctors are responsible for this. Without touching my son they declared him dead and told me to

take him home." Angry villagers told reporters the absence of doctors and deaths of patients due to wrong treatment are common phenomena at the health complex.
