
Payra Deep-sea Port Project at a glance



Deep-sea port beckons

Shipping ministry sources said the PPA is now scrutinising proposals of various governments and their companies for different components of the mega project. Further MoUs may roll out next month.

The Rabnabad channel is situated in Meghna Estuary on Tentulia River in Patuakhali. It is about 270km far from the Chittagong Port and 90km from Mongla Port. This site was chosen as it has available land along the channel with an average height of two metres above sea level. The land does not submerge during monsoon and it is well connected by road and river networks.

According to techno-feasibility study prepared by British firm HR Wallingford & consortium, the Payra port will require a total of 7,000 acres of land. Of this, 6,000 acres will be used for port development, 500 acres for coal terminal and the remaining for resettlement of people affected by construction of the port.

HR Wallingford has been carrying out a series of studies, including environment and resettlement, since January 2015.

The top component to be undertaken by the PPA itself with help of other nations is the conservancy and port management to ensure safe navigation of ships. This job includes planning and developing the port.

The PPA would also develop the core port infrastructure. This covers the essential infrastructure for the port estate as a whole, sewage, drainage,

services, road and railway access across the port estate.

The G2G contracts will be awarded for housing, education and health facilities of the port officials and developing port community.

A dedicated small power plant will be built soon so that Payra port can meet its own electricity demands without depending on other sources.

A multipurpose terminal, one kilometre in length, would be built by 2018 on the basis of G2G cooperation. This terminal will have cargo storage facilities and handle all cargoes.

A one-km long container terminal will be built by end of 2018 under FDI. This terminal must be able to handle containers that would be transshipped for onward movement by barge up to Dhaka or Mongla or Chittagong or moved by road or railway. A second terminal of same specification will be built later, but it would be run by private sector.

A dry bulk terminal on 500 acres of land will be developed by the end of 2018 to help import 40 million tonnes of coal per year for up to eight planned coal-fired power plants. This terminal will also facilitate import of limestone for de-sulphurisation. The facility will handle other dry bulk cargoes like cement clinker.

Payra will also host an LNG terminal to facilitate import of Liquefied Natural Gas (LNG) that would be used for a gas-fired power plant or fertiliser

what death is. His mother Sakhina Begum, 45, will never use those sandals again.

Reckless driving of an illegal battery-run auto-rickshaw claimed her life just a couple of hours ago.

All this happened before the very eyes of Yusuf at Tin Rastar Mor in the city's Mohammadpur around 11:00am. Sakhina along with her son was

riding the three-wheeler on her way to her daughter Afsana's Mohammadpur home from South Keraniganj. The two were seated on one side of the auto-rickshaw which

by design had no doors. When they reached Tin Rastar Mor, the auto-rickshaw driver swerved to avoid a head-on collision with another vehicle. Within a blink of an eye, a CNG-run auto-rickshaw hit the battery-run three-wheeler, throwing the mother and son off the vehicle,

according to witnesses. With injuries to her head and face, Sakhina was taken to Zainul Haque Sikder Women's Medical College and Hospital and later to Dhaka Medical College Hospital where doctors declared her dead.

The child miraculously escaped unhurt.

Defying a ban, battery-run autorickshaws have been plying many roads across the country for years, largely due to lax enforcement of law. These three-wheelers often cause fatal accidents.

Rana Hasan, who took the two to the hospitals, said he saw the child kneeling beside the woman on the road and went to help them.

Sakhina's nephew Babul Mia said Yusuf is the youngest among the three daughters and two sons of the deceased. His father Babul died when his mother was pregnant with

Palestinian PM dismisses Netanyahu's direct talks proposal

Palestinian Prime Minister Rami Hamdallah yesterday dismissed an Israeli proposal for direct negotiations instead of a French multilateral peace initiative, calling it an attempt to "buy time". Hamdallah made the comments as

he met French Prime Minister Manuel Valls, who has held talks in Israel and the Palestinian territories this week to push Paris's peace initia-"Time is short," Hamdallah said.

Netanyahu is trying to buy time... but this time he will not escape the international community." Netanyahu has rejected the plan and called for direct negotiations. Valls told Netanyahu when he met him on

Israelis and Palestinians have been at a standstill since a US-led initiative collapsed in April 2014. Palestinian president Mahmud Abbas has welcomed the French plan, but Netanyahu has repeatedly expressed his opposition while saying he is willing to meet Abbas at any time. On Monday, he told Valls that

France should host a summit between the two men in Paris. Palestinian leaders say years of

negotiations with Israel have not ended its occupation, and they have pursued a strategy of diplomacy at international bodies. Valls has sought to address Israeli concerns over the French ini-

tiative, saying it would not try to impose a solution and that negotiations between the two sides would ultimately resolve the conflict. He has called himself a "friend of

Israel" during his trip, and said Israeli security must be guaranteed.

Yesterday, the HC gave the government four weeks to explain as to why its negligence and failure to release Zobed would not be declared unconstitutional and why the victim would not be compensated with Tk 20 lakh. The bench of Justice Moyeenul

Islam Chowdhury and Justice Md Iqbal Kabir came up with the rule following a writ petition filed by rights organisation -- Children Charity Bangladesh Foundation.

The home secretary, law secretary, High Court registrar, the then judge of Satkhira's Additional Sessions Judge's Court-2, inspector general of prisons and jail superintendent of Satkhira have been made respondents to the rule.

The HC will deliver a final verdict on Zobed's compensation after holding a hearing on the rule, which could take several months, said lawyers. Zobed was jailed for life in 2001 for

poisoning his eight-year-old daughter Lily in 1994. He was acquitted in 2003 by the HC, petitioner's lawyer Abdul Alim told The Daily Star. But the Satkhira's Additional

Judge's Court-2 never sent the acquit-

tal order to the district jail.

The superior court's verdict was forwarded to the local court. However, the Satkhira court said to have ordered the officials concerned to keep the HC judgment in the record room and did not send it to the jail, Alim said.

Alim said Zobed was released from prison on March 2 this year and Children Charity Bangladesh Foundation then collected relevant documents and filed the writ petition with the HC on May 19 seeking necessarv orders.

Zobed said he informed the jail authorities in 2005 about the HC verdict acquitting him.

"I sent eight letters to the Additional Sessions Judge's Court of Satkhira through jail authorities between 2005 and 2010 seeking information about the status of my appeal filed with the High Court ...," he said.

"But I did not get any reply," said Zobed, adding that he is now leading a life like that of a helpless person.

On February 24 this year, additional public prosecutors of Satkhira court Zillur Rahman and Fahimul Haque prayed to the Additional Sessions Judge's Court-2 of Satkhira for the release of Zobed Ali.

The court on March 2 ordered his release.

In the condemnation resolution, opposition leader Mehmoodur Rasheed demanded the government raise the issue before international human rights organisations. He argued against the executions stating that the Bangladesh government awarded "death penalties to Jamaat-e-Islami leaders for their love for Pakistan", reports dunyanews.

Pakistan Jamaat-e-Islami chief Sirajul Haq claimed that Bangladesh Prime Minister Sheikh Hasina was working on instructions of the Indian government,

the TV station said on its website.

Sirajul had led funeral prayers in absentia of the Bangladesh chapter's leaders.

Diplomatic tension between Bangladesh and Pakistan rose significantly over the war crimes tribunal Bangladesh had asked Pakistan not

to interfere in its internal affairs, like trials for crimes against humanity. The country had also asked Pakistan "to stop misinterpreting" the 1974 tripartite agreement signed by Bangladesh, India and Pakistan.

Jurists, rights activists hail

FROM PAGE 1 The SC upheld a High Court verdict that was delivered in 2003 to bar law enforcement agencies from making arbitrary arrests on suspicion and torturing detainees on remand. It, however, said it would come up with some modifications to the HC judgment and guidelines in the full text of

the order.

Eminent jurist Dr Kamal Hossain said, "This is truly a landmark judgment, since it will ensure protection of fundamental rights of citizens in relation to arrest, detention in custody, remand and interrogation, as well as assure protection against torture, and related abuse of these powers, by those who rely on outdated laws and practices, which are no longer valid under the constitution.

"Thus, this judgment will assure citizens of constitutional protection appropriate for the 21st century, and not allow unconstitutional practices such as arbitrary arrest, unlawful interrogation and detention and torture going back to the 19th century and colonial times ..."

Dr Kamal, a lawyer for the petitioners, made the observations in a press statement.

M Amir-ul Islam, noted jurist and another lawyer for the petitioners, said since the Appellate Division dismissed the government's appeal challenging the HC verdict, the relevant laws must be amended.

Justice Md Awlad Ali, a former High Court judge and vice-chairman of Bangladesh Legal Aid and Services Trust (BLAST), one of the three organisations that filed a writ petition over the issue in 1998, said, "This is a landmark judgment. It will protect people's constitutional rights largely."

The petition was lodged following the death of Shamim Reza Rubel, a student of Independent University in Dhaka, due to

brutal torture in police custody. It was aimed to stop such deaths,

said noted jurist Shahdeen Malik. "Incidents of police torture have increased recently. However, it is a matter of hope that following the judgment, police torture will come down and we will move towards becoming a civilised nation," he said.

Rights activist Sara Hossain, also a lawyer for the petitioners, said, "This judgement is a big weapon. It proves that people's rights can be established through joint efforts by the court, lawyers, mass media and human rights and social activists." Nur Khan Liton, acting executive

director of rights body Ain o Salish Kendra, another petitioner, said the petition had been filed to stop arbitrary arrest of any suspect and torture in police custody. He added, "With this verdict, our 18-

year-long legal battle to protect human

rights now reaches a significant level and with the full implementation of the guidelines [already set by the High Court], our victory will be achieved." While there is a rising trend of arbitrary arrests and enforced disappearances in the country now, the full

implementation of the guidelines will

help curb the phenomena, he said.
