

HOW TO DISHONOUR YOUR MARTYRED HEROES

Roanu leaves port city with Tk 209cr damage

It has been almost a week since Cyclone Roanu hit the country and left a trail of devastation in its wake, causing a damage of about Tk 209 crore in the port city, according to Chittagong City Corporation.

Due to gusty wind and rainfall as well as tidal water, different roads, culverts, drains, footpaths and lightspoles-wires got damaged in different city areas, said CCC sources.

Around 90km paved, unpaved and brick made roads were damaged, they said, adding, the extent of the damage is about Tk 162.50 crore.

Contacted, Lt Col Mohiuddin Ahamed, chief engineer of CCC, said most of the damages occurred in Bakalia and coastal areas like Uttar and Dakkhin Patenga.

About 20km of footpaths, 17km of drains, five culverts/bridges, about 300 electric poles, 5,000 street lights and about 50km of electric wires got damaged, said CCC, adding, the amount of damage is about Tk 46.50

The storm also knocked down homes and toppled hundreds of trees, they further said.



Recording of testimonies

KIBRIA MURDER CASE

resumes

A Sylhet court yesterday resumed recording of testimonies of witnesses in the former finance minister SAMS Kibria murder case in the absence of former state minister for home Lutfozzaman Babar, one of the accused in the case.

Judge Makbul Ahsan of Sylhet Speedy Trial Tribunal recorded the testimonies and fixed June 1 and 2 for the next hearing, said Kishore Kumar Kar, public prosecutor of the tribunal.

Twenty out of 171 witnesses so far gave their depositions before the tribunal.

During yesterday's proceedings, 13 accused were present at the court, but Babar was not due to his sickness, said the PP.

On September 13 last year, the court framed charges against BNP leaders Babar and Harris Chowdhury and 30 others in the case.

Of them, 13 accused are in prison, nine on bail and the rest

including Harris on the run. On January 27, 2005, five people including Kibria were killed and 70 others injured in a grenade attack on a public rally.

3 Khulna madrasa teachers missing for 14 days

Families demand their safe return at press confce

Three madrasa teachers, picked up by some unknown people from separate places in Khulna city on May 12, could not be traced till yesterday.

Abdullah Al Saim Turja, Shoyeb Biswas and M Monirul Islam are teachers of Harintana Bismillahnagar Qawmi Madrasa and Orphanage in the city.

As police could not trace them in the last two weeks, their families at a press conference at Khulna Press Club yesterday urged the authorities concerned to take steps to ensure their safe return.

In a written statement, they alleged that Turja was picked up by some unidentified people in a white microbus while he was returning home from the madrasa along with

his colleague M Hafez Bin Ashraf on May 12. The abductors also snatched two mobile

the madrasa principal. Later, they left the place taking Turja. Later, his father Shahidul Islam filed a case with Harintana Police Station.


