Pabna trader attacked for protest

A fertiliser trader was brutally attacked with sharp weapons and critically injured in Failzana village of Pabna's Chatmohar upazila on Sunday night after he protested the illicit relationship of a man with a woman from his own community.

The victim, Ranjit Rosario, 30 son of Judge Rosario of Failzana village is undergoing treatment in Pabna Medical College Hospital and remains in critical condition.

The local Christian community is now worried over the attack and are demanding exemplary punishment of his attackers. A group of men numbering four

or five led by Badsha Miah from Nengri village in the upazila attacked him with sharp weapons, the victim said.

"Badsha had an illicit relationship with a Christian woman in my village. I caught him three months ago with the woman and took him to the local elders. They forbade him from coming to our village again which angered him and Badsha has threatened to kill me several times since then," Ranjit said.

"I filed a general diary about the incident with Chatmohar police station a month ago but he did not stop threatening me," Ranjit said. His older brother Autul Rozario

said, "We have rescued him and admitted him to Chatmohar upazila health comlex from where he was shifted to Pabna Medical College Hospital Monday morning."

"We fear there might be more attacks from this group on us," he Victim's wife Pollobi Rosario

told The Daily Star her husband who is a fertilizer dealer in the village keeps to his own business but these men are threatening to kill him now because he protested Badsha's illicit involvement with a woman from their own community.

"This woman in question has now left for Dhaka which has enraged Badsha and he wants to take revenge on my husband, " Pallabi said.

Member of Failzana Union Parishad Md Haran Ali, also a resident of the same village, said the local Chistians are very worried about the attack. Officer in charge of Chatmohar

police station Subroto Kumar said, police is trying to nab Badsha and his men but they remain absconding right now.

Victim's family were preparing to file another case against Badsha at the time this report was filed.

Worker killed at shipbreaking yard

4 others injured when iron plate fell on them

A worker was killed and four others were injured as an iron plate fell on them while they were working at a shipbreaking yard in Chittagong's Sitakunda upazila on Sunday. The dead is Rana Miah, 30, of

Gaibandha, said the shipbreaking yard officials. Abdur Rahman, assistant sub-

inspector of Sitakunda Police Station, said the accident took place at Seiko Steel Shipbreaking Yard in Sonaichhari around 6:00pm. Five workers were wounded in the incident. Rana was rushed to Chittagong

Medical College Hospital where doctors declared him dead. The four others wounded were taken to the hospital of Bangladesh Ship Breakers' Association at Bhatiari in Sitakunda.

Abdul Hai Khan, deputy inspector

general of the Department of Inspection for Factories and Establishment in Chittagong, said their inspector visited the shipbreaking yard. "We are investigating whether the

workers were provided safety equipment," he said. Asked, Osman Gani, manager of

Seiko Steel Shipbreaking Yard, said the workers were provided all safety equipment, but they took off those due to severe heat. "We will compensate the victims'

families as per the labour law," he said. An unnatural death case was filed in

this connection.

Including Rana, at least four workers have so far been killed in accidents in different shipbreaking yards in Chittagong this year. Around 13 workers were killed in accidents in shipbreaking yards last year.

the three-wheeler. Finally, with the help of District Women Affairs Officer Shahidul Islam, she got Tk 3.28 lakh from Bank Asia's Bogra branch. Adding to that her own fund of Tk 95,000, she finally became the first female owner cum driver of an

auto-rickshaw in the district.

Nazma, who lives with her husband, two sons and mother in a tinroofed house at Madhya Malgram in the town, dreams that one of her sons will become a doctor and the other a technician.

Her elder son Jannatun Nayeem, 16, is a student of class IX at RSF Model School and College in Shajahanpur upazila. He has obtained full-free scholarship because of excellent results. Her younger son Jahid Alam, 14, is also a student of class IX at Baghopara Technical Training College under Sadar upazila.

"I hope my new profession will contribute to the family income so that my sons can make my dreams come true," she said.

Initially, choosing such a profession, which anyone would deem highly unusual for women in Bangladesh, was not so easy. She had to bear insults from her brother-in-law Shahjalal, who said male passengers would stalk her.

Her nephew Mamun threatened to cut off all family ties with her.

But she is hopeful her relatives will soon overcome the misunderstanding and welcome her new profession.

Her husband Jahangir Alam, 36, however, extends all-out support for Nazma.

"First I was discouraged by locals

and relatives, but then I felt that woman should stand up on their own feet and encouraged her to take up the profession," said Alam, who works at an iron-made product factory. Nazma wakes up early in the morn-

ing, prepares food for the family and leaves for the 20-km Bogra-Shariakandi Road to transport passen-She hopes to earn on average Tk

1,000 per day after spending Tk 250 for gas and other miscellaneous costs. With that income, she plans to pay

off her loan in 33 months at Tk 11,600 monthly instalments. She however has a three-month loan moratorium period, during which she does not have to pay the instalments. On the road, Nazma primarily

faced harassment from fellow workers and chain masters, who decide and control the routes and often charge drivers for parking at the autorickshaw stands. "They raised questions about my

work and often behaved adversely. But leaders of local motor owners and workers association intervened and urged them to treat me as a fellow worker and a sister," she said. Sangram Singha, president of

Chelopara CNG-auto-rickshaw owners' association, said they would provide all-out support to female drivers if more women join the profession.

Even Deputy Commissioner (DC) of Bogra Md Ashraf Uddin, who was present at the bank-financed autorickshaw handover ceremony, hailed her unprecedented career.

He said the district administration and police would provide full support to every female driver. Nazma's endeavour has already

encouraged other women to venture into the driving profession.

Golzar Hossain of the locality said his wife Shefali Begum, 22, is considering taking loan to buy an autorickshaw.

The bank would work to empower women and ensure their economical solvency, said Mozaffar Hossain, executive vice-president and manager of Bank Asia, Bogra branch.

Saudi King, which includes full opening of labour market, particularly for male workers, seeking Saudi investment for development of major infrastructure in Bangladesh, further increasing of Saudi assistance and investment, increasing imports from Bangladesh, among other things.

Officials said several deals in the areas of investment, education and cultural cooperation are expected to be signed. Officials were still working on the details of the visit and agenda for discussion.

Sources said the PM is expected to welcome the Saudi initiative to form a 34-nation coalition of like-minded Islamic countries to fight terrorism, but at the same time she will cite the government's policy that requires a UN approval for its participation in any military operation of the alliance.

"Bangladesh will consider sending troops to Saudi Arabia only if UN Security Council approves it and in case the two holy mosques face threats," said a foreign ministry offi-

Sources in the foreign ministry said Hasina during her meeting with the Saudi King and other high officials would express interest in enhancing defence cooperation with the Kingdom.

The prime minister will also meet Crown Prince and Deputy Prime Minister Mohammad bin Naif bin Abdulaziz Al-Saud and Deputy Crown Prince and second Deputy Prime Minister Mohammad bin Salman Al

Besides, she is expected to meet important members of Saudi royal family, investors and expatriate Bangladeshis.
