Aslam Chy of BNP on 7-day remand in sedition case

A Dhaka court yesterday placed BNP leader Aslam Chowdhury on a seven-day remand in a sedition case filed allegedly for hatching a conspiracy with Israel's Likud Party and its intelligence agency Mossad to oust the government.

Metropolitan Magistrate Md Golam Nabi passed the order after Fazlul Haque, inspector of Detective Branch of police, produced Aslam before his court with a 10-day remand prayer in the case.

In the remand prayer, the IO said Aslam was involved in a conspiracy with Likud Party and Mossad. So he needs to be remanded to find out the vital clues.

Defence sought cancellation of the remand prayer and appealed to the court to grant their client bail saying that Aslam was implicated in the case as part of a conspiracy to harass him politically. Earlier on May 27,

Unemployed nurses to be

Unemployed nurses have decided not to leave the street until they meet the prime minister for addressing their demands of postponing the recruitment exams slated for June 3, Nahida Akhter, general secretary of Bangladesh Basic Graduate Nurses' Society, told The Daily Star by phone yesterday.

She said they met Health Minister Mohammed Nasim on Monday night after taking position in front of his Dhanmondi residence in the capital for several hours.

Dr Deen Mohammad Noorul Huq, director general of the Directorate General

of Health Services, was also present there, and they assured the nurses of arranging a meeting with the PM by June 1, she added.

Unemployed nurses have been demonstrating since early April protesting a Public Service Commission (PSC) circular of March 28 on recruiting 3,616 senior nurses in public hospitals, which says applicants below 36 and attaining Bachelor of Science and diploma in nursing had to take an

The nurses said the exam prerequisite was unjust because those who attained the educational qualifications a few years back and approaching the age might be left out.

CHECKING VIOLENCE IN UNION PARISHAD POLLS

The Election Commission's measures to curb violence in the ongoing union parishad polls remain confined to only sending letters to the home ministry, asking for its help.

On May 8, a day after the fourth phase of the polls, the commission

sent a letter to the ministry requesting that it take steps to ensure security to voters, especially minorities and women, and conduct drives against criminals and illegal arms before and during the next phase.

But the fifth phase, held May 28, was the deadliest so far, with 12 deaths and 200 injuries in one day.

After sending the letter, the commission, however, did not follow up about what extra measures the ministry would take, and it sent a similar letter with the same request yesterday.

About sending the same letter once again, EC's Secretary Sirazul Islam last evening told The Daily Star, "We want

Four Moulvibazar suspects indicted

Tribunal to decide June 20 about charge framing against four of Noakhali

The prosecution yesterday pressed two charges over the alleged involvement of four Moulvibazar men in crimes including killing, looting, arson, rape, abduction, confine-

ment and torture during the 1971 Liberation War. Moreover, the three-member International Crimes Tribunal-1 led by Justice Anwarul Haque concluded hearing three charges from the prosecution and defence over the involvement of four Noakhali men in similar crimes and

Kabir submitted the formal charges and other documents and the tribunal fixed June 15 to decide whether to take those into cognisance.

Talukder alias Lal Miah, 62, Anis Miah, 76, and Abdul Musabbir Miah, 64, of Rajnagar upazila in Moulvibazar are on the run. The tribunal's investigation agency on March 23 com-

pleted probes and said to have found evidence centring

their involvement.

Verdict today about three Habiganj men

International Crimes Tribunal-1 today will deliver the verdict in a case against three Habiganj men facing four charges of crimes against humanity committed during the 1971 Liberation War.

The three-member tribunal led by Justice Anwarul Haque with members Justice Md Shahinur Islam and Justice Md Shohrowardi fixed the date yesterday. Proceedings concluded on May 11.

Now in jail, Muhibur Rahman alias Boromian, 65, his younger brother Mujibur Rahman alias Angur Mian, 60, and their cousin Abdur Razzak, 63, of Baniachang upazila of Habiganj pleaded not guilty.
