32-km Sylhet road to be upgraded to nat'l highway

The government is going to upgrade Airport-Salutikar-Companiganj-Bholaganj road, one of the battered roads in Sylhet, to a national highway to facilitate the smooth transport of stone and sand.

An agreement was signed between the Roads and Highways Department (RHD) and the construction firm at a hotel in the capital yesterday for the upgradation work of the 32-

kilometre road at a cost of Tk 442 crore, says a press release of the road transport and bridges ministry.

A good number of farmers of Sadullapur, Palashbari and Gobindaganj upazilas under the district are now cultivating litchi, switching from traditional crops like paddy, jute or wheat as the popular summer fruit brings better profit.

Besides, the fruit cultivation eventually requires less effort as after initial investment for planting saplings in orchards and nursing for a couple of years, the mature trees yield fruits for many years.

During the ongoing peak harvesting season, traders from other districts are coming to collect the fruit from gar-

dens in the area. Visiting Chandipur village in Gobindaganj upazila, this correspon-

produces 6,000 to 8,000 fruits yearly, while a medium size tree gives 4,000 to 5,000 fruits," said Afsal Hossain, another grower.

Chemical-free litchi has good demand in the market and price is also higher as consumers are now much aware, said locals.

Earlier in the season, litchi sold for Tk 200 to Tk 250 per hundred pieces, but now the price ranges from Tk 150 to Tk 200, they said.

"In Gaibandha district, over a thousand hectares of land has been brought under fruit cultivation, mostly mango and litchi. We provide the growers all possible help for better yield and motivate them not to use chemicals on fruits," said AKM Ruhul Amin, deputy director, the Department of Agriculture Extension, Gaibandha.

Gaibandha BNP chief lands in jail

A court here on Monday sent the president o Gaibandha district unit of BNP to jail after he surrendered before the court in an arson case.

The district BNP and its front organisations brought out a procession in the town yesterday, demanding immediate release of Anisuzzaman.

Jubo Samity activist murdered in Bandarban

An activist of Jubo Samity, a youth wing of Parbatya Chattagram Jana Sanghati Samity (PCJSS), was found murdered in Bandarban's Sadar upazila early yester-

The deceased was identified as Sunil Chakma, 35 information and publicity secretary of Kibuk Para unit of Jubo Samity.

Nu Thui Ching Marma, wife of the victim, said Sunil went out of their house with Maigya Marma, a neighbour, at around 2:00am.

"As he did not return home, I went to search for him near our house and found him dead with injury marks on his neck and face, she said.

Police recovered the body and sent it to Bandarban Sadar Hospital for autopsy.

Police arrested Maigya Marma, suspecting his involvement in the killing, said Rafiq Ullah officer-incharge of Bandarban Sadar Police Station.

Contacted, U Chaw Shing Marma, president of Bandarban Sadar unit of PCJSS, claimed that Sunil was killed by his political opponents. He demanded immediate arrest of the killers.

Two days ago, Sunil locked in an altercation with the supporters of AL nominated candidate over campaigning for the coming union parishad elections scheduled for June 4.

DEATH IN CUSTODY

Probe body formed in Jamalpur

A three-member probe body, headed by Additional Police Superintendent of the district Md Shariful Haque, was formed to investigate death of arrestee Hashem Ali under police custody in Sarishabari upazila of the district on Monday.

The probe body has been asked to submit its report within three days, said Superintendent of Police Nizam Uddin.

Hashem, 35, son of late Jinnat Ali of Tariapara under Sarishabari municipality was accused in a murder case filed with Sarishabari Police Station in connection with his wife's killing. He was arrested on Sunday from his cousin's house in the capital's Gulshan area where he had been hiding, according to police.

Family members alleged that he died due to custodial torture, and demanded that "policemen responsible for the killing" be brought to justice.

Sundarbans robber gang 'Master Bahini' surrenders

Ten members of Sundarbans-based infamous robber gang 'Master Bahini,' including its ringleader, surrendered to Rapid Action Battalion (Rab) in presence of Home Minister Asaduzzaman Khan Kamal in Mongla yesterday.

All the robbers formally surrendered with 52 firearms and 5,000 bullets around 3:00pm, said Lt Col Md Faridul Alam, commanding officer of Rab-8. The 10 gang members are

Govt decision brings jubilation

Following a protracted campaign by Bogra civil society activists to preserve the town's iconic Nawab palace a signboard from the archaeological department is finally in place marking its protection as a designated

Also the home of Mohammad Ali, who became prime minister of 1953, preservation of the 150-year-old residence appeared to be at risk when the property was suddenly

sold in mid-April to a group of local businessmen.

Subsequent demonstrations and written appeals by locals urged the government to protect the palace as a matter of priority.

After the cultural affairs ministry determined the site to be of significant heritage value warranting protection, a gazette notification was published recording the inclusion of the property as being proan undivided Pakistan in tected under the Antiquities Act 1968.

On Wednesday 25 May 2016 a signboard to this effect with the gazette notifi-

cation papers was finally installed on-site, bringing jubilation to much of Bogra
