Abducted college girl traceless for two months

A college girl, abducted from Sakoya Tiktiki village in Lalmonirhat Sadar upazila on March 30, is yet to be rescued. The victim is an HSC student at Barabari Shaheed Abul Kashem

College in the upazila. A case was lodged in this connection, accusing one named and 4/5 unnamed people, with Lalmonirhat Sadar Police Station two days after the

incident. Police arrested the named accused, Faysal Hossain alias Baro Lal, 30, son of late Fazlar Rahman of the village, on May 5. He got bail from the District and Sessions Judge Court on May 21,

Police said the college girl was abducted by Baro Lal and his accomplices while she was going to her college. They took her to Tentulia area of Panchagarh district, where she was kept locked in a room for a month. The girl somehow escaped from the

the investigation officer of the case, said Baro Lal was arrested by the police and confessed that he and his friends abducted the girl. The victim fled away a month back, but he doesn't know where is she now, the SI said quoting Baro Lal.

"Police are trying to arrest the other accused, and trace out the victim's location," he said.

Four to walk gallows for killing two minor boys

Four people were awarded death penalty yesterday for killing two minor boys in Netrakona and Barguna districts.

A Netrakona court sentenced three people to death for killing a minor schoolboy after abduction in 2014, reports UNB.

Khan, 20, son of Kanchan Khan, Sohag, 20, son of Abul Kashem of Kendua upazila, and Sharifuzzaman alias Humayun, 20, son of Sultu Mia of Rajibpur upazila in the district. Of them, Sharifuzzaman was tried in absentia.

Women and Children Repression Prevention Tribunal Judge AKM Abul Kashem also fined them Tk 50,000 each. In default, they are to suffer another one year in jail.

According to the prosecution, Shukkur Ali, 12, a Class V student of Chitua Nouapara Government Primary School, and son of Faruk Bhuiyan, went missing on June 9, 2014.

The following day, the kidnappers demanded Tk 6 lakh as ransom from the family over cellphone. The victim's father filed a case with Kendua Police Station on June 30.

10 hurt in Jessore post-poll clash

Ten people were injured in a post-polls clash at Kahlia village in Jahurpur union under Bagharpara upazila of Jessore district last night.

Locals said the clash ensued after the supporters of defeated member candidate Ansar Ali swooped on supporters of elected member candidate Shafiqul Islam because Shafiqul berated Ansar Ali at the village.

Both groups used sticks and other weapons during the clash that gradually spread over the entire village and the adjacent areas.

Being informed, police rushed to the spot and brought the situation under control after an hour. Police arrested two supporters of Ansar Ali.

Lightning kills 3 of a family in Noakhali

Three members of a family were killed by lightning in Musapur Union under Companiganj upazila of the district yesterday.

In this Scction "Public Property" means :-

Any property movable or immovable which belongs to, or the protection of which is the legal responsibility of-

(i) The Government or a local authority; or

(ii) Any company, firm, undertaking, institution, organization or other establishment which is managed or controlled by the Government or a local authority or in which the Government, by itself or jointly with a local authority or company managed or controlled by it, holds controlling financial share or interest or which is specified by the Government for the purpose of this section; and

- (b) a project financed out of an external loan or with external aid until it reaches-(i) in the case of an industrial project, the stage at which it is capable of commencing normal production; and
