FROM PAGE 16 checks latex burns and fungal spots on fruits, they added.

The new methods, said the officials, come as a blessing to farmers against the backdrop of widespread use of pesticides and fungicides that threaten ecological balance and public health. They also help farmers have a more reliable estimate of their harvest prospects.

"By protecting mangoes from diseases and pests, the new methods would boost the production of export quality mangoes. They would also ensure protection of mangoes from scratches and scars, making the fruits spotless," said Sorof Uddin, senior scientific officer at the research sta-

When the mangoes are 40 to 55 days old, each of them are bagged until harvest. No pesticide sprays are needed for the fruits once the bags are put on them.

Mango growers usually spray pesticides 15 to 25 times in their orchards in a season. But if they adopted the bagging method, they would require spraying pesticides for only two to three times at the early stage of farming, the official said.

All the leading mango-producing countries have been using this method to have better yields, he Over 16 lakh bags, costing about

Tk 5 each, have already been used in the mango orchards in the district this year, including 11 lakh in Shibganj upazila alone. The number might go up to 25 lakh. Last year orchard owners used only 5 lakh bags, said officials.

"We took the opportunity, because it's the beginning of summer, to make our concerns known," he told a press briefing, noting several high-profile events in Europe in June and July.

"I'm not aware of any specific, credible, terrorist event around these events or in any particular place in Europe. This was issued ... based on an accumulation of information," Kirby said.

Responding to the US alert, the head of Italy's anti-terrorism police unit, Lamberto Giannini, said there were "no specific warnings or particular evidence." But he told Italian media the situation across Europe "requires maximum attention."

The British Foreign Office declined to comment but pointed to its own guidance advising of a "high threat" of terrorism in some European countries.

The State Department alert noted France will host the June 10-July 10 UEFA Euro 2106 soccer championship and had extended its state of emergency, imposed after the Nov 13 Paris attacks, through July 26 to cover the July 2-24 Tour de France race.

"Euro Cup stadiums, fan zones, and unaffiliated entertainment venues broadcasting the tournaments in France and across Europe represent potential targets for terrorists, as do other large-scale sporting events and public gathering places throughout Europe," the department said.

Gopalganj, Madaripur, Munshiganj, Narsingdi, Manikganj and Narayanganj were badly affected following the network disruption, according to an Airtel letter to the Bangladesh Telecommunication Regulatory Commission (BTRC).

The disruption affected 40 percent of Airtel's 2G and 3G network,

according to the letter. Thinking that the network disrup-

tion was a consequence of the expiration of deadline for the biometric SIM re-registration that coincidentally ended on Tuesday, subscribers became agitated.

Some Airtel subscribers also staged a demonstration in front of its Dhanmondi office around 10:30am.

They later left the scene following assurance from Airtel officials and police.

A subscriber, Rafiul Islam, told The Daily Star that he became worried after his mobile phone set displayed the sign of "no network coverage"

around 6:30am. "I wondered why my Airtel SIM has been blocked even though it is

biometrically verified," he said.

Meanwhile, subscribers of different carriers complained that some SIMs were blocked even after going through the re-registration process, while some have had their connections still alive even though those had not been re-registered.

BTRC officials said as the issue was a technical one, it would take a while for everything to get normal.

The other two participated in facilitating the murder. The criminal activities and unlawful acts of the three brothers did not happen in seclusion. Those were carried out in broad daylight but nobody resisted the attacks, given the context and the notoriety of Razakar Bahini, according to the judgment. "Accused persons had acted deliber-

ately as part of 'collective criminality' in accomplishing the purpose of attacks, being aware of consequence of their acts," said the International Crimes Tribunal-1, with two other judges --Justice Md Shahinur Islam and Justice Md Shohrowardi, in presence of the convicts, their family members, prosecutors, defence lawyers and journalists.

Prosecutor Sultan Mahmud Simon said, "We are happy and hope that the victim's family members will get some solace following the verdict."

Defence counsel Masud Rana said his clients did not get justice. The defence will challenge the verdict at the Supreme Court, he said, expressing the September. hope of getting justice there.

# Fahim Munaim passes away

The decision on his burial will be made after two of his sons return from abroad. Till then, the body will be kept at the Square Hospital's mortuary, according to Maasranga Television.

Fahim served as managing editor of The Daily Star from 1996 to 2007.

He joined The Daily Star on June 10, 1996 as deputy managing editor and was promoted to the post of managing editor on December 1 the following year. Fahim became executive editor of

the newspaper on February 1, 2010. A well-known TV personality, Fahim

joined Maasranga Television, a concern of Square Group, as the chief executive officer and chief editor in March 2010. He became press secretary to the

then chief adviser of the caretaker government in 2007 and the ambassador to Indonesia the following year.

Fahim, son of journalist Syed Nuruddin, was born on July 4, 1953. He studied at Mirzapur Cadet College, and later completed his bachelor's and master's degrees in Public Administration from George Mason University in the US.

In his professional career, he was executive director at the Daily Sangbad and managing editor at the Morning Sun, news agency UNB and weekly Dhaka Courier. He earned huge popularity among journalists during his stint there.

He also worked as press councillor at the Bangladesh Embassy in Tokyo, Japan.

As the news of his death broke, tributes began pouring in from his wellwishers and colleagues and admirers.

Mahfuz Anam, editor and publisher of The Daily Star, said, "Fahim joined us when we were still a small and struggling newspaper. As the managing editor, he played a crucial role in introducing modern and dynamic Star financially viable."

The Star editor said it was a privilege to work with Fahim whose ever cheerful disposition and positive outlook on life made working with him a constant pleasure. He devoted his whole life to building professional and ethical bered journalism.

"He was a very dependable colleague and a more dependable friend," said Anam.

Expressing profound shock, Fakhruddin Ahmed, former chief adviser to the caretaker government, said Fahim contributed immensely to the public life of Bangladesh during his long and successful journalistic career.

When Fahim was called upon by the council of advisers to serve as press secretary to the chief adviser of the nonparty caretaker government in 2007, he welcomed the opportunity to serve his country, and did so effectively and with deep integrity, Fakhruddin said in a condolence message.

"I spoke with him virtually every morning during my tenure as chief adviser, and I always found his counsel to be immensely valuable, on topics

ranging far beyond his immediate purview as press secretary."

"We shall all, as a nation, miss his deeply-held commitment to the freedom of the press. And I will remember him always as a man of honesty and openness, who maintained calm and a sense of humour in every situation, Fakhruddin said, expressing deep management system making, The Daily sympathy to the bereaved family members.

Under Article 65, the lawmakers are

permitted to formulate laws, but they cannot do that properly as they keep holding posts of chairman of governing bodies of four separate institutions, he said. The lawyer said the section 5 of the

2009 regulation is also against the Secondary and Higher Secondary Ordinance, 1961.
