Failed chairman candidate lifts road bricks earlier set by him

Local administration stops the callous act within hours

The local administration stopped brick lifting by men of a defeated union parishad (UP) chairman candidate from a village road in Sadar union of Dupchanchia upazila under the district on Tuesday.

Abu Sayeed Fakir, Awami League (AL) nominated candidate for the May 28 union parishad (UP) election, set bricks on around 250-metre earthen road at Kamar village in Sadar union, as the locals assured voting in favour of him, said locals and upazila officials.

But Sayeed, also president of AL's Sadar union unit, was defeated in the UP election and apparently due to his grievance over the matter, he ordered his men to remove the bricks from the road on Tuesday morn-

Informed, Dupchanchia Sayeed Fakir, a ward memasked the upazila engineer

The engineer sent a surveyor of the office to the spot and the latter found Sayeed's men lifting bricks from the road.

Then the upazila administration stopped the act in the afternoon.

The full text of the HC judgment, released in March 2013, observed that the BGMEA building stood in Hatirjheel project "like a cancerous growth" and structures like these would swamp the whole city unless the building was removed forthwith.

The court also ordered the authorities to pull the building down and use the land in the public interest and directed the BGMEA to the garment industry." provide refunds to the people who bought floor spaces in the building.

Prime Minister Sheikh Hasina during her first tenure laid the foundation

ing in November 1998, while former premier Khaleda Zia inaugurated the building in October 2006. Rajdhani Unnayan Kartripakkha (Rajuk) issued

ronmental clearance and Dhaka Water Supply and Sewerage Authority (Wasa) clearance for the building in the canal. Civil Aviation Authorities also issued the height clearance.

Besides those clearances, the BGMEA authorities needed to obtain building approval from Rajuk, which they did not. Rajuk only served one notice on the BGMEA authorities about this in more than a decade of the building's existence.

Various environmental and civic groups time and again demanded that the government take steps to knock the illegal BGMEA building down.

BGMEA's lawyer barrister Rafique-ul Huq said, "I personally feel that demolition of the BGMEA building will have a very bad effect on the garment sector and the economy of the country, as the economy depends on

A year after their marriage, Borhan used to torture Mayarun for dowry.

On Wednesday night, the couple engaged in an altercation over the issue. At one stage, Borhan killed his wife, alleged the victim's mother.

The body was sent to Sylhet MAG Osmani Medical College Hospital morgue for autopsy, said police.

Borhan went into hiding soon after the incident, said AKM Fazlul Haque Shibly, officer-in-charge of Golapganj Police Station.

Locals said the incident took place when the supporters of two defeated member candidates -- Faraj Ali and Billal Mia--locked in an altercation over the defeat of their candidates in the election held on May 28. Of the injured, 15 were

Away in Mymensingh, three people, including a local Awami League leader, were beaten up allegedly by their party rivals in same night.

The victim, Ali Emdad, Officer-in-Charge Abdul 55, president of Banshati union unit of AL, his nephew Rubel Hossain, 34,

and Borhan Uddin, 35, were admitted to Muktagachha Upazila Health Complex.

Emdad and Rubel were later shifted to Mymensingh Medical College Hospital as their condition deteriorated.

Quoting locals, police said a group allegedly loyal to defeated AL nominated chairman candidate Ujjal Chandra swooped on Emdad with bamboo and wooden sticks and beat him up while he was taking tea at a stall around 10:30pm, leaving him injured.

Rubel and Borhan Muktagachha upazila the received injuries when they tried to save Emdad from the attackers, Officer-in-Charge Abu Mohammad Fazlul Karim of Muktagachha Police Station said.

"The mobile operators play an important role in building a digital country. And here, we see that the government either imposes a new tax or hikes it every year," he added.

He demands comprehensive taxation and a full withdrawal of supplementary duties on mobile use; otherwise, users will lose affordability.

Muhith had proposed a 5 percent supplementary duty on all kinds of earnings related to SIM cards last year as well; but he reduced it by 2 percentage points in the face of widespread criticism.

The government also proposed a 1 percent surcharge on mobile phone use in the budget for 2014-15, which was implemented in March this year.

If this proposal is accepted, users will have to pay 15 percent VAT on total use, 5 percent supplementary duty and then 1 percent surcharge on top of that. In other words, users have to pay a total of Tk 121.96 to take a service of Tk 100 from carriers.

Or, customers can enjoy only Tk 82 of their Tk 100 top up, which is Tk 83.59 at present.

An official of Grameenphone said this hike would burden the customers even more. "The mobile phone
