The High Court yesterday directed the authorities concerned to maintain status quo on earth filling, construction of structures, and land grabbing in Chaktai and Rajakhali canals in Chittagong for the next six months.

Following a petition, the court directed the government to demarcate the boundaries of the canals through conducting a survey and submit a report to it in two months.

The HC also issued a rule upon the government to explain in four weeks why it should not be directed to protect the canals and to evict and demolish the structures built in their lands.

The HC bench came up with the order after hearing a writ petition filed by Human Rights and Peace for Bangladesh seeking the directives.

The secretaries to the ministries of local government and rural development; water resources; forest and environment; and finance; Chittagong City Corporation mayor; chairman of Chittagong Development Authority; deputy commissioner of Chittagong; assistant commissioner of land of Bakulia upazila; and the officer-in-charge of Bakulia police have been made

Rainfall adds to waterlogging woes in Barisal city

Unabated encroachment on canals, lack of proper drainage, sewerage system are reasons, allege locals

Amid continuous encroachment on canals and a lack of proper drainage and sewerage system in Barisal city, menacing waterlogging has become a matter of grave concern for the dwellers, especially in the rainy season.

Daily lives are being severely hampered due to the incessant downpour, forcing people to remain confined to their houses, said locals.

Streets, footpaths, educational institutions, and office premises were submerged in water, they said, adding that public transport also became scarce and those few available started demanding higher-fare.

Just the Sunday's rainfall, crippled the life in the city as Sadar Road, Fakirbari Road, College Row, College Avenue, and Battala areas went under ankle to knee-deep water.

Hindrance to the water flow in canals and a

lack of drainage and sewerage system are the main reasons behind this waterlogging, complained locals.

"I waited a long time to find any mode of transportation, even offered to double the fare," said Aklima Begum, who came to pickup her son Anik from Sister's Day Government Primary School in Fakirbari area, adding, "I ended up walking in the water."

"Anik might fall sick because of this polluted water," said the worried mother, while bracing herself as she has to face the ordeal once again.

"If this continues, the entire city will turn into a canal," said Akkas Hossain, a cultural personality. "Initiatives must be taken to clear drains and canals overstuffed with garbage," he said.

Lincoln Bayen, coordinator of Bangladesh Environmental Lawyers Association (Bela), said, "Around 22 canals used to flow across the

city; only six exist now. A stringent and active monitoring system has to be taken by the authorities concerned to stop illegal encroach-Nandita Bosu, chief planning officer of Barisal

City Corporation, said, "Unscrupulous people are destroying the ecological balance by erecting illegal structures on the banks of the canals. BCC is trying to restore navigability of the canals. All illegal structures are being demolished." "We have already signed a project with BfW

AG, a German bank, to develop and protect our ecology, which will be implemented from next year," she added.

Ranajit Kumar, CEO of BCC said, "We're going to develop our drainage system next year. Meanwhile, as a temporary solution, we'll continue with cleaning drains and freeing of the

Awami League has chalked out a day-long programme, including hoisting the national and party flags atop party offices and Bangabandhu Bhaban, and placing wreaths at Bangabandhu Sheikh Mujibur Rahman's portrait at Bangabandhu Memorial Museum in the capital's Dhanmondi. On this day in 1966, Awami League under the leadership of Bangabandhu called for a day-long hartal throughout East Pakistan pressing the demand for autonomy to end exploitation, deprivation, subjugation and tyranny, let loose by the Pakistani regime on the people of the province. As people were observing the hartal across the province, law enforcers opened fire at different places, killing at least 10 people, including labour leader Monu Miah, Shafique and Shamsul Huq, which intensified the movement further. As a sequel to it, came the historic mass upsurge in 1969, and subsequently, the Liberation War in 1971.

lawmaker Nurunnabi Chowdhury from Bhola-3 asked the minister whether any foreign citizen is involved in illegal activities abroad managing Bangladeshi passport illegally. The minister said, "No foreigner has Bangladeshi passport."

In reply to another query, Kamal said setting up of three more passport offices in Dhaka and Comilla is under active consideration of the government.

Meanwhile, Foreign Minister Abul Hassan Mahmood Ali told the parliament that some 72 diplomatic missions of Bangladesh are active in 56 countries, including nine in their own buildings.

He said the government had arranged lands for constructing more Bangladesh mission buildings in five more countries -- Nepal, Malaysia, Australia, Myanmar and Brunei.
