## Railway property reclamation bill placed in JS

A bill styled "Railway Property (Unlawful Possession Reclamation) Bill - 2016" was placed in parliament aimed at recovering the railway land and property from illegal occupation.

Railway Minister Mujibul Haque yesterday placed the bill which also annulled the "Railway Property (Unlawful Possession) Ordinance - 1979" giving legal coverage to the actions so far done under the ordinance.

Grabbing and illegal possessions of railway property will be considered as a punishable offence, according to the bill.

The bill was sent to the parliamentary standing committee on railway ministry for scrutiny and to report back to the House within 30 days. A total of 4,391 acres of railway land have been grabbed so far by individuals and government, semi-government, autonomous, private, religious and educational organisations, according to ministry sources.

Government, semi government and autonomous institutions have grabbed over 922.34 acres of land while religious and educational institutions have grabbed over 90.83 acres of land, said the source.

In the bill, there is a provision of maximum seven years' imprisonment or fine or both for stealing any kind of railway property as well as occupying such properties illegally.

Moreover, abettors will be jailed for five years or fined or both under the proposed law. The bill said the Railway Security Force would be able to arrest anyone without warrants if any officer and member of the force deemed that the very person was involved in cognizable offence under this law.

# Charges taken into cognisance

Testimony recording of third witness against two Shariatpur men ends

STAFF CORRESPONDENT

The International Crimes Tribunal-1 yesterday took the charges into cognisance brought against five Moulvibazar men for crimes allegedly committed by them during the Liberation War in 1971.

The three-member tribunal led by Justice Anwarul Haque also asked the inspector general of police to give a report on three fugitives of the case and fixed July 24 for passing the next order.

Of the accused, Yunus Ahmed, 71, of Sonatiki and Ujer Ahmed Chowdhury, 63, of Goashpur village are now in jail, while Samsul Hossain Tarafder, 65, of Bagajura, alleged Al-Badr commander in the upazila, Nesar Ali, 75, of Jamura, and Mobarak Mia, 66, of the same upazila, are on the run. Except for Samsul, all other accused were allegedly involved in the Razakar Bahini, the prosecution

Prosecution on May 25 pressed five specific charges against them and prayed to the tribunal to take them into cognisance.

The charges are: killing of Danu Mia, looting and torching of three houses and confinement of three people and abduction, confinement and torture of three people and looting and torching of the houses of one Harendra Bhattacharya between November 22 and December 5; killing of one Jamini Mohan Dev and abduction, confinement and torture of three people on November 25; abduction of four people including one Rasraj Bhattacharya on November 27; abduction and torture of four people and killing of two between November 29 and December 8; and killing of 14

people including one Shushital Dhar on December 29.

Meanwhile, the tribunal completed recording the testimony of the third prosecution witness in the case against Sulaiman Mollah and Edris Ali Sarder of Shariatpur for allegedly committing crimes during the Liberation War.

Abdul Jalil Howlader, of Chikndi village under Shariatpur Sadar Police Station, gave testimony linking the two accused to the killing of scores of people, mainly Hindus, and rape of Hindu women in 1971. Abdul Aziz Sikder and Jalilur

Rahman, the first and second prosecution witness, gave almost similar description of the incidents, implicating the duo.

The court adjourned the case proceeding until June 20 when Jalil will face further cross-examination.

## Arrest warrant issued against two doctors, owner

A Chittagong court yesterday issued arrest warrant against two doctors and a managing director of a private hospital following a case filed by a patient's relatives alleging that the patient died due to negligence of the doctors.

Judge Harunur Rahsid of the Metropolitan Sixth Court issued the warrants after taking cognisance of the murder case.

They are: Kajal Rekha Roy, a gynaecologist, Debashis Talukder, a register of cardiology department of Chittagong Medical College, and Abdul Jabbar, managing director of Chittagong Patient Care Hospital located in Panchlaish area of the port city.

Quoting the case statement, Arefin Risbi, lawyer of the plaintiff, said the victim, Sayema Sikder, 22, a second year student of Government Women College in the city and the wife of Noakhali district's senior district judge Morshedul Alam, was pregnant and under the treatment of Kajal.

She was admitted to the hospital with labour pain on June 2 pursuant to a suggestion

filed the case, informed the doctor of the pain. She gave birth to a baby boy the following day around 1:00am after a caesarean section

performed by Kajal. Debashis, who gave her anaesthesia before the operation, was at the hospital till 4:00am and said that the patient was in good

condition, but in fact she was not yet free from danger. As there was no doctor at the hospital between 4:00am and 6:00am, the family

wanted to shift her to other hospital, but the hospital authorities did not allow them to do so. However, around 7:30am when the patient was taken to the city's Metropolitan Hospital,

the doctors there said she died about one hour earlier, said the case statement. This correspondent, however, found the

trio incommunicado despite several attempts to contact them. Nirmalendu Bikash Chakraborty, addi-

tional deputy commissioner (prosecution) of Chittagong Metropolitan Police, said the arrest warrant would go to Panchlaish police.
