Ex-DU VC Prof Maniruzzaman passes away STAFF CORRESPONDENT

Former Dhaka University (DU) vice chancellor (VC) Prof M Maniruzzaman Miah passed away at a hospital in the capital yesterday. He was 81.

The noted educationist breathed his last around 11:45am while undergoing treatment at the Intensive Care Unit, Square Hospital's marketing and business development officer, Achintya Chakrabortty, told The Daily Star.

He had been admitted two days back with various ailments. The DU authorities

declared a holiday today, exempting exams, in his honour, said a press release. A pro-BNP intellectual,

he was the chairman of Zia Parishad and member of Shoto Nagorik Jatiya Committee, a pro-BNP intellectual platform. Born in May 1, 1935,

Prof Moniruzzaman passed matriculation in 1951 and ISC in 1953. He completed his masters in geography from Rajshahi University in 1957. He started his career the next year by joining Jagannath College.

After obtaining PhD from the University of Paris in 1966, he joined the geography department of DU where he taught for many years. He became a professor in 1986, and was also involved with academic and administrative activities.

He was appointed as DU VC in March 24, 1990 and served until November 1, 1992. He went on retirement in 1992.

Prof Moniruzzaman was a talented teacher, said DU VC Prof AAMS Arefin Siddique in a condolence message.

Hasina urges Obama to work together to eradicate terrorism Condemns Orlando attack

Prime Minister Sheikh Hasina yesterday strongly condemned the deadly terrorist attack on a Florida nightclub in the United States and called for taking collective efforts to eradicate this hateful menace from society.

"I condemn this dastardly act of terror in the strongest possible term and reiterate my government's 'zero tolerance' policy against any form of terrorism and violent extremism," she said in a message sent to US President Barack Obama.

The prime minister said terrorists must be regarded as terrorists regardless of their colour, creed, origin or orientation. "Let's redouble our collective efforts to eradicate these hateful menaces from our peace-loving societies," she said.


Cops find nothing on first day of remand

On the first day of the remand, police could not get any new information from the two persons held in connection with the murder of Mahmuda Khanam Mitu, wife of Superintendent of Police Babul Akter, said Chittagong Metropolitan Police (CMP) sources.

Police is enquiring Md Shahzaman Robin and Abu Nasar Gunnu to know about which ideology they believe in, and examining the CCTV footages and other evidence to be sure of their involvement, said CMP officials.

Contacted, the newly appointed Investigation Officer (IO) also Assistant Commissioner (AC) Kamruzzaman of DB said they are interrogating Robin and Gunnu to know whether they have any link with militant outfits.



granted a seven-day remand for the duo after they were produced before the court seeking a 10-day remand.

On Wednesday, police detained Gunnu from a shrine named Darbare Musabiya in Forhadabad area. Following the arrest, mentioning him as an "ex Islami Chhatra Shibir" activist, police officials said they have information that he was present at the place where Mitu was killed.

Meanwhile, Robin was held from Shital Jharna area under Bayezid Police Station on Saturday.

When asked about whether Robin is the very person seen in CCIV footage crossing the road and approaching Mitu with a mobile phone in hand, IO Kamruzzaman said they started interrogating him.

"It is yet to be confirmed," he said, adding that a special team of CMP was working on it. A CID team examined the motorcy-

cle used by the three assailants and collected DNA samples from it, said a DB source. Talking to the media, Additional

Commissioner of CMP Devdas Bhattacharya said they still did not find anything to say before the media.

Meanwhile, a microbus driver, who was detained from Sitakunda on Thursday, was released as police did not find any strong evidence of his involvement in the killing, said the additional commissioner.

GOVT DECISION OF SUSPENDING 3 PVT MEDICAL COLLEGES 1,000 students reeling in uncertainty

Some 1,000 students of three medical colleges have become worried of their future after the government on Sunday decided to suspend their academic activities for not complying with private medical college policy.

The colleges include Northern Medical College located in Rangpur, City Medical College in Gazipur and Nightingale Medical College in Ashulia.

The decision was taken at a meeting on private medical college policy held at the health ministry with Health Minister Mohammed Nasim in the chair.

Prof Abdur Rashid, director of medical education of the Directorate General of Health Services, said low quality of education, lack of own building, faculty shortage, withdrawal of the initial deposit of Tk 1 crore without the ministry's permission, led to their decision.

The meeting, however, decided that the students will be transferred to other private

medical colleges under relevant universities in the concerned areas. The students, however, questioned why

they should be the victims for any possible violations of the college. "Registration for the final year is ongoing. At such a time, the suspension news has

really shocked us. I don't know what to do next," said Ahmed, a student of City Medical College in Gazipur.

Mohammad Ali, a second year student of the college, said it will be difficult for them to adapt to a new college, even if they are transferred.

College Principal Brig Gen (retd) Prof Yunus Ali Mondal said he had no idea why the academic activities should be suspended. The ministry officials visited the college on a regular basis and they could have informed the college authorities of any issue they had, he said.

Some 200 students of Nightingale Medical College in Ashulia, meanwhile, demonstrated on the campus against the government's decision.

BCL leader Rony gets six months adinterim bail

The High Court yesterday granted ad-interim bail to a

leader of Bangladesh Chhatra League (BCL), who was jailed for two years for carrying an illegal firearm and vote rigging during Union Parishad election in Chittagong's Hathazari upazila, for six months in an arms case.

Nurul Azim Rony, BCL general secretary of Chittagong city, was sent to jail on May 8, a day after he : was held with an illegal firearm at a polling centre in Hathazari.

Yesterday, the bench of Justice Md Habibul Gani and Justice Md Akram Hossain Chowdhury also issued a rule upon the government to explain in four weeks why Rony should not be granted regular bail

Assistant Attorney General Monzu Naznin told The Daily Star that the HC granted the bail as the case was filed against Rony on May 8, though he was shown arrested on May 7.

The government will move an appeal for staying the HC order.

Our Chittagong correspondent reports that on May 7, during Union Parishad election, a mobile court arrested the BCL leader with a nine mm pistol and 15 bullets from Chariya Board School centre at Mirzapur Union. He was sentenced to two years' imprisonment under Sections 74 and 75 of the

Rebels behind UP polls violence

Law minister tells JS; installation of tube wells, water sources in all constituencies mulled, says LGRD minister

Rebel candidates of political parties and intolerance were responsible for violence in the recently held Union Parishad (UP) elections, Law Minister Anisul Huq told parliament yesterday.

Replying to lawmakers' queries, the minister said that stray incidents of violence took place in some areas of the country owing to "intolerance" among rival candidates of the same political parties.

Anisul, who is also in-charge of the Election Commission in the parliamentary affairs, claimed that the elections to 4,104 UPs were held amid fierce competition from its first phase to the last phase.

However, according to media reports, the UP elections, held between March 22 and June 4, were marred by widespread violence that left at least 126 people dead and countless more injured across the country.

No foreign help needed to save minority people


Says Inu UNB, Dhaka
