BNP's Aslam sent to jail on completion of remand

A Dhaka court yesterday sent BNP leader Aslam Chowdhury to jail after completion of his five-day

remand in a sedition case filed for allegedly hatching a conspiracy with Israel's Likud Party and its intelligence agency Mossad to oust the Awami League government in Bangladesh. Metropolitan Magistrate

SM Masud Zaman passed the order after Fazlul Haque, investigation officer (IO) of the case and inspector of Detective Branch of police, produced Aslam before the court with a forwarding report.

In the report, the IO claimed that they gleaned some important clues from him about the incident, which were being verified.

So he should be confined to jail until the investigation is completed, mentioned the IO.

Earlier, he was placed on a 12-day remand in two phases in the case. Aslam was shown arrested in the case on Mav

27 after he was sued for the

alleged sedition on May 26. Earlier, on May 15, he was picked up from the capital's Khilkhet over the alleged plot.

Later, he was remanded for seven days showing him arrested under Section 54 of the Criminal Procedure Code.

On May 24, Aslam was also shown arrested in two arson cases filed during BNP-led 20-party alliance's anti-government agitation in January last year.

Police later prayed for a 20-day remand. The court fixed June 15 for remand hearing.

Hearing on charge framing deferred in Rana Plaza cases

A Dhaka court yesterday deferred to July 18 the hearing on charge framing against 41 people, including Rana Plaza owner Sohe Rana, in connection with the country's deadliest industrial disaster.

At least 1,136 people, mostly garment workers, were killed and more than 2,500 injured after the ninestorey building collapsed in Savar on April 24, 2013.

Judge SM Kuddus Zaman of the District and Sessions Judge's Court gave the order as Sarwar Kamal, one of the accused, now in jail, was not produced before the court yesterday.

The court on April 28 took cognisance of the charges against Rana and 40 others in connection with the case filed over the killings.

Earlier on June 1 last year, Investigation officer (IO) Bijoy Krishna Kar, CID assistant superintendent of police, submitted two charge sheets, one for murder and the other for building code violation.

The 41 accused also include Rana's parents, four factories' owners, mayor of Savar and 11 government officials. Of the accused, only Rana is in jail, 31 are on bail and nine are absconding.

Another Dhaka court fixed June 15 for the hearing on charge framing against Rana and 17 others in a case filed over "violation of building codes" in constructing the building.

Train service still poor despite fare hike

Allege passengers; initiatives being taken to improve services, say authorities adding that fare will be readjusted every year from now on from that country soon and another

Although Bangladesh Railway raised the train fares three and half months ago aiming to improve train services, nothing has been done so far to justify the fare hike, The Bangladesh Railway increased

the train fares by 7.23 percent, effecting from February 20 to cut losses and improve the services.

Although nearly three and half months have elapsed since the fare hike, the railway services remain horribly poor as were in the past, allege many passengers.

"Most train compartments, seats and toilets of almost all trains are not fit for use as those are torn, dirty and filthy. Besides, any train hardly leaves its station in time," said Ariful Haque, a resident of the capital, who

commutes from Dhaka to Chittagong and vice versa by trains frequently for his official work.

Farhana Karim, another passenger who travelled to Feni by Turna Nishita recently, said her night-time journey turned into a nightmare due to nuisance of bugs.

"The bug bites were so terrible that I had to remain busy driving them away all the time," she said.

General Secretary of Consumer Association of Bangladesh (CAB) Humayun Kabir, who visited Sylhet by trains many times, said he noticed no difference in the railway services before and after the fare

Bangladesh Railway Additional Director General (operations) Habibur Rahman said the railway authorities used to increase the train fares after 10-15 years in the past, but from now on the fares would be readjusted every year.

He said a tariff reform policy was formulated in this regard and Prime Minister Sheikh Hasina has already approved it.

According to the Bangladesh Railway, the fare for general seat was raised at a lower rate while that of air-conditioned ones and goods and container-carrying trains at a relatively higher rate.

Special Indian visa camp to open soon

Following an overwhelming response, the Indian high commission will open a special visa camp, similar to an ongoing 12day one launched for the first time on June 4 to attract Bangladeshi tourists during the Eid-ul-Fitr holidays, in a few months.

"We have plans to set up such visa camps through other parts of Bangladesh," Indian High Commissioner to Bangladesh Harsh Vardhan Shringla told reporters at the New Chancery Complex in the Baridhara

He said extending the camp's duration depended on a number of factors, including their capacity. "Let us focus on the next three days. We will do our best...We will apply our experiences and best practices in similar camps," he said, adding that the visa process would be further simplified.
