New citizens' platform seeks govt protection against Islamist terrorism

Journalists, activists and leaders of different sociocultural organisations yesterday demanded government protection for bloggers, publishers, freethinkers and people of different faiths who are being hacked to death allegedly by Islamic militants one after another.

They organised a "unity and solidarity rally" in front of the capital's Jatiya Press Club urging the government to identify and arrest the killers without arresting and harassing thousands of ordinary people in the ongoing antimilitancy drive by law enforcement agencies. Media Activists for

Secular Bangladesh (MASB), a journalists' platform, organised the rally, presided over by Joint Secretary General of a faction of Bangladesh Federal Union of Journalists (BFUJ) and MASB Coordinator Pulack Ghatack. The speakers questioned

anti-militancy drive led by SP Babul, who was the additional deputy commissioner of detective branch (DB) of Chittagong Metropolitan Police (CMP) at that time.

Chittagong Metropolitan Magistrate Harun-ar-Rashid granted the remand in a murder case filed on May 25 in 2015 against Bulbul, said Additional Police Commissioner (Prosecution) Nirmalendu Bikash Chakraborty, adding

Bulbul, who is in jail custody, is the first JMB man whom police took in remand after Mitu's murder on June 5.

Following the murder, CMP Commissioner Iqbal Bahar said the JMB men who are now in prison will be interrogated, if necessary. He also suspected that the imprisoned JMB men might also be linked with these kinds of murders.

Experts tell seminar at DU

Extension of primary education up to class VIII would be a major challenge as it would require appointment of skilled and additional teachers, their training, preparation of new curriculum and textbooks and a big expenditure, said educationists and government officials.

Most of the discussants advocated scrapping the primary terminal examinations this year, saying the exams at this stage create a huge pressure on the children. They also suggested making the curriculum and textbooks simpler.

They were addressing a seminar, "Primary Education up to Class VIII and the Reality", at Nabab Nawab Ali Chowdhury Senate Building of Dhaka University yesterday.

On May 18, the government took the decision to extend the level of primary education from class V in line with the National Education Policy

In his keynote speech, Prof Siddiqur Rahman, a former teacher of the Institute of Education and Research at DU, stressed formation of a curriculum development committee and preparing new syllabuses for class VI, VII and VIII considering those under the primary level.

"Initially the government needs to introduce class VI, VII and VIII at 20,000 primary schools and each school should have at least five new teachers. Therefore, a total of 1 lakh more teachers will be needed."

M Tamim, a professor of Buet, said,

'8 Jamalpur War Crimes Suspects'

Court vexed with prosecution over dearth of witnesses

International Crimes Tribunal-1 yesterday expressed discontent over investigations carried out centring one of five charges in a case against eight "Jamalpur Al-Badr men" over crimes committed during the 1971 Liberation War. The accused are Ashraf Hossain, 64, Prof

Sharif Ahammed, 71, Abdul Mannan, 66, Abdul Bari, 62, Harun, 58, Abul Hashem, 65, Shamsul Haque, 75, and AKM Yusuf Ali, 83. Shamsul and Yusuf are in jail while the rest absconding. Prosecutor Tapos Kanti Baul yesterday

Bangladesh elected VP for 71st UNGA session

Bangladesh was elected on Monday as one of 21 vicepresidents (VP) of the United Nations General Assembly's 71st session, something diplomatic sources say will help the country augment its active

participation. Earlier, Ambassador Peter Thomson of Fiji was elected to be the session's president for one year, beating Cyprus Ambassador Andreas Mavroyiannis in a close 94 to 90 vote with seven invalid ballots and one abstention.

Of the remaining VPs, five are the permanent members. The remaining elected VPs are Congo, Côte d'Ivoire, Djibouti, Mauritania, Nigeria and Zambia (Africa); Nepal, Solomon Islands and Turkmenistan (Asia-Pacific); Armenia (Eastern Europe); Bahamas, Belize and El Salvador (Latin America and Caribbean); and Belgium and Germany (Western Europe and others).

Bangladesh's candidature was endorsed by the Asia-Pacific Group.
