

Mind your own business Selim tells US, UN over pleas not to hang war criminals

Awami League (AL) Presidium Member Sheikh Fazlul Karim Selim yesterday in parliament asked the USA and United Nations to mind their own businesses instead of worrying about Bangladesh.

"You had worried about us in 1971 and we suffered a lot for that. Do not think about us anymore. There is no IS, militant and Al-Qaeda in our country. If there is any, it is in your country. Please do not interfere in our internal matters," he said during discussions on the proposed budget for fiscal 2016-17.

Selim said the US foreign secretary and the UN secretary general had requested Prime Minister and AL President Sheikh Hasina not to hang Motiur Rahman Nizami and other war criminals.

"I do not understand what type of humanity, democracy and the rule of law they want. We do not need your suggestions," he said.

Pointing at the US, Selim said, "You did not apologize yet for what you had done during Bangladesh's Liberation War in 1971. You stood against the elected government supporting Pakistan that carried out bloodshed in Bangladesh."

The AL lawmaker said BNP Chairperson Khaleda Zia a few days ago had stated that there would be an election without Hasina.

Khaleda was hatching conspiracies one after another to lead a repeat of the 21st August grenade attack and "she should be

Khaleda's press secretary sued for 'torturing wife'

Maruf Kamal Khan Sohel, press secretary to BNP Chairperson Khaleda Zia, has been sued for torturing his wife, police said.

Tania Khan, wife of Maruf, filed the case with Mohammadpur Police Station on Monday night under the Women and Children Repression Prevention Act, Jamaluddin Mir, officer-in-charge of the police station, told The Daily Star.

Maruf beat up his wife with a "lethal weapon" following a family feud, leaving her critically injured, said Tarekuzzaman, investigation officer of the case. Later, the victim was admitted to Shaheed Suhrawardy Medical College Hospital, the IO added. In the complaint, Tania alleged that her husband was having affairs with women and used to beat her up whenever she raised her voices against that, the IO said.

The Daily Star could not reach Maruf over the phone. However, in a Facebook status posted last night, Maruf claimed his wife is a "violent schizophrenic" patient. He said he had treated her in "Mukti" hospital in the capital for several times, but cannot do it now because of his financial and other disabilities.

No more DV for Bangladeshis, says US embassy, warns of frauds

The United States has urged Bangladeshi citizens to remain cautious about "malicious people" who are alluring Bangladeshis with fake claim about diversity visa (DV) although Bangladesh is no more an eligible country for the DV programme.

"We don't have DV any more for Bangladeshi citizens," Consul General of the US embassy in Dhaka Elizabeth Gourlay told a press conference at the capital's American Club yesterday. There reports that people are being informed through email, Facebook or cellphone SMS that he or she has been selected for DV.

All tanneries to be shifted in this year: Amu

Industries Minister Amir Hossain Amu yesterday told the parliament that the process to relocate all the tanneries from the capital's Hazaribagh to the designated tannery estate in Savar will be completed within this year.

He also said the tannery estate was set up on 199.40 acres of land at an estimated cost of Tk 1078.71 crore in Savar. Tannery owners have ignored many deadlines set by the government for relocating their industrial units to Savar over the last decade. The latest deadline was April 10, 2016.

Construction worker falls to death

A construction worker died after falling from the second floor of an under-construction building in the capital's Gulshan-1 yesterday.

The deceased was Swapan Meer, 23, of Laxmipur. Victim's cousin said Swapan was taking measurement of a wall for setting glasses on the floor of the 14-storey building. At one stage, he went to the edge of the wall and fell to the ground as his legs slipped. Swapan was declared dead at Dhaka Medical College Hospital.

Now shopping malls will be strictly monitored

Says Ctg DC

The shopping malls of Chittagong city will be brought under strict monitoring now so that consumers are not harassed or charged excessive prices, said Chittagong Deputy Commissioner (DC) Mesbah Uddin yesterday at a meeting.

The DC was speaking at a views-exchange meeting with the representatives of associations of different shopping malls and cloth traders at

his conference room. With an aim to keep the price of textiles normal and stable round the clock including the month of Ramadan, Chittagong District Administration (CDA) organised the meeting where representatives of Consumers Association of Bangladesh (CAB) were also present. "A few unscrupulous traders make excessive profit," said the DC, adding, "We cannot give them such

opportunity." The DC said if asked, the traders have to show their purchasing and selling prices to the monitoring team. "Our teams will go to the malls and strictly monitor those," he said. He also urged the business leaders to keep complaint boxes at the markets for the customers and urged the staff to not to misbehave with women.

31 new power plants on way

State Minister for Power Nasrul Hamid yesterday told parliament that 31 power plants with a total generation capacity of 9,361 MW are under construction at present in the country.

Replying to lawmakers' queries, he also said the plants would go into operation in phases in between 2016-2019.

In the scripted answer, the state minister said, of the 31 under-construction power plants, 16 with 5,625 MW capacity are in the public sector and 15 with 3,736 MW capacity in the private sector.

Nasrul Hamid also informed the House that the power generation capacity of the country has been lifted to 14,539 MW during the present government.

Replying to a question, the minister said the government will import 600 new buses by February or March next year to minimise the crisis. Taking about government's special measure to deal with passengers' rush during Eid holidays, he said around 1,000 volunteers will be deployed at 14 spots on different highways to ensure smooth vehicular movement.

They will work for five days in three shifts to assist law enforcers with an aim to ease traffic congestion, he said. The spots include, Kazla of Demra, Bhulta of Narayanganj, Savar and Ashulia.

The government will also set up mobile toilets besides highways to facilitate the passengers, he said, adding, "We will also arrange alternative roads at some spots of highways."

Quader said his ministry has already completed around 80 percent task of repairing 144 spots on different highways where accidents took place frequently.
