Children used as horse jockeys

Although the inhuman use of children as camel jockeys is being banned in the Middle East, a similarly cruel practice is going on in Jhalakathi and its neighbouring districts.

Children as minor as six are being used as jockeys in horse races. More dangerously, the organisers do not feel the necessity of using any safety gears for them.

"I fell from the horse several times and got hurt," said eight-year-old Towhid, a horse jockey, who studies in class-IV at Putiakhali Primary School of Putiakhali village in Rajapur upazila.

Towhid said he could not afford treatment every time he fell. "My father is a rickshaw-puller. It is hard to find passengers here," he said.

Poverty forced Towhid to contribute

to his father's income by working as a horse jockey. He has been engaged in the dangerous job in May-December, the race season, three to four times a week, for Tk 100 a day.

"When there is a race, I have to take part about four times," he said. Sometimes he has to race six times a day if there is more than one race.

"I know the risks but I do not know any other means of earning money," said Towhid, who wishes he could buy

books and a bicycle by his earning.

"Small horses used in the race can easily carry young children because of their low weight," explains Lal Mia, a manager and owner of horses, who hailed from Dogona village in Kathalia upazila.

Children have been used as horse jockeys in the area for around 12 years, he adds.

The children are sometimes so small that adults need to mount them on the horses.

"If we hire an adult, we have to pay him Tk 400 to Tk 500. But a child is available at only Tk 100 a day," says Lal

He earns Tk 600-1,000 from a horse and a jockey from each single race.

Lal Mia alleges that the main purpose behind the horse race is gambling, as spectators often put bets on horses, making the event an illicit but lucrative one for the organisers. Three to five horse races are organ-

ised in Jhalakathi every week during the season. Horses are also sent to race in other neighbouring districts.

Horse jockey is not included on the list of hazardous jobs published by the Ministry of Labour and Employment.

The Indian High Commission in Dhaka took up the issue with Bangladesh's foreign ministry and police, said Vikas Swarup, spokesperson of the Indian external affairs ministry, on Friday.

India's response to the threat was largely due to the intervention of the Indian Prime Minister's Office as PM Narendra Modi is a follower of RK Mission, reports our New Delhi correspondent. The RK Mission in Dhaka was one of the few non-government institutions that Modi visited during his twoday Bangladesh tour in June last

Sources said the Indian PMO had instructed its Ministry of External Affairs to take the threat issue seriously and act.

Swami Suhitananda, general secretary of the RK Mission headquarters, met senior officials at the Indian PMO on Friday and discussed the threat issued to the mission's branch

in Bangladesh, said mission sources. A police official in Dhaka on Thursday said the priest received the letter on a IS letterhead, with the perpetrator identifying himself as one AB Siddiqui.

"Bangladesh is an Islamic state. You can't preach your religion here. If you continue preaching, you'll be hacked to death with machetes between the 20th and 30th," the

officer quoted the letter as saying. The development comes at a time when suspected militants have killed a number of secular activists, Hindus and other religious minorities across

Bangladesh in recent months.

demanded authorities hunt down the man-eaters. Gujarat's chief conservator, AP Singh, said wildlife officials identified the three lions by analysing the lions faeces and paw prints. Human

remains were found in the faeces of the three lions. The behaviour of the animals was also observed - cats which have tar-

geted humans often act more aggressively towards people. It is believed the male had

attacked and killed the humans, while the females had eaten the leftovers. The male lion has been moved to

an enclosure at the nearby Junagadh zoo, while the two females will be held in cages at a rescue centre, a zoo official said.

After having found no evidence the other 14 lions had eaten humans, they were released back into the wild by investigators.

Gir sanctuary, one of the world's last refuges for wild Asiatic lions, has become overcrowded beyond its 270 lion capacity. While some of India's remaining 500 or so wild lions have migrated to surrounding wildlife parks in search of territory, other prides have settled near riverbeds or farmlands on the sanctuary's borders, leading to conflict with nearby villag-

In 2013, the Supreme Court ordered Gujarat to relocate some lions to other states to prevent the population from being hit all at once by a natural disaster or disease. But Gujarat has resisted moving any of the lions, saying it does not trust other Indian states to protect the big cats.

A Madaripur court placed Faizullah on a 10-day remand after he was produced before it on Friday afternoon.

Over the last three years, suspected militants have attacked and killed university professors, writers, publishers, secular bloggers, gay rights activists, foreigners, policemen and members of religious minorities, including Shia and Sufi Muslims, Christians and Hindus.

About 50 people have become victims of such targeted killings since February 2013. Responsibility for most of the mur-

ders was reportedly claimed by either Islamic State or Ansar al Islam (Bangladesh Chapter of al-Qaeda in Indian Sub-continent).

This was the first time the name of Hizb-ut Tahrir came up following such an attack. The government banned all activities of this radical Islamist outfit, saying it had been carrying out anti-

state, anti-government, anti-people and anti-democratic activities for long. With Faizullah, at least 19, including six suspected militants, were killed

UN chief Ban Ki-Moon yesterday said

that the "detention" of migrants who have arrived in Greece since March should cease immediately, as he visited the frontline of the migration crisis engulfing Europe. He made the comments after visit-

ing two camps on the Greek island of Lesbos, where some 3,400 migrants are being held while officials assess whether they can legitimately claim "Detention is not the answer, it

should end immediately," said Ban, who held talks with Greek Prime Minister Alexis Tsipras in Athens earlier in the day.
