## Defeated UP chairman candidate arrested

Police arrested a defeated chairman candidate of Ruhea Union Parishad (UP) in Thakurgaon Sadar upazila from Ramnath village on Sunday on charge of obstructing government officials from discharging duty at a polling centre during May 7 election in the

The arrestee is local BNP leader Golam Mostafa, a resident of the village.

The law enforcers also arrested three other BNP men -- Akhter Hossain, president of ward unit of the party, its vice president Md Biplob and activist Abdul Malek -- from the

Police said the supporters of Golam Mostafa encircled Mondoladam Government Primary School centre, demanding declaration of the results of the centre, fearing that the result of the UP polls would be changed.

They also obstructed election officials and law enforcers performing their

Later on May 12, the presiding officer of the polling centre, filed a case, accusing over 2000 people in this connection, said Officer-in-Charge of Ruhea Police Station Khan Md Shahrier.

The arrestees were produced before a court which sent them to jail, said the OC.

# Unfit buses get repaired for Man to die for killing wife brisk business ahead of Eid

The old vehicles often pose risk of accidents on highways

A number of outdated and virtually unfit buses get repaired and painted as owners want to do a brisk business ahead of Eid ul Fitr by arranging up and down journeys for home bound passengers, ignoring the risk of running such vehicles in highways.

Usually, from the fag end of holy Ramadan, people working in the capital and other cities go to their village home to celebrate Eid with their near and dear

But many of them face a bitter experience in bus terminals as the number of running buses is usually too inadequate to meet the increased demand.

Taking the opportunity, owners of very old buses earn windfall profit by arranging journey by the buses after some repair as the passengers are out to go home even if they have to pay double or triple the usual fare, said sources.

Uthowainu Chowdhury, assistant director of Bangladesh Road Transport Authority (BRTA) in Nilphamari, said, "More than 70% buses in the district are without any fitness certificate. Before Eid, owners of many of these vehicles get them repaired to carry passengers, defying risk of fatal accidents."



repairing workshops in Nilphamari and Saidpur, workers were seen repairing cracks in buses with galvanizers, replacing broken window glasses, sewing seats and painting the bus bodies.

"This bus will appear as new after the painting work is complete," said Faruk for around two weeks before Mistry, a worker at Adani More repairing workshop in Saidpur municipality.

"Ahead of Eid Every year, we repair 8-10 old buses to make them fit for carrying passengers in long routes.

Visiting different bus We take Tk 30-40 thousand as fee for repair of each bus while the owners supply spare parts," said Bablu Mia, owner of the workshop.

> Such an old bus usually carries 45 passengers in seats and 20-30 others who have to keep standing. During the rush period

and after the Eid earning of an outdated bus owner often reach Tk 12 lakh to 14 lakh as much more than usual fair is realised from homebound and return passengers, sources said.

Afzal Hossain, owner of an unfit bus in Nilphamari, said, "We are helping passengers to reach home as the buses run by government owned BRTC and non-government transport companies are unable to tackle the crowd of Eid time passengers."

Md Waznabi, traffic inspector of Nilphamari police, said, "We regularly launch drives against unfit vehicles but sometimes law can't be implemented properly in view of transport crisis, especially during the Eid holidays."

A Mymensingh court yesterday sentenced a man to death for killing his wife for dowry in Muktagachha upazila in 2012. The death penalty awardee

is Ashraful Islam, 28, son of Nowsher Ali of Gandappur village in the upazila. The court also fined him Tk 10,000, court sources said. According to the prosecu-

tion, Ashraful, a day labourer, married Rekha Akhtar, 19, daughter of Billal Hossian of Nayanbari village under Phulbaria upazila in 2011. Within nine months of


their marriage, Ashraful demanded dowry several times, but Rekha's parents could not manage the money. On January 18, 2012,

Ashraful locked in an altercation with Rekha over the issue. At one stage, he stabbed Rekha, leaving her dead on the spot.

# Habiganj court rejects bail petition of five accused

A Habiganj court yesterday rejected bail petition of five accused in the case for killing four kids.

The accused are Abdul Ali, Rubel Mia, Jewel Mia, Arju Mia and Shahed Mia. They are all residents of Sundrateki village under Bahubal upazila of the district, said lawyer Tilock Kanti Chowdhury. Advocate Abul Hasem Mollah, special

public prosecutor, said Women and Children Repression Prevention Tribunal in Habiganj rejected the bail petition of the five accused and fixed June 28 for the next hearing. Muktadir Hossain, inspector of the

Detective Branch of police in Habiganj, placed the charge sheet against nine accused on April 6. Two of them are on bail and two are absconding.

According to the case statement, Abdul Ali had a longstanding dispute with Panchayet leader Khaleque Master over establishing supremacy in the locality. Abdul Aziz, father of Tajel Miah, was known as a close aide to Khaleque.

Bachchu, a CNG-run auto-rickshaw driver, was also a supporter of Khaleque. However, he was expelled from the Panchayet following a dispute with Khaleque.

Later, Abdul Ali along with Bachchu made a plan to teach Khaleque a lesson and targeted Abdul Aziz first. They decided to kill Aziz or his son to take revenge on the Panchayet leader, the statement said.

Rubel and Bachchu planned to abduct Aziz's son Tajel from a football match scheduled for February 12. However, the match was abandoned due to rain.

Bachchu later tactfully took Tajel and his cousins Monir Mia, Ismail and Shuvo, on his auto-rickshaw that evening from near the playground. Later, Rubel, Arju and other accused joined him and drugged the children to make them unconscious.

They then strangled the children inside the three-wheeler and kept their bodies at Bachchu's garage. Later, they buried the bodies.

# Minor girl raped, hospitalised

A minor girl was raped by an aged man at Gorapara village under Noakhali Sadar upazila yesterday.

Md Anwar Hossain, officer-in-charge (OC) of Sudharam Model Police Station, quoting victim's parents, said her mother went to Banderhat near their house after reciting the Holy Quran at noon. The girl was alone when neighbour Md Mostafa, 60, entered the house and raped her. At one stage, she became unconscious.

The girl's mother returned home after 45 minutes and saw her daughter lying on the floor with blood around her. Locals rushed her to the Noakhali Medical College Hospital immediately.

On information, police raided the area to arrest the rapist, but he had gone into hiding soon after the incident, the OC added.

Dr Farid Uddin Chowdhury, Resident Medical Officer, said the condition of the victim is very critical. She has been given two bags of blood, he added.

# Locals block road, torch killer vehicle in Noakhali

Locals blocked Choumuhani-Sonaimuri road at Bagadia under Sonaimuri upazila of the district and set fire to a pick-up van yesterday after a government employee was killed in a road accident. The deceased was identified as Abdul

Gofur, 55, of Bagadia village under Sonaimuri village and an employ of Sonaimuri Upazila Health Complex.

Kazi Haniful Islam, officer-in-charge of Sonaimuri Police Station, quoting locals as

saying that Gofur was walking to his work place at 8:30am. When he reached near his office at Bagadia Uttar pool, a Choumuhani-bound mango-laden pick-up from Sonaimuri ran over him, leaving him dead on the spot.

Agitated people set fire to the pick-up van and blocked the road for an hour. The driver, however, managed to flee the scene.

On information, police went to the spot and brought the situation under control. Police recovered the body and sent it to Noakhali

Medical College Hospital for autopsy.
