Mir Quasem review petition hearing July 25 STAFF CORRESPONDENT

The Supreme Court yesterday fixed July 25 for the hearing of a petition filed by war criminal Mir Quasem Ali

seeking review of its judgement that had upheld his death penalty. Chamber judge of the Appellate Division of the SC Justice Hasan Foez Siddique

fixed the date following a government petition that prayed for a date for the hearing on the review petition. On June 19, Quasem

submitted the petition to the apex court through his lawyers seeking review of its verdict that had upheld his death penalty for crimes committed by him during the country's Liberation War in 1971.

In the petition, the Jamaat-e-Islami leader prayed to the SC to acquit him of all seven charges on which he was found guilty.

In the 86-page petition, 14 grounds have been mentioned based on which the SC may consider the review petition.

The International Crimes Tribunal on June 6 issued a death warrant for Quasem Ali hours after the SC had released the full text of its verdict upholding his death penalty.

On November 2, 2014, the ICT-2 handed down capital punishment on 63year-old Quasem, chief of Chittagong Al-Badr force, for committing crimes against humanity in 1971.

On March 8 this year, the Appellate Division upheld the ICT-2 verdict.

Quasem is considered by many as the main financier of the anti-liberation party. He allegedly paid \$25 million to an American lobbyist firm to carry out a smear campaign to make the war crimes trial controversial, the then law minister Shafique Ahmed told parliament on April 28, 2013.

The death row war criminal was shifted to the Dhaka Central Jail from Kashimpur prison of Gazipur on June 20.

Power sector faces | Check operation of unfit seven challenges

Nasrul Hamid tells JS

The power sector faces seven challenges in the coming days, State Minister for Power Nasrul Hamid told the parliament yesterday.

The challenges are primary fuel, skilled manpower, service enhancement, reduction of corruption at field level making renewable energy popular, implementation of projects in due time and ensuring investment.

The state minister talked about the issue while participating in a general discussion on the proposed budget for 2016-17 fiscal. He said the government had planned to set up four floating regasification units, and is going to set up three landbased LNG terminal to ensure primary fuel in the country.

Aiming to create skilled manpower, Nasrul said the

government wanted to introduce a curriculum on power and energy. "This course is also absent at the university level, but we need enough electrical mining engineers." On the improvement of service and reducing corruption, Nasrul said the transmission and distribution payment

should be service-oriented. He also opted for automation of all the systems through call centre supervisory control and data acquisition system.

vehicles during Eid rush Rights activists demand at human chain

Rights activists yesterday demanded that the government take effective steps to check operation of unfit vehicles and launches during Eid rush.

Some profit-mongering businessmen operate rundown vehicles and vessels taking advantage of the huge rush of passengers, which causes fatal accidents, they added.

The nuisance must be stopped, they viewed at a human chain organised by the Passenger Welfare Association of (PWAB) in front of the capital's Jatiya Press Club.

Mozammel Hoque Chowdhury, secretary general of the association said, "As per our assessment, around 20 percent of the passenger vehicles, operated on highways, are unfit. But the percentage rises at 29 during Eid rush."

Similarly, 17 percent of the launches, which ply during Eid rush, are unfit, he viewed.

WAR CRIME TRIALS

Court orders publishing advert for appearance of two fugitives

Testimony, cross-examination of fourth prosecution witness against 2 Shariatpur accused recorded

International Crimes Tribunal-1 yesterday directed its registrar office to publish advertisements in two national dailies asking for the appearance of two fugitives, including a former leader of Habiganj Awami League, who were allegedly involved in crimes during the 1971 Liberation War.

The three-member tribunal led by Justice Anwarul asked Liakat Ali, 61, former president of Habiganj's Lakhai upazila unit Awami League, and Aminul Islam alias Rajab Ali, 62, of Astogram upazila in Kishoreganj, to appear within one week of the day the ad is published.

Earlier, police submitted a report

saying they were fugitives. The tribunal also fixed August 21 to pass the next order in the case.

On May 3, the prosecution pressed seven charges against the duo and the tribunal accepted the charges on May

The seven criminal incidents they were "found to have been involved in" are looting and killing of 43 Hindu men in Krishnapur in Lakhai, killing of nine Hindu men in Chandipur in Lakhai, killing of 26 Hindu men in Gadainagar in Lakhai, killing of eight Hindu men in Sadanagar village in Lakhai, killing of one Rangu Mia in Nasirnagar, killing of five men in Sabiyanagar in Astogram, and killing of 10 other men in the same village.

Meanwhile, the tribunal completed recording the testimony and crossexamination of the fourth prosecution witness in a case against two men of Shariatpur, Sulaiman Mollah and Edris Ali Sarder, who are facing similar charges.

Nurul Islam Sarder, 69, of Kashabhog village under Palang Police Station testified, linking the two to the killing of scores of people, mainly Hindus, and rape of Hindu women.

Earlier, Abdul Aziz Sikder, Jalilur Rahman and Abdul Jalil Howlader, the first, second and third prosecution witnesses, gave near similar descriptions of the incidents, implicating the duo.

The tribunal adjourned proceedings until today.
