Wasim was one of the three who attacked Mitu. He shot her with a gun, which police have yet to recover. Anwar, at the time of the attack, was in the area as a member of a backup team, added the official. Replying to a question, Iqbal Bahar

said the attackers were the members of crime gang. "We have come to know about others involved and we are trying to arrest them." Asked about the murder motive, the

CMP commissioner said he would not comment about it before the investigation completes.

Queried if the murder was committed by Islamist militants or if it has anything to do with personal or professional issues, he said they were looking into all possible aspects. On June 5, three assailants stabbed

and shot dead Mitu, 32, who left her OR Nizam Road house on foot around 6:35am to put her son on a school bus at GEC Intersection in Chittagong.

On Saturday, a four-member police team interrogated Babul for 15 hours at the DB office on Minto Road after he

was taken away around 1:00am. According to sources, he was questioned about his "suspected link with the murder" though there was no

official version in this regards. But CMP Commissioner Iqbal Bahar yesterday said, "Babul was not taken away." Cops were deployed at

the SP's house and also during his movement between home and the DB office for his security, he added. On another query, the CMP boss

said Babul was not under police surveillance. "Why would the plaintiff be

under surveillance when there is scope for direct steps if his involvement is found?" Meanwhile, Dhaka Metropolitan

Police (DMP) Commissioner Asaduzzaman Miah yesterday said the SP was quizzed as per the law. There was nothing unusual in interrogating the plaintiff. The SP was asked to come to the DB

office on Minto Road for questioning but he wanted a car to reach there, the DMP commissioner said. "We sent a vehicle accordingly," he said during a programme for distribution of Eid clothes among the poor on Dholaipar High School ground.

Babul's father-in-law Musharraf Hossain, himself a former police official, said it is a positive development that two suspects have been arrested and made confessional statements.

"Now their statements have to be verified," Musharraf told The Daily Star

last night.

He also pointed to the fact that criminals used knives, firearms and a motorcycle but not all of those were recovered. Though a motorcycle has been found, it needs to be ascer-

tained if that is the one used by the killers, he added.

Asked about his son-in-law's suspected link with the murder, he said he does not believe any such stories.

Babul made some enemies because of his achievement in service, he said. "So any information given against him should be verified even if it takes months."

Commander Lt Col Sazzad Hossain told our Moulvibazar correspondent.

The villagers alleged that they left their homes in the face of torture and harassment by forest officials of the reserve forest.

Manish Chandra Debbarma, head-

man of Debrapara village, said that around 600 indigenous people live in the five villages only half a kilometre away from the Bangladesh-India bor-"Most of us work as day labourers

inside the forest, but we are often harassed by forest officials," he said, adding that the harassment had increased since the discovery of a large cache of arms and ammunition in Satchhari National Park in Habiganj in 2014.

The location where the arms were recovered is about half a kilometre away from the villages.

"Since that incident, forest officials often threaten us with eviction and tell us to go away from the forest land," Manish claimed.

He alleged that forest guards had destroyed some of their homes about four months ago and evicted some of their community members from the forest land in Chunarughat.

Abdul Wadud, beat officer of Sanbari beat under Kalenga forest, refuted the allegation of torture.

He said that on Friday he sacked a number of Tripura community men

who were working as forest guard.

attacked a forest bungalow. As a result, we detained four people," he claimed. They were released later, he added.

RFM Monirul Islam, divisional forest officer (DFO) of the Sylhet Forest Division, claimed that the villagers were rehabilitated there in the early 1970s and were given agricultural land inside the forest area under the condition that they would in return guard the jungle along with forest employees.

"However, the men were not performing their duties for the last 10-15 days. When the beat officer of Sanbari forest met some of them on Friday on his way to Asr prayer, he had an argument with them about the matter," he claimed.

"Later, these men attacked the Sanbari forest office. They also waited with sticks to beat up the officer but were stopped by other community people..." he alleged, adding that four men, who attacked the office were detained but later released to the headman of a Tripura village.

The villagers told the BSF that around five people went missing from the Tripura villages in the last one week, while their women and children were being harassed every day, reported our Kolkata correspondent.

Following the tension between

forest officials and the Tripura community men, members of Tripura and Kharia indigenous communities are now living amid utter insecurity in the hilly jungles, villagers said.

Pushpo Rani Debbarma, 65, wife of headman Chitto Debbarma, said "We feel unsafe as forest officials can evict us anytime. We are passing our days in Khemyti Debborma, 60, mother of

two, said that after the men lost their jobs in the forest, cooking at many houses in the villages had stopped, as they could not buy anything.

Shamim Ahmed, chairman of Paikpara Union Parishad, said, "The indigenous Tripura community people are peaceful. They do not engage in any violence. But some forest officials disturb them." Jonok Debbarma, former general

secretary of Bangladesh Tripura Kollyan Sangsad, said, "Indigenous people are peaceful, yet we face harassment regarding our land rights." Lt Col Sazzad Hossain said when

BSF informed them about the attempt by the Bangladeshi indigenous people to cross the border, BGB along with a forest range official and four local UP members went there, held a flag meeting and brought them back.

"Indigenous people had been living in the Kalenga Reserve Forest and sought shelter from the BSF following problems with forest department workers," he added.

Nirmalendu Chakrabatry, officer-"Infuriated, the Tripura men in-charge of Chunarughat Police Station, told The Daily Star that 187 indigenous people sought shelter in India.

> Forest department people often harass Tripura community men, so they sought shelter there (India) for safety, he said.

> Yesterday, law enforcers along with union parishad chairmen and forest officials went to the Tripura villages to discuss the situation with the villagers. "We assured the villagers that steps

will be taken against any forest official or beat officer if the villagers were harassed again," Lt Col Sazzad told The Daily Star after the meeting.

The villagers were also asked to talk to the BGB about their problems, instead of going to BSF for shelter, he

Despite the assurance, the villagers were still apprehensive about their

2008 exempting the accused from the charges as their offence was not found in the investigation. Police submitted a charge sheet

before a court on October 5, 2008, against Khaleda and 15 others, Mahbub said, adding that under the ACC law, there is no scope for further investigation into a corruption case if a final report is submitted earlier. The lawyer said the apex court

would later fix a date for hearing Khaleda's petition. Earlier on September 17, 2015, the

HC rejected a writ petition of the BNP chief filed in 2008 challenging the legality of trial proceedings in the case.

On May 25 this year, the HC released its full judgement directing the trial court to proceed with the case in accordance with the law. The court also vacated its 2008 stay order on the case proceedings.

point-blank range. I could not shout because the policemen gagged me.

After that they put me again in the "Leguna" and took me to Dhaka Medical College Hospital. The doctors of the hospital advised to admit me but the policemen did not do so.

They kept me without treatment till the next day. On January 18, 2015, police showed me as an accused in three cases about burning and vandalising vehicles, filed with Paltan and Darus Salam Police Stations.

They kept me in the custody on remand for three days without any treatment. Then I was detained in Dhaka Central Jail and then Kashimpur Jail and released on bail after seven months.

In August 2015, I was sent to jail in a case of attacking a polling centre during the elections on January 5, 2014, and after two months, I was released on bail.

Now, there are four cases pending against me. I need appear at various courts regularly. Thus my academic career is being seriously hampered. My wounded right leg has thinned because I could not take timely treatment. It cannot support my body. I feel severe pain in the wounded area. I could not get proper treatment later due to the economic hardship of my family.

# New York dedicates Gay Pride to Orlando massacre

Hundreds of thousands of people were expected to pour onto the streets of New York yesterday to celebrate one of the city's largest Gay Pride marches and honor the 49 people killed in the Orlando nightclub massacre.

Safeguarded by hundreds of police, participants from hundreds of groups are expected to take part in the march down Fifth Avenue from 36th Street

and culminating in Greenwich Village. The parade was to begin at noon (1600 GMT) following a moment's silence to honor 49 people who were killed and the dozens more who were injured in the massacre at a gay nightclub in Orlando on June 12.

### Pak army chief flies to Karachi after high-profile attacks
