A mobile court in Nilphamari fined three bakeries, five restaurants and a mosquito coil factory Tk 1.15 lakh and sealed off the factory for various irregularities in Saidpur municipality yesterday.

The court fined Tanvir Laccha Semai in Bichali Hati area Tk 30,000; Shahin Laccha Semai in Neamotpur Tk 10,000 and Roz Bakery at Darul Ulam intersection Tk 20,000 for producing Laccha Semai -a kind of vermicelli -- in an unhygienic condition.

# Woman, 8-month-old Seven men hurt son die in road crash in Ctg clash

Four people, including a woman and her eight-month-old son, were killed and seven others injured in road accidents in three districts yesterday and on Thursday.

In Kishoreganj, woman and her eightmonth-old son were killed and five people injured as a bus plunged into a roadside ditch in Agarpur area of Kuliarchar upazila yesterday, reports UNB.

The deceased were Nazira and her son Shamim.

AKM Mizanul Haque, in-charge of Bhairab highway police, said the Kishoreganj-bound Ananya Super bus plunged into a roadside ditch as the driver lost control over the vehicle leaving the woman and her child dead on the spot.

In Jhalakathi, Yusuf Ali Faraji of Mahishkandi was killed and two of his family members were injured when a pickup-van hit a roadside tree on Barisal-Khulna highway after the driver lost his control over the vehicle in Raipur yesterday.

Yusuf and his family members were going to his native village from Dhaka on Eid vacation.

In Mymensingh, Shafiqul Islam, 42, of Gouripur was killed as a truck rammed his motorcycle in Kaltapara area on Mymensingh-Kishoreganj Road in the upazila on Thursday evening.

At least seven persons were injured in a clash between two groups of locals at Khagaria in Satkania upazila of Chittagong yesterday.

The injured were rushed to different hospitals including Chittagong Medical College Hospital (CMCH), said police.

Of them, three injured -- Shamsul Alam, 60, Md Forkan, 26, and Md Hanif, 32,-- were undergoing treatment at the hospital with hack injuries, said Nayek Jahangir Alam of CMCH Police Camp. While the test is to be held in 2017, the outreach programme for the exercise would be conducted earlier.
