Munshiganj road crash kills five, injures 20

Five persons were killed and 20 others injured in a road accident at Keotakhali on the Dhaka-Mawa highway in Sreenagar of Munshiganj yesterday afternoon when a Mawa-bound bus, Tungipara Express, hit a roadside tree as the vehicle's driver lost control over it.
Lyon Master, 40, of Tungipara; Khalilur Rahman, 33, of Bagerhat; and Moin Khan, 28, of Sreenagar upazila are among the five dead, said Md Shamsuzzaman Babu, assistant superintendent of police (Sreenagar circle).
Identities of the two other dead could not be ascertained immediately.
Shahidur Rahman, officer-in-charge of Sreenagar police, confirmed it.
Locals rescued the injured and rushed them to different hospitals in Munshiganj and Dhaka.
Meanwhile in Pabna, two persons died and eight others were injured as a pick-up van carrying 10 to 12 homebound people fell into a roadside ditch in Mannannagar area of Tarash upazila in Sirajganj yesterday, after the vehicle's driver had lost control over it, reports our Pabna correspondent.
The deceased are Nurul Islam, 18, son of Abdul Malek, and Jamal Uddin, 35, son of SEE PAGE 5 COL

"He loved his daughters deeply. He brought us to Dhaka from Narsingdi so that they can get better education," a grief stricken Monira Ameen Moni, wife of Mintu, told this correspondent on Thursday night.
"I don't know what'll happen now. I am worried about my daughters' future," she wailed. One of her daughters is a fifth-grader and the other one is only three years old.
Anif Newaz Farazi, a close friend of Mintu, said Mintu informed him about his plan to come home ahead of Eid. "I was angry as he earlier said that he might not visit because he was not getting the Eid holiday. But on Tuesday, Mintu informed that he got the leave. He sounded so happy," Arif said.
Mintu was killed in the accident which occurred from a gas cylinder explosion at a ship where he used to work, Serajul Islam, counselor at the Bangladesh embassy in Doha told The Daily Star on Thursday night over phone. "We have been informed that the explosion also killed another Indian employee," he said.
The official mentioned that the company had already donated around Tk 9 lakh to the victim's family and bore all costs of sending back the body. Besides, the family might get some other financial support later, he said.
Family members said the body was buried at Mintu's village home in Narsingdi's Raipura yesterday.

Man shot, robbed of Tk 20 lakh

Lokman Mia, 45, supervisor of Alhizar Textile Mills in Demra, was hospitalised with a bullet wound in his leg, said police. Lokman and the factory owner were carrying the money in a private car to the factory in Savar from their stores in Chawkbazar.
Six people on three motorcycles intercepted them around 5:30pm, witnesses said.

Apprentice lawyers urged to carry ID cards

Bangladesh Bar Council urged apprentice lawyers to carry identification (ID) cards and wear brown or ash-coloured ties, not black ones, during their probation period in the court.
Bar Council Secretary AKM Johurul Alam issued the letter recently to all lawyers' associations as per the council's decision.
The lower courts' lawyers and learner lawyers both use black ties and the probationers do not carry any ID cards, making it difficult to distinguish them from a full-time practicing lawyer, the letter read.
To clear the identity of apprentices, the learner lawyers have been urged to wear brown or ash-coloured ties and carry ID cards, it added.
