Malnutrition hits poor children in Lalmonirhat

Many do not attain normal physical and mental growth

Many children in the district do not attain normal physical and mental growth due to severe malnutrition.

Three children of Jarina Begum and Mansur Ali of Kakina village under Kaliganj upazila say they can't pay attention to their studies or take part in games or normal activities due to weakness, which is caused by malnutrition. Jarina Begum said, "We feed rice to our chil-

dren three times a day, but cannot give them meat, fish or fruit regularly due to poverty." Mansur Ali, a farm labourer, said, "The doctor told me to buy vitamin syrup for our children, but I cannot afford it."

Salma Akhter, 8, a Class III student at Bagdora village under Lalmonirhat Sadar, said she goes to school after eating some rice, but she does not have lunch in the school. "I feel very weak, and that affects my learning," she said.

Reaz Khandaker Rinkue, an NGO representative working for Char Health and Education in

Lalmonirhat, said malnutrition in Lalmonirhat, especially in chars and remote villages, is very common. "It is necessary to build awareness among the people about the bad impact of malnutrition, and also to provide nourishing food to the ultra poor. That will remove malnutrition gradually," he added.

Lalmonirhat Civil Surgeon Dr Ahsan Ali Babu said if a malnourished woman gives birth, the baby will also be malnourished. If it does not get nourishing food, its normal growth gets hampered and it will never be fit mentality and physically, he said. Officials of the Women Affairs Department in

Lalmonirhat said a lactating mother of an ultra poor family gets financial support for buying nourishing food, but the programme is meant only for the municipality area.

Juliya Sultana Suma, a teacher of Char Falimari Smrity Roy Primary School, said, "If the children of this school get nourishing food, it will make them very good in their studies," she added.

District Primary Education Officer Nabez Uddin said World Food Programme (WFP) is providing nourishing biscuits at some primary schools in Hatibandha and Patgram upazilas, but most schools, especially in char areas, are deprived of this facility. "I am trying to start the WFP programme in all schools in the district," he said.

Jamal Ibne Musa, whose efforts helped a trafficked Indian boy to reunite with his family, has received a fresh threat yet again on Sunday allegedly from the boy's captors. Aklima Begum, who allegedly brought Sonu, a 12-year-

old Indian boy, to Bangladesh from the Indian capital New Delhi in 2010, went to Jamal's house at Geramardan village in Betagi upazila of Barguna in the evening and threatened him to implicate in another case. Jamal's wife Niru Begum said Aklima and her cohorts are

on the run since Sonu's return to India, but they often come to the village and warn Jamal and his family members of dire consequences.

"I feel proud when I think about Sonu's reunion with his family but at the same time I get frustrated when think about the six false cases filed against me and my family members," Jamal said.

'Now I demand impartial investigations in all the cases and acquit me and my family members of those cases to help me return to our normal life', added Jamal.

Jamal said as he had lost his job and had no earning sources it is difficult for his family of five to appear at different courts regularly in connection with those cases.

He also urged the authorities concerned to take necessary steps to withdraw all the cases filed against him and his family members.

Sonu was reunited with his family in New Delhi on June 30.

The boy flew to Indira Gandhi International Airport in New Delhi by a Jet Airways flight, from where his parents took him to their house in New Seemapuri locality in the northeast part of the Indian capital.

Abandoned newborn gets new mother

A newborn was found abandoned beside Panchagarh-Tunirhat road in Panchagarh municipality area.

Mominul Islam, officer-in-charge of Panchagarh Police Station, said motorcyclist Habibul Islam found a one-day-old baby boy beside the road on Sunday night.

Informed by Habibul, police rescued the newborn and sent him to Panchagarh Sadar Hospital.

The baby was abandoned there soon after birth and his physical condition was good, said Raziul Karim, resident medical officer of the hospital.

Hearing the news, a number of couples thronged the hospital and showed interest to adopt the new born, said police.

Considering the couple's interest and their financial condition, police give the baby to childless Lipi Akhtar, wife of Saharier Pervez of Ghatiapara village.

Woman's kidney removed, instead of stones

A doctor removed one of the kidneys of a woman instead of removing the stones that had developed around the vital organ.

Dr Hazrat Ali conducted the operation at HK Mother Care Hospital at Kalitola (opposite of Sadar Police Station) in Dinajpur town on June 30.

The doctor, earlier convicted by a court to eight years' imprisonment in a case for illegal abortion, set up the clinic at a 10storey building, said sources.

The victim woman, Anwara Begum, 42, wife of Abdul Kuddus of Pakura village in Biral upazila of Dinajpur, was admitted to HK Mother Care Hospital on June 29 for removing stones of her left kidney, said family members.

"Examining an X-ray and other reports, Dr Hazrat Ali told us that the kidney was alright and in view of the position of the stones, there was no possibility of any harm to the kidney if the stones were removed through surgery," Anwara's son Aynul Islam

told journalists.

Dr Hazrat Ali conducted the operation on June 30.

As the woman felt complications, her family members on Saturday informed the doctor of the matter several times, but the latter ignored the matter.

Pressed by Anwara's relatives, Dr Hazrat Ali later admitted to them that he had cut off the patient's left kidney after finding problems during the surgery.

Hearing the matter at her hospital bed, the woman started wailing.

"Dr Hazrat Ali cut out the entire kidney instead of removing the stones from it. He offered us Tk 1 lakh to settle the matter. But we demand exemplary punishment of the doctor," said the victim woman's son Aynul Islam.

Contacted, Hazrat Ali declined to make any comment regarding the incident.

In 2013, a Dinajpur court convicted him to eight years' imprisonment in a case for illegal abortion. Spending nearly a year in jail, he got bail from the High Court and returned to his medical profession.

5 more Pabna missing men shown arrested

Five people from two villages of Faridpur upazila under the district have been detained by Rapid Action Battalion (Rab) in Madhabpur upazila of Habiganj district on Saturday, nearly two months after they were picked up allegedly by law enforcers.
