Man 'kills' his child over family feud

A man allegedly killed his two-and-a-half-month-old son following a family feud in Kaliakoir of Gazipur yesterday.

Khadiza Begum, mother of the victim Arafat Hossain alias Sunny, filed a murder case against her husband Jahangir Alam, 28. The couple lived in a rented house in Sakaswar area of Kaliakoir.

Police said Jahangir of Mymensingh had been having a feud with his wife Khadiza for quite some time.

On Saturday night, Kadiza fell asleep after feeding her child. The next morning she found her son dead, said police.

On suspicion, locals detained Khadiza and Jahangir and handed them over to police. Police said Jahangir confessed to the killing.

Qulkhwani of Faraaz held

Faraaz Ayaaz Hossain, one of the 22 victims killed in the Gulshan terrorist attack, represented values that made his family and relatives proud, his grandfather and Transcom Group Chairman Latifur Rahman said yesterday.

"He represented the true narrative of Islam. So we are extremely proud of him. He

also elevated the dignity of Bangladesh," he told the qulkhwani of Faraaz at his residence in Gulshan after Asr prayers.

Faraaz, 20, along with his friends -- Indian national Tarishi Jain, a student of the University of California, Berkeley, and Abinta Kabir, a Bangladeshi American -- was in the Holey Artisan Bakery on July 1 evening when armed militants stormed the restaurant and held people hostages.

Abinta, daughter of Ruba Ahmed, chairman of Elegant Group, and Faraaz were students at Emory University in Atlanta, and had come to Bangladesh during their summer

holiday. During the attack, militants had let Faraaz go, but not Abinta and Tarishi, but Faraaz refused to leave his friends behind and was eventually killed along with his friends and

nine Italian and seven Japanese citizens inside the restaurant.

Newborn rescued from dustbin awaits a lap

A newborn, rescued from a dustbin near the capital's Badda Post Office yesterday morning, is still waiting for a home at Dhaka Medical College Hospital.

Hearing screams, locals found the infant, wrapped in polythene, inside the dustbin around 10:30am and informed police, said Abdul Jalil, officer-in-charge of Badda Police Station.

Cops, with the help of a local woman, rescued the newborn and hospitalised the baby at the neonatal unit of DMCH around 1:30pm, he added. "We are trying to identify the parents," the OC said.

DMCH Deputy Director Khawaja Abdul Gafur told The Daily Star that the hospital authorities are providing treatment to the infant who is two-three days old and weighs around 2.8kg. "With some infections of jaundice, the infant is undergoing treatment. But the baby is now out of danger," he said.

SC orders halt for four weeks

same period. Chamber Judge of the Appellate Division of the SC Justice Hasan Foez Siddique passed the order following two separate petitions filed by the Stranded Pakistanis General Repatriation Committee.

MITU MURDER

'Arms supplier, aide' remanded

A Chittagong court yesterday granted a three-day remand each for the two accused in a case filed over possessing arms used in the murder of Mahmuda Khanam Mitu, wife of Superintendent of Police Babul Akter.

They are Ehteshamul Haque, alias Haniful Haque alias Bhola, 41, of the city and Monir Hossain alias Manir, 28, of Comilla.

Police said following confessional statement of Bhola who was arrested on June 27, they arrested Monir who hid Bhola's weapons. Later, police recovered one pistol, one revolver and six bullets from Monir's house, said Detective Branch's Assistant Commissioner Kamruzzaman, also the investigation officer of the murder case. An arms case was lodged against the duo, he said, adding that Bhola was also shown

arrested in Mitu murder case as he supplied arms for the killing. "Bhola is an enlisted arms supplier and Monir is his associate. We need to interrogate them to know whether they had kept more arms in their possessions. So we sought a ten-day remand," said Sub-inspector Mohimuddin, the IO of the arms case. On June 5, assailants stabbed and shot Mitu dead in the port city.
